That DCC & An Garda Síochána seek to address the ongoing problem of large groups of youth up to 40 to 50 who regularly congregate along the main shopping district of Ballyfermot playing music through large mobile music systems at all hours of the night, the area is left in a shocking state with waste etc after they disperse.

South Inner City Drugs Task Force funds a lot of projects in Basin Street yet the Garda Station it actually reports to is Kilmainham which has the remit for the Canals Drugs Task Force. The Councillor requested that this issue be referred to the City Wide JPC for determination.

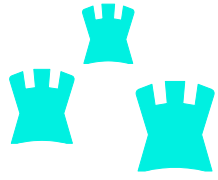

Introduction and background

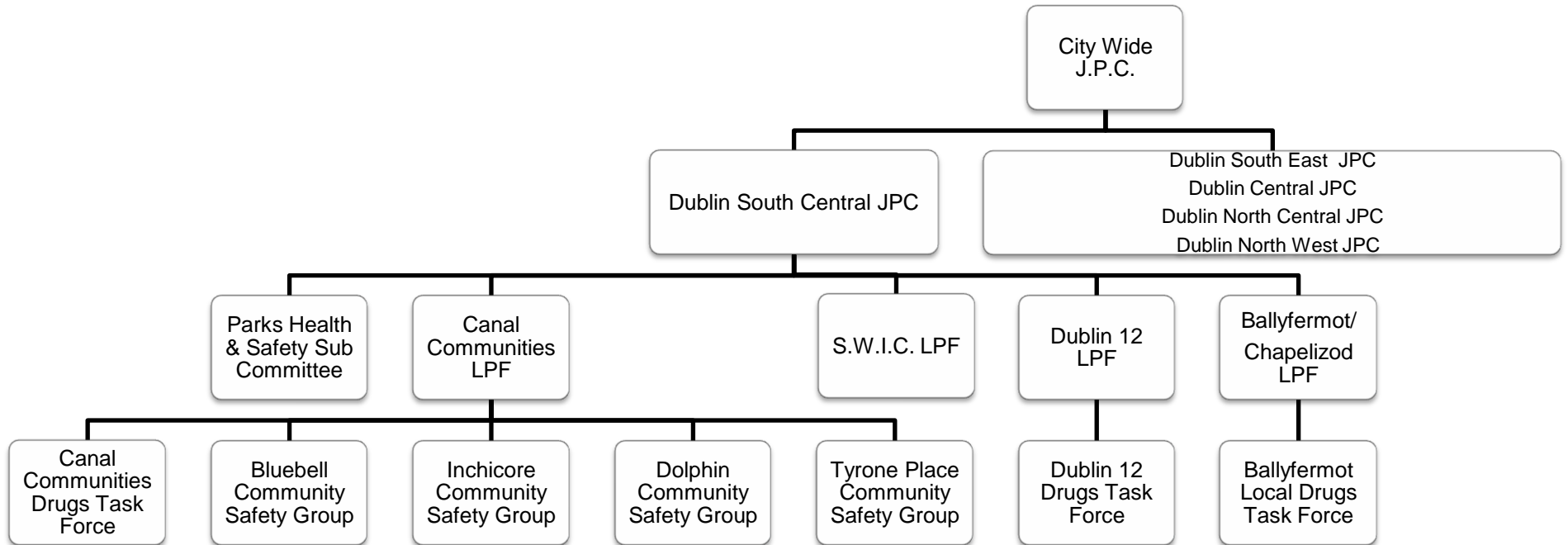
Section 35 of An Garda Síochána Act 2005 provides for the establishment of Joint Policing Committees. The Dublin City Joint Policing Committee was established in 2006 and five Sub-Committees were established to correspond to the five operational areas of the City Council.

The function of the JPCs is set out in section 36(2) of the Garda Síochána Act which states: -

“The joint policing committee’s function is to serve as a forum for consultations, discussions and recommendations on matters affecting the policing of the Local Authority’s administrative area, and in particular to -

- a) Keep under review –
 - (i). The levels and patterns of crime, disorder and anti-social behaviour in that area (including the patterns and levels of misuse of alcohol and drugs), and
 - (ii). The factors underlying and contributing to the levels of crime, disorder and anti-social behaviour in the area,
- b) Advise the local authority concerned and the Garda Síochána on how they might best perform their functions having regard to the need to do everything feasible to improve the safety and quality of life and to prevent crime, disorder and anti-social behaviour within the area,
- c) Arrange and host public meetings concerning matters affecting the policing of the local authority’s administrative area,
- d) Establish, in consultation with the local Garda superintendent, as the committee considers necessary within specific neighbourhoods of the area, local policing fora to discuss and make recommendations to the committee concerning matters that it is to keep under review under paragraph (a) or on which it is to advise under paragraph (b), in so far as those matters affect their neighbourhoods, and
- e) Co-ordinate the activities of local policing fora under paragraph (d) or otherwise”

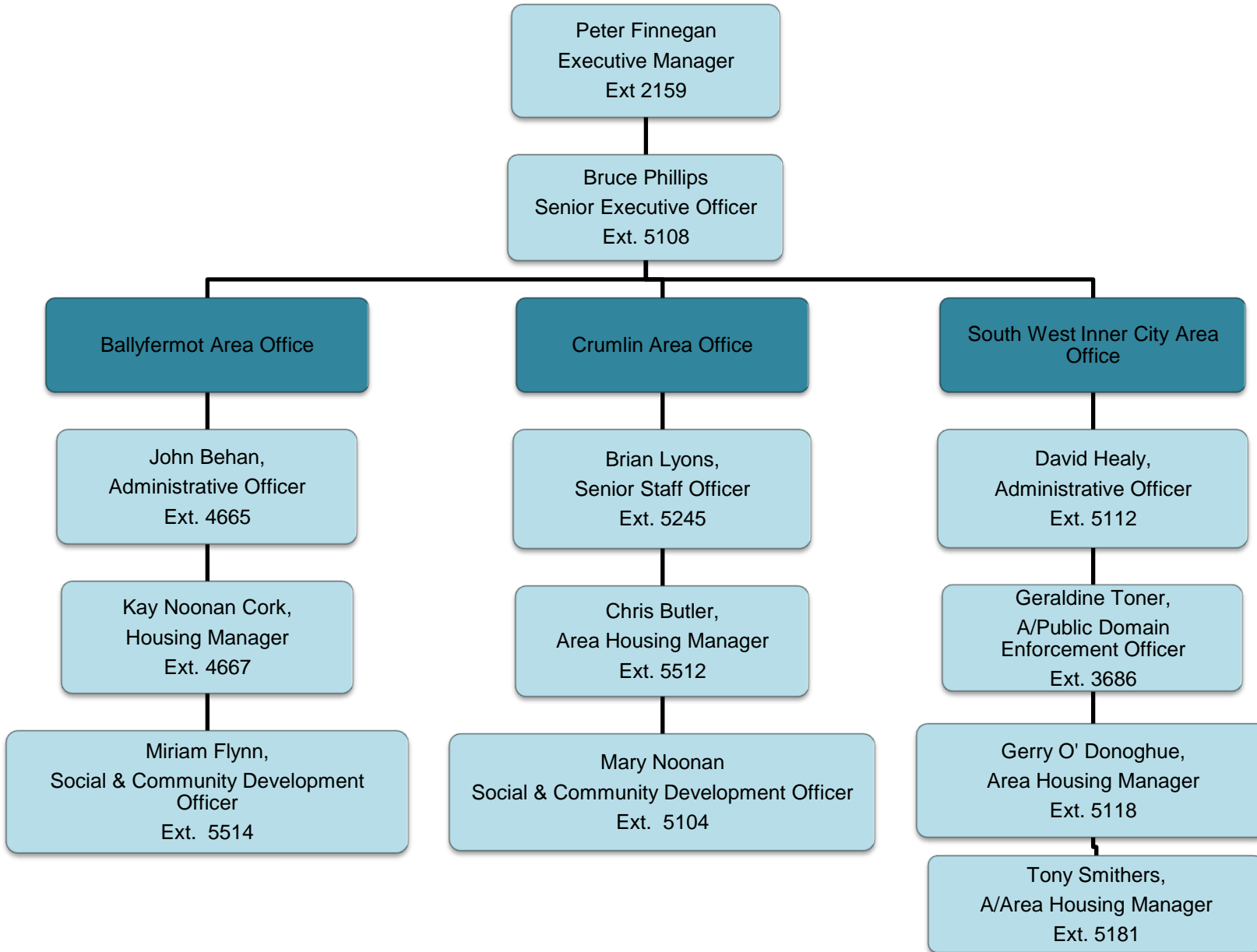

Objective 1: To reduce the levels of anti-social behaviour in public parks, open spaces, along the Red Luas Line and private rented dwellings by improving co-ordination between An Garda Síochána, Dublin City Council and community representatives

Security gates at Davitt House have been repaired and upgraded and will be commissioned shortly. New Housing Manager will be meeting all residents groups and Gardaí to discuss Estate Management issues in complexes.

Ballyfermot AGS

Inspector John Tuite, Ballyfermot Garda Station appointed as Garda Liaison with DCC. There is almost daily contact by the Community Policing Sergeant with the housing section in DCC, Brian Tate and Kay Noonan.

Two extra cameras were installed in the Cherry Orchard area in December by the Council and are being controlled and monitored at Ballyfermot Garda Station. These cameras have been very beneficial in covering the black spots in the Cherry Orchard area and have been useful in tackling anti social behaviour in the area.

Crumlin AGS

A Parks User Group specific to the Crumlin District has not been set up to date. Objections have been raised by the Local Policing Forum to the proposed setting up of the Super Parks Groups. It is felt that with the amount of parks in the District that the locals contacts and management will not be as effective. Gardai attended at Brickfield Park on the 24/4/2017 for the official opening of a new Astro Soccer Pitch.

Kevin Street & Kilmainham AGS

A Park User Group has not been set up to date. However, Gardai continue to patrol targeted 'hotspots' such as Merchants Quay, St. Audoen's Park, The 'Cabbage Patch', St. Patrick's Park & Herberton Park – these areas are patrolled by members on designated special beats with assistance provided by

**Parks Health and Safety Sub-committee Report for South Central Area JPC Meeting
on Monday 29th May 2017.**

There have been two meetings held. The first meeting took place on 15th March at the Clondalkin Equine Centre. The purpose of this site visit was to see what had been achieved from funding received from the Department of Agriculture, Food and the Marine, the vision of the local community and to consider if a similar project could be suitable for Cherry Orchard.

The second meeting took place on 23rd May and considered the on- going issues relating to quad bikes / scramblers and horses. The meeting heard that the majority of problems associated with quad bikes occur immediately after Christmas with issues diminishing thereafter for the remainder of the year. The meeting learned that the Road Safety Authority and South Dublin County Council have run campaigns on greater awareness on the responsibilities and risks with quad and scrambling motorbikes. It was the view of the meeting that the South Dublin County Council campaign literature could be used as a template by the City Council to run an awareness campaign in the run up to Christmas.

The issue of wandering horses in public spaces was also discussed. It was the view of the meeting that substantial issues continue to exist with horses in Cherry Orchard despite the presence of a first class equine centre. The meeting heard that a suite of measures are needed to tackle the issue and that enforcement alone through the collection of horses will not lead to a sustainable solution. To achieve a greater and deeper understanding on the issue the Control of Horses Section in the City Council have been invited to attend the next meeting.



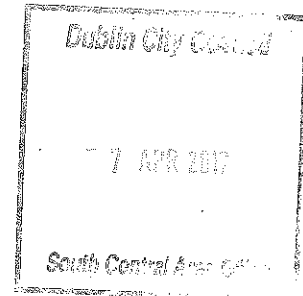
