(The report stated that there was an objection received from Dublin City Council's Planning Department who object to the extinguishment of public right of way at this location as it would not encourage permeability or connectivity contrary to the provisions of national and city policy and it <u>may also prejudice the development of</u> <u>17 houses on the site of the tennis courts (highlighted on</u> <u>the map) which were granted permission under An Bord</u> <u>Pleanala Ref: PL29N.242866 (DCC Ref: 2401/13))</u>
