# 526 Councillor Criona Ni Dhalaigh

That this Area Committee believes that it is not in the interest of good planning or community cohesion to permit an over-concentration of student and hotel accommodation in any one area of the city, especially

not one as old and historic as Dublin 8 area with an existing housing crisis. We therefore note with concern the burgeoning construction or planned construction of student accommodation as follows: 380 in Mill Street, 308 Brown Street, and Brickfield Lane, 400 in New Market, 471 in the Thomas Street Binary Hub, and so many which received planning permission already.

We also therefore note with concern the planned construction of 1300 hotel and AirBnB accommodation as follows, Aloft - Blackpitts - 200+ rooms, Maldon- Kevin street/Clanbrasil Street - 137 rooms, Hotel beside Fallons - Sheraton - 257 rooms, Tivoli redevelopment - 298 units, Mother Redcaps and Iveagh Market redevelopment - 97 rooms + 79 apart units, Charlemont Hilton are apparently adding extra floors – (tbc), Clayton Hotel beside the barge - 181 rooms.

We further believe that a moratorium on anymore student, guesthouse, hotel, AirBnB, planning permissions for Dublin 8 be agreed until a full assessment of the impact of these 1,159 expensive student accommodation units and 1300 additional tourist accommodation on the local host community is carried over the next 5 years.

That this Area Committee requests that the old Unilever site on Davitt Road be used for the purposes of public housing and community facilities. # PUBLIC DOMAIN INTERIM REPORT ON SOUTH CENTRAL ENFORCEMENT PROGRAMME 2017

The A/Public Domain Enforcement officer has engaged Certification Europe Ltd to provide services in relation to the rollout of an enforcement programme within the Sth Central Area. This programme of enforcement started in April 2017 and it is planned to run until September/October 2017 (Weather & Budget Permitting). Two authorised officers have been employed to carry out this work @ €42 per hour per person. Gardai have also been secured on non public order duties to assist in this work. The rate for the Gardai is €40 per hour per person. The A/Public Domain Enforcement officer is also involved in working along side the above mentioned staff. Locations for the installation of CCTV have been identified and CCTV cameras have been installed at a number of locations. It is planned to put up wall/pole of shame (Photos of Possible Dumpers) in areas. Images are currently been downloaded in relation to the Wall/pole of shame.

To date the programme has covered the following issues:-

 Enquiries from residents in relation to the disposal of their household waste (Door Knock)

- Inspecting areas prone to incorrect presentation of waste (Urban Villages, Thomas Street & area) Bags have been removed from these areas and inspected..
- 74 fines have been issued under the 2013 Bye Laws in relation to the storage, presentation and collection of household and commercial waste. Information has also been given to residents & businesses on possible ways to reduce their waste costs, items for recycling and correct presentation of waste etc.
- 15 fines have been issued under the 1997 Litter Pollution Act (Illegal Dumping) and 14 fines have been issued for failing to clean up after dog (Removal of Dog Faeces)
- Installation of CCTV cameras in areas prone to illegal dumping/incorrect presentation of waste.
- Patrolling parks and open spaces regarding dog fouling and issues relating to anti social behavior have been death with by An Gardai Siochana. (Drinking in Public Places)
- In the areas we have door knocked there is very little evidence of compliance in relation to segregation of waste at source.

# South West Inner City Area Report

#### St. Teresa's Gardens

Phase 1 of the St. Teresa's Gardens Regeneration Masterplan is now complete following the demolition of the 6 blocks on the Eugene Street side of the site. The refurbishment of 2 blocks at the front of the complex is also complete. There is currently 1 occupied flat in the 4 remaining blocks awaiting demolition. A Contractor has been appointed to demolish the 2 rearmost vacant blocks with works due to take place in June-July.

The football club moved into new ground floor premises in the front refurbished block in January whilst the boxing club are due to make a similar move shortly.

Tenders documents for the construction of 34 houses and 16 apartments are due to be issued this month with a view to the construction of the new dwellings starting in quarter 4 this year (subject to the completion of enabling works).

Tender documents for Precinct Improvement Works in the area between the refurbished blocks are also due to be issued shortly. Works will include a small playground, plaza, additional parking and electronic gates.

#### **Dolphin House**

A Part VIII planning application was approved at the October 2014 City Council meeting for demolition, new build and refurbishment at Dolphin House (phase 1). A total of 96 existing flats will be replaced by 100 new units. The demolition of the 2 'canal' blocks was completed in early 2016 whilst the new build and refurbishment commenced on 17<sup>th</sup> October last year and are progressing satisfactorily. Work is scheduled to be completed in Autumn 2018.

Planning permission was granted to Fold Housing Association in November 2016 for 42 units of older persons apartments with a community centre at a site to the rear of the football pitch. Construction is expected to start in June/July 2017. It would be the intention to transfer the existing tenants in Dolphin Park to the new dwellings. Dolphin Park, which consists of 44 bedsits, would then be demolished to allow for new housing to be developed on the site.

# **New Public Park, Cork Street**

Works to develop a 0.6 hectare neighbourhood park on the site of the demolished Chamber Court flats on Cork Street commenced in February and are progressing well. It is expected that the park will be completed by summer 2017.

# St. Audoen's Park, High Street

St. Audoen's Park is included in the Liberties Greening Strategy. As part of the proposed improvements to High Street it is planned to enhance the area by improving accessibility, permeability and circulation throughout the park.

A Part 8 planning application for the project was agreed at the July 2016 City Council meeting. Tenders have been submitted and are currently under assessment.

#### New Public Park, Bridgefoot Street/Island Street

Plans to develop a high quality neighbourhood park at Bridgefoot Street have been reactivated and public workshops were held on Thursday, 20th April in St. Catherine's Church, Thomas Street. The consultant landscape architect has prepared proposals which were presented at a second workshop which took place on 15<sup>th</sup> June.

#### Newmarket

A Public Realm Improvement Plan for Newmarket Square and its environs is now complete. The Plan describes, supports and guides the implementation of improvements to enhance the use and attractiveness of the area. Following agreement at the February Area Committee meeting a Part 8 planning application for the project was advertised on 20<sup>th</sup> February. A copy of the plan was available for inspection in the Planning Department in the Civic Office for 6 weeks from that date. A report in relation to the Part 8 planning application was included on the agenda for last month's Area Committee meeting and it is expected that a full report will be prepared for the July City Council meeting.

#### **Francis Street**

A Public Realm Improvement Plan for Francis Street, Hanover Lane and part of Dean Street has also been completed. The plan provides for provides for a more pedestrian friendly environment which encourages people to visit the area on foot. The plan also supports the continued commercial operation of the Arts and Antiques quarter. Following agreement at the March Area Committee meeting a Part 8 planning application for the project will be advertised on 28<sup>th</sup> April. A copy of the plan was available for inspection in the Planning Department in the Civic Office for 6 weeks from that date. The closing date for the receipt of submissions or observations is 28<sup>th</sup> June.

# **Dolphins Barn**

A Public Realm Improvement Plan for Dolphins Barn is being prepared at present. The cost associated with the plan is provided for in the 2016 Discretionary Fund. A very well attended community workshop took place in St. Andrews Community Centre on 28<sup>th</sup> November last year with a second workshop scheduled to take place in the same venue on 27<sup>th</sup> June.

### St. Luke's Church

Works in relation to the conservation and adaptive reuse of St. Luke's Church are ongoing. Dublin City Council plan, at the same time, to create a small urban park in the north graveyard (facing St. Luke's Avenue) and to carry out improvements to the south graveyard (access via Newmarket Square). Works to both graveyards are due to take place between mid June and the end of September whilst works to the church building are also expected to be completed in early autumn.

#### The Liberties Festival and Liberties Awards

The 2017 Liberties Festival takes place from 15th to 22nd July with a packed programme of arts and community events across The Liberties. The festival is Dublin's longest running and has received a number of accolades in recent years. The main sponsors of the festival are Dublin City Council and Diageo Ireland. This year SICCDA and The Liberties Festival have inaugurated The Liberties Awards, recognising excellence in the community and local businesses. #### Improvement works at Cashel Avenue and Captains Avenue

Improvement works at Cashel Avenue and Captains Avenue consisting of new parking zones, new footpaths and a plinth wall surrounding the greens have been completed. The works were funded from the South Central Area Discretionary Fund 2016. Reseeding took place at both locations this month and trees will be planted towards the end of the year.

# **Summer Projects 2017**

Planning for four voluntary summer projects in the Ballyfermot/Drimnagh is well under way. The following have registered for this year: -

#### **LCDC**

The Dublin City Local Economic and Community Plan action Plan for 2017 was launched in June. The plan identifies actions that will be undertaken by the City Council, other statutory agencies and community development organisations during 2017.

The Dept. of Housing, Planning, Community and Local Government City Community Facilities Scheme is open for applications. Funding will be available for groups to carry out small capital projects or work that will promote participation and engagement in local communities. The grant is being administered by the LCDC and the City Council. Closing Date for application is 30<sup>th</sup> June 2017.

#### **Historian in Residence**

Ms. Cathy Scuffil has been appointed by Dublin City Libraries to the South Central Area to work on a part time basis with various history events, topics and projects across the area. The historians will be available to do walks, talks, tours, exhibitions, publications etc There is also a Decade of Commemorations fund for history events, similar to the 1916 Rising grants scheme, the application form and guidelines are online (there is no closing date).

# Halloween 2017

In Ballyfermot the community team are working with a steering group from the Partnership and Youth Organisations to identify possible community events around Halloween.

Community staff are working with the Bosco Youth Centre and Drimnagh Residents group to organise events for the Drimnagh area.

#### Street Feast 2017

The City Council supported the annual Street Feast in the South Central Area. Over 20 Street Parties were held in Ballyfermot, Walkinstown and Inchicore. Council staff will be in contact with residents who organised Street Parties to offer support and encourage them to organise play days and other activities.

# **Ballyfermot /Chapelizod**

The Chapelizod Community Choir which was set up by community staff is up and running with over 40 people from the Ballyfermot /Chapelizod area attending on a weekly basis. Maryfield Nursing Home will be the venue for the choir and community staff are in the process of supporting a committee to form to manage the choir.

The City Council are working with Muscular Dystrophy Ireland on an environmental project on the exterior of their premises at the junction of the Kylemore and Lucan Road.

The Chapelizod Community Festival which is supported by Dublin City Council takes place from the 2nd -9th July. The programme of events is currently being finalised. Further details can be found on <a href="https://www.chapelizodfestival.com">www.chapelizodfestival.com</a>

Community staff are supporting school programmes in the area. Children from St. Dominic's and neighbouring schools attended the launch of the Fairy Door installations in Markievicz Park.
