1. Minutes of meeting held on 3rd May, 2017
Minutes agreed. In relation to the sustainable delivery pilot scheme, Mr B. O'Brien, Acting Executive Manager (Traffic), said that the pilot is working well and there will be a further report to the SPC. Reports on "armadillo" cycling dividers, and on a contra-flow cycle lane across the railway and Royal Canal at the proposed Broombridge Luas terminus will be submitted to the next meeting of the SPC.
 2. Letter dated 16th June, 2017, from Private Secretary to the Minister for Transport, Tourism and Sport regarding the regulation of rickshaws.
Letter noted.

3. Parking Appeals Officer's Annual Report 2016
Report noted. It was agreed to write to the Minister for Transport, Tourism and Sport to request the introduction of a tiered system of parking fines for persistent parking offenders
4. Advertising on new pay and display parking meters - verbal report (deferred from May SPC meeting)
Report Noted. The City Council proposes to advertise free tourist attractions on 4 pay and display parking meters on a trial basis.
5. Coach parking in Dublin city
Report noted. A more detailed report will be submitted to the September meeting of the SPC.
6. Liffey Cycle Route - verbal update

7. Feasibility study on Parking Protected Cycle Lanes
Report noted. The City Council is meeting with the NTA to discuss possible ways of implementing the parking protected cycle lane scheme at a reduced budget.

9. Street Name plates (deferred from May SPC meeting)
Report noted. It was agreed to seek advice from the Institute of Designers of Ireland on the design of street nameplates and report back to the SPC in six months.
10. Operation of horse drawn carriages (deferred from May SPC meeting)

11. Minutes of Cycling and Walking Sub-Committee meetings held on 7th December, 2016 (deferred from May SPC meeting) and on 1st March, 2017
Minutes noted. The Chairperson noted that funding will be made available from the start of the 2017/2018 school term to provide cycle training in primary schools.
12. Luas Cross City works (verbal update – Mr Derek Dixon, Project Engineer, Dublin City Council Luas Cross City Liaison Office)

13. Letter dated 16th March, 2017, regarding emergency Motion agreed at the South Central Area Committee meeting of 15th March, 2017 (deferred from April SPC meeting)
It was agreed that the Manager would issue a response to the South Central Area Committee in relation to the traffic issues raised in the letter.
14. Motion in the name of Councillor Dermot Lacey: "This Committee requests an overall examination of cycle lane routes junctions to provide dedicated traffic lights for cyclists and provide filter arrows for drivers preventing them from turning left or right with the appropriate signal."
It was agreed to defer Cllr Lacey's Motion to a further meeting and seek further clarification on it.

Report noted. It was agreed to refer the Draft Dublin City Council Control of Stationless On-Street Bicycle Hire Bye-Laws 2017 to the City Council to recommend holding of the public consultation process.
