1) Request for Zebra Crossing Not Recommended on Warrington Place, SR 17669

Having carried out a site inspection it was determined that the difficulty of crossing and volume of pedestrians did not warrant a controlled crossing. Vehicular speeds were also noted as relatively low.

Dublin City Council for the most part do not recommend Zebra crossing as they are generally not effective at changing driver behaviour and may provide a false sense of safety to pedestrians. A pedestrian does not have the right-of-way until they actually step onto a zebra crossing.
