D) to confirm if the new rules brought in by the Minister, for landlords to supply carbon monoxide alarms, applies to council properties? Also could the manager confirm one will be provided to the tenant? In July the response stated that the dwelling would be inspected to consider if the alarm was to be provided and also to consider the provision of a fire blanket. Could the manager provide an update on that?
