# Environmental

The Community Team along with members of the Public Domain Team worked extensively with local residents to support this years' Pride of Place Entry for the North West Area. The residents and environmental upgrades in Doon Court, Graigue Court and Knowth Court and surrounding areas are continuing to organise and attend meetings with the groups as they work on their presentation for the competition. The Pride of Place judging took place on the 29<sup>th</sup> August in the Council Chambers, Ballymun Civic Offices. The group put a big emphasis on the importance of passing down their environmental and community skills to the next generation. This was a great success and was attended by approximately 80 local community and organisation members. The Judges were very impressed with the strong and enduring sense of community spirit displayed by the group and the area in general.

Ongoing meetings took place with Public Domain Staff also in relation to local environmental initiatives and distribution of planters, blue bags, brushes etc. The Community Team continued to work with environmental groups on various planting projects. To date, over 50 community groups have received support and plants from the section.

The third and fourth Greening of the Area Workshops (GAP, DCC, local residents, Poppintree Youth Project) took place in Doon Court and Shangan Green. Continued meetings took place for the City Neighbourhood Awards Ceremony which took place in Ballymun Civic Office on Thursday the 7<sup>th</sup> September at 7pm.

#### **Events**

The team members continued to roll out the new plan for Otherworld Festival 2017 along with staff from Axis, Youthreach, BRYR, Aisling, PYP and others. A number of new community group members have become involved and are working on a number of initiatives including a new revamped 'Zombie Walk Parade' and an even bigger space designed by community groups for the Plaza on Halloween Night.

The Community Team members attended several organising meetings and took a very active part in the Family Fun Day organised by the Ballymun Network for Assisting Young

People and Children which took place on Friday the 25<sup>th</sup> August at the Balbutcher Lane site beside BRYR. This event was a fantastic success, with over 1200 people in attendance, it is a great example of how well things can work when all major organisations get involved.

#### Pyrite

The last phase of remedial works has started in the Carton Estate. To date 52 families have moved out of their home to allow for pyrite remedial works. There are two houses remaining on Carton Terrace that require pyrite remedial works. This work is due to start on 18<sup>th</sup> of September. There are four houses that require remedial pyrite works in Owensilla, work is due to start at the end of September. Ballymun will be free of all identified pyrite properties by Christmas of this year.

# Consultation for Super Depot

Dublin City Council has scheduled a follow up information meeting for the residents of Carton in the Poppintree Community Centre and the residents of St Margaret's halting site in the Community Room in St Margaret's, on the proposed Super Depot for the site to the front of Carton Way and IKEA. The meetings are due to take place on Tuesday 19<sup>th</sup> of September.

# **Druid Court**

Dublin City Council held an open meeting to discuss blocking the arch at Druid Court (61-72) following a number of anti social complaints. It was the opinion of the residents that attended the meeting that blocking the arch was not going to solve the issues. It was suggested that Dublin City Council block the court off in the middle. A follow up meeting to discuss this further was held on Wednesday 13<sup>th</sup> of September.

# **Estate Enhancement**

Bollards are to be reinstated in Sandyhill Gardens at the request of the residents. Kissing gates that were installed in Marewood Crescent are to be modified to be more effective as discussed with the residents living in the Crescent.

# Anti Social Behaviour

There has been an increase in the level of crime in the west area in Ballymun. Not all issues have been reported formally as there is a real fear for people's safety. Dublin City Council continues to work with the Gardaí in relation to these matters. The Safer Ballymun meeting took place on the 12<sup>th</sup> of September at 7pm in the Council Chambers.

# Ballymun4Business (B4b)

The B4b Steering Committee meets on a regular basis and has lined up a number of networking events for 2017. A number of the B4b members helped out with a clean-up of Poppintree Park after the park run on 18<sup>th</sup> August. B4b also donated a 'Buddy Bench' to the Andy Morgan Foundation which is now located in the park.

Ballymun has entered the BOI Enterprising Towns Awards and a Steering Committee has been set up by B4b to facilitate our bid. Planning is well under way. Local comedian and actor Eric Lalor has been brought on board to MC the judge's visit. The judge's visit will take site visits to key initiatives and businesses in Ballymun such as The Rediscovery Centre, Innovation Hub, Musgrave Market Place and Axis. We will encapsulate all the great community work through a number of short videos featuring people, who live, work and study here in Ballymun. The judge's visit has been confirmed for Tuesday 3<sup>rd</sup> October.

#### Food Enterprise

Enterprise Ireland approved a grant of €11,250 to research the viability of creating a food enterprise hub in Ballymun. This grant is based on a total spend of €22,500 which the Area Office is co-funding. We are now in the process of tendering for a consultant to carry out the research.

### Vacant Neighbourhood Commercial Units

We are awaiting quotes from suppliers in respect of remedial work on the vacant unit in Sillogue. We are considering carrying out this work to make it a more attractive proposition for potential tenants.

<u>Free Wi-Fi for Plaza</u> – The Wi-Fi installation has been completed and is now fully functional. The Economic Development Officer has been in touch with DCU who are open to the prospect of their 'Next Generation Management' students taking it on as a project to develop a strategy around maximising its potential. A meeting will take place over the next week.

## Civic Alliance Update

The next Civic Alliance Meeting was held on 14<sup>th</sup> September 2017, where there was a presentation on the North City Operations Depot and an update on the LAP.

The Economic Sub Committee met on 31<sup>st</sup> August. Liam Barry, Economic Development Officer gave an update on the feasibility application which was submitted to the Regional Development Fund to research food enterprise space in Ballymun as mentioned above. There was an update on the B4B network, highlighting recent events. Ballymun have put forward a bid for the Enterprising Towns Competition and the judges will be visiting Ballymun in October. There will be a presentation on how enterprise and community work together. There will be another start up event in November; it will be about growing business internationally via ecommerce. Mark Kellett will invite a PR expert to the next sub committee meeting to give guidance on developing a communication strategy.

<u>The Social Sub Committee Meeting</u> which was due to be held on 11<sup>th</sup> September was cancelled. A sub-committee is looking at Welfare Dependency in Ballymun.

<u>The Physical Sub Committee</u> held a meeting on 7<sup>th</sup> September. There was an update on the LAP, the Northern Site, Civic Office new lettings and detenanting of the shopping centre.

A package of projects in Sillogue has been approved to proceed to preliminary design stage.

Sillogue Avenue – Main Street Link Road, Gateway Crescent Extension, Sillogue Avenue Realignment (continuation of the Sillogue Avenue – Main Street Link Road). Sillogue Gardens upgrade.

The roads projects all have Part 8 approval. They require detailed design, preparation of tender documents, procurement of a contractor, contract administration and site supervision, and finally handover.

Sillogue Gardens, along with a number of other areas of older housing in Ballymun, has significant issues with existing infrastructure. The existing drainage infrastructure is in very poor condition with significant damage, blockages and other shortcomings related to the original drainage installation. There are also significant issues with the existing road and footpath construction and condition. The public lighting is also substandard. In order to address these issues major remedial works are required. These works require surveys of existing roads and drainage systems, provision of a number of costed options, detailed design of chosen option, preparation of tender documents, procurement of a contractor, contract administration and site supervision, and finally, handover.

#### Draft Ballymun Local Area Plan Update

At a Special Council Meeting on the 11th July 2017, the Elected Members considered the Draft Ballymun Local Area Plan, and the Chief Executive's Report No. 199/2017 on the Public Submissions, and Report No. 254/2017 on Motions from the Elected Members, resolved to amend the Draft Ballymun Local Area Plan, and to place the material amendments on public display. The public display period of the Proposed Material Alterations of the Draft Ballymun LAP took place from Monday 31st July to Monday 28th August 2017 (inclusive). A total of 24 no. submissions/observations were received during this statutory display period. The Chief Executive's report on these submissions (report No. 310/2017) was circulated to the Elected Members on Tuesday 5<sup>th</sup> September, and a briefing session with the Members was organised for Friday 8th September. The Elected Members have until close of business on Friday 15th September to submit motions on the Chief Executive's report. This will be followed by a report on any such motions. The Chief Executives Report on the motions received and the Draft Planning Scheme will be considered at the meeting of the City Council on Monday 2<sup>nd</sup> October at 6.15pm, where the Council will decide by resolution to make or not to make the Local Area Plan. A LAP shall have effect four weeks from the day that it is made.

#### **Shopping Centre**

The Credit Union are currently fitting out their new unit in the Civic Centre.

#### Northern Site:

Lidl is due to lodge the planning application by the end of September. It is Lidl's intention to display the plans to the public in the Ballymun Civic Centre atrium on the 19<sup>th</sup> September

from 4pm to 8pm. The North West Area Elected Members have been invited to attend a preview of the plans and do a walk around with the design team at 1.30pm on the same date before the main public exhibition.

# Small Housing Site at Balbutcher Lane

Quotes were recently obtained from sales agents for the proposed marketing and disposal of this site. We hope to be able to put the site on the market in the near future.

# **Safety Fora Updates**

# Safer Ballymun

A meeting of this forum took place on Tuesday September 12<sup>th</sup> at 7pm in the Council Chamber, Ballymun Civic Centre. It was well attended by local residents, DCC staff and public representatives.

Councillor Noeleen Reilly gave an update on the recent City Neighbourhood Awards held in Ballymun Civic Centre and thanked everybody involved for their efforts. The Gardaí gave the crime statistics for the period since the last meeting. Issues that were discussed following this included the recent shootings, anti-social behaviour in particular drug dealing in the Courts, and illegal dumping. Residents also expressed concern about Halloween approaching and what plans are being put in place for this. Safety Week will take place from Monday 23<sup>rd</sup> of October to Friday 27<sup>th</sup> October and various events are being planned during this week.

The next meeting is scheduled to take place on Tuesday, October 24<sup>th</sup> and this meeting will be the launch of Safer Ballymun Safety Week.
