1 Lord Mayor's Business

The Lord Mayor opened the meeting by expressing condolences on his own behalf and on behalf of the City Council to the families and friends of the following recently deceased:

Mansion House for the people of Dublin to express their sympathy and solidarity with the people of Barcelona. The Lord Mayor also wrote to the Spanish Ambassador to Ireland and the Mayor of Barcelona to express the sympathies of the people of Dublin.

- *Mrs Olive Bell*; The mother of former Lady Mayoress Jill Lacey who lived in the Mansion House with Lord Mayor Dermot Lacey and Jill during their term as Lord Mayor of Dublin and who died on 24th August, 2017.
- *Susan Jackson*; The aunt of Councillor Vincent Jackson who died aged 105 years. She was a regular visitor to the Mansion House on her birthdays.

The following amendment to Report 287/2017 was proposed by Cllr Dermot Lacey, Mannix Flynn, Chris Andrews, Paddy McCartan, Sonya Stapleton and Claire Byrne and approved by the City Council:

Dublin City Council agrees that in conjunction with the works agreed under the Part 8 procedure for the Herbert Park to Donnybrook Road Dodder Flood Relief Works/Greenway listed at Item 7(b) on the agenda for the Council meeting of the 4th September 2017 to request the Chief Executive:

- 1. To engage in meaningful discussions with the Bective Lawn Tennis Club to agree:
  - a) Prior to commencement on site, Dublin City Council (DCC) shall liaise with Bective Tennis Club (BTC) and for the duration of the project:
  - b) Agree with BTC terms for access to the Bective Tennis Club grounds for the purpose of its works, including scheduling of works to completion.
  - c) Remediate any damages to the lands caused by the works, including fencing planting, pathways, security, screening measures and reinstatement of playing surfaces.
  - d) Agree with BTC the boundary treatment prior to completion of detailed design stage.
  - e) Review the provisions for Eglinton Terrace including upgrading of fencing as part of the overall Dodder Greenway Project.
- 2. To enhance the proposed greenway as an amenity by:
  - a) Including in the implementation of the scheme, measures for restoration of habitat and character of the riverbank as far as reasonable and practical in consultation with the National Parks Wildlife Services and DCC Parks and Landscape Services.
  - b) Provide seating and viewing points along the greenway.
  - c) Consider the proposal for a supplementary route via Eglinton Terrace as part of the overall Dodder Greenway.
  - d) Provide appropriate public lighting for the route as part of the overall Dodder Greenway.
  - e) The height of the flood defence wall shall be kept to a maximum height of 1.1metres above the level of the greenway.
- 3. In order to ensure adequate community engagement, continue to liaise with the Dodder Action Group in the implementation of the scheme.

This City Council asks that the Chief Executive begin the process of taking the Iveagh Markets back into the full control of Dublin City Council. The terms of the lease granted to Mr Keane, first in 1997 and then again in 2004 under report number 218/2004 have been frustrated by the actions of the developer.

Report number 218/2004 clause 7 states that "Mr Keane or his nominee shall, within 36 months of the execution of the Agreement for Lease, have completed the redevelopment work on the market buildings and the construction of the hotel in the case of delay due to strikes, lockouts or any other circumstances outside the control of Mr Keane or his nominee. Such longer period if required to be agreed with Dublin City Council at the time the delay occurs. Mr Keane or his nominee shall not use the premises for any purpose other than redevelopment as a commercial market and the construction of a hotel".

Clause 12 "Dublin City Council reserves the right to re-enter on the entire property and resume possession thereof should Mr Keane or his nominee fail to commence and complete the redevelopment and construction works within the specified period or in the event of bankruptcy or insolvency of Mr Keane or his nominee, save in the case of a financial institution which has entered into a mortgage with Mr Keane or his nominee for the purposes of financing the redevelopment and construction works"

The terms of this extension of the lease have not been met and so Dublin City Council should begin the process to transfer the markets back into their full control with a view to developing the Iveagh Market as per Clause 12.

(C) The City Council suspended Standing Orders to agree the following two emergency motions to be taken without debate:

That Dublin City Council:

- Notes that two of the five schools built under the 2008 rapid build programme found not to be fire compliant are in the Dublin City Council area namely Belmayne Educate Together School and St Francis of Assisi National School Belmayne
- Further notes that the inspections of these schools and the findings of noncompliance by the Department of Education took place in October 2015 but knowledge of the non-compliance in these five cases only became public knowledge on 1st September 2017
- Further notes with concern the efforts made by the Department of Education throughout the year to not make the findings of these inspections public when subjected to a Freedom of Information request by the Dublin Inquirer newspaper.
- Calls for the Department of Education to make prompt contact with the principal, staff representatives and parents representatives of all the affected schools and provide them with the necessary reassurance that all remedial measures have been taken to make the school buildings safe

- Calls for the prompt delivery of the promised permanent builds for Belmayne Educate Together and St Francis of Assisi National Schools
- Requests that the Chief Fire Officer reports on the quantity of public and commercial buildings and domestic dwellings built in the Dublin City Council area that have been self certified as fire safety compliant by the construction industry and furthermore what resources would be required for Dublin City Council to conduct a comprehensive fire safety compliance inspection of all of these buildings.

## Submitted in the names of Councillor M. O'Brien and E. Ryan

This City Council recognises the serious fire issues discovered by recent Department of Education fire safety audits at several rapid build schools in North Dublin installed by Western Building Systems Ltd, who used single layers of 12.5mm plasterboard in parts of the buildings construction which would not achieve sufficient fire resistance to provide the required time for evacuation and requests comment from the manager on whether such construction practices have been used in the city council's residential rapid build homes.

Furthermore, the elected members request a detailed report from the city's Fire Officer on the proposed remedial works the Department of Education believes will address the serious fire issues discovered at two rapid build schools in Belmayne, North Dublin -Belymayne Educate Together and ST. Francis of Assisi - and to provide information to the elected members as to what contingency plans have been to put in place in both schools to ensure the safety of the school children, teachers and parents until the proposed works commence on September 17th. **Submitted in the name of Councillor J Lyons**
