Placing CCTV cameras at locations where individuals are illegally depositing waste is of no value as Dublin City Council cannot identify people and therefore not able to take any enforcement action under the Litter Pollution Acts.

All the payphones on the streets in the Dublin City Council administrative area are owned by EIR. Therefore, Dublin City Council cannot instruct EIR to remove their payphone kiosks.

Over the last three years Dublin City Council (DCC) has actively engaged with EIR on the removal of redundant payphones. While recognising that EIR is the universal service provider of public payphones in the country, Dublin City Council deployed the ComReg criteria for permissible removals (Section 4.1 of ComReg 1469 Provision of Public Payphones 2014) to request EIR remove kiosks at 44 locations in the DCC administrative area.

EIR have removed one third of the payphones requested and their removal required persistent pressure from Dublin City Council and/or An Garda Siochana. Most of the unsightly kiosks are on EIR's list of kiosks for removal. Dublin City Council awaits notification from EIR on when removal will take place.
