Reply

Litter bins are emptied a minimum of once daily in the Drimnagh area. Bins are emptied twice daily in busier areas including shopping locations for example. Main streets and thoroughfares are cleaned daily and other areas are cleaned on appropriate schedules including weekly, monthly etc. All areas are inspected regularly and where a need for additional cleaning is identified additional resources are allocated to ensuring cleaning is carried out.

In respect of the response time for service requests received via the customer services centre (including Fix My Street) a service level commitment has been given to achieve a target of attending to all illegal dumping and street cleaning requests within 24 hours.

It is not possible to provide a breakdown of requests received for the Drimnagh area or the response times for these requests. Requests are recorded on an administrative area basis.
