

Local Community Development Committee Annual Report 2017 and Report on LCDC Membership 2018

Hereunder is the Annual Report 2017 of the Dublin City Local Community Development Committee and the membership of the Dublin City Local Community Development Committee for 2018 for formal appointment by resolution of the Dublin City Council.

Background

The Dublin City Local Community Development Committee (LCDC) was established in 2014 in accordance with the Local Government Reform Act, 2014 and the Guidelines for the Establishment and Operation of Local Community Development Committees issued by the then Minister for the Environment, Community and Local Government in July 2014.

The key functions of the LCDC include:

- The preparation, implementation and review of the community elements of a Local Economic and Community Plan for the Dublin City Council administrative area
- Co-ordination, management and oversight of local and community development programmes that have been approved either by the relevant local authority or by agreement between the LCDC and another public authority
- The co-ordination more generally of local and community development programmes within its operational area
- The administration and monitoring of the Social Inclusion and Community Activation Programme (SICAP) and other grant or funding schemes as they arise

The Dublin City Local Economic and Community Plan 2016 - 2021

In 2017 the LCDC, together with the Economic Development and Enterprise SPC, published the Action Plan 2017 and the Report of Action Plan 2016 of the Dublin City Local Economic and Community Plan 2016 – 2021 (LECP). A briefing session was held on 01 June 2017 to inform stakeholders of LECP progress achieved.

The Social Inclusion and Community Activation Programme

The Social Inclusion and Community Activation Programme (SICAP) is funded nationally by the Department of Rural and Community Development; the Dublin City LCDC is the contracting authority for the programme which is delivered in five discrete 'Lots' across Dublin City with an overall budget in 2017 of €5.3 million. During 2017 the five SICAP Programme Implementers worked with 8,261 individuals and 615 local community groups

across the City. During the course of 2017, the LCDC carried out an end of year review of the 2016 programme and a mid-year review of the 2017 programme.

During 2017, a second iteration of SICAP (2018 – 2022) was subject to a public procurement process. The LCDC carried out a full tender evaluation process and contracts for the new programme are now in place in each of the five Lots.

Community Facilities Scheme 2017

In March 2017 the then Department of Housing, Planning, Community and Local Government allocated €64,500 to the Dublin City LCDC for the awarding of small-scale capital grants to community and voluntary organisations. Following an open application process, 68 local community or voluntary groups were awarded grants averaging €900 and ranging in amount from €250 to €1,500.

Healthy Ireland Fund 2017

In August 2017 the Department of Health invited the Dublin City LCDC to submit proposals for local initiatives that would support the implementation of national policy to improve the health and well-being of the population. The LCDC was successful in its application for €100,000, the maximum value of the fund, and five local initiatives were implemented from January 2018 to May 2018. The development of a Healthy Ireland Strategy for Dublin City will be completed by end June 2018.

RAPID 2017

In November 2017 the Department of Rural and Community Development launched an updated version of the RAPID Programme, with a €64,500 allocation for Dublin City. The Dublin City LCDC invited one citywide project, the Dublin City Farm and Ecology Centre to apply for the funding. The application was successful and the full amount of funding was awarded to the Dublin City Farm to purchase a variety of equipment for the farm, which is due to open to the public in late 2018.
