The flood in 2011 was an exceptional flood and the whole city was affected. Consultants at the time inspected the area and found that "the source of the flood waters was surface water drainage, which was inundated due to heavy prolonged rainfall. Flooding appears to be a combination of out of sewer flooding and overland flooding. Flood waters built up at a low point at the corner of Blarney Park. Flows from an overwhelmed culvert at Poddle Park also contributed to this flood."	0
