

**Questions to Chief Executive
Central Area Committee Meeting
11th September 2018**

Q1 Councillor Ray McAdam

To ask the Chief Executive to confirm whether the laneway to the rear of (details supplied) is in the ownership of Dublin City Council.

Q2 Councillor Gaye Fagan

To ask the Chief Executive to have a look at the bin situation at (details supplied). Is there any way one of the railway arches could be re-opened and the bins stored in there.

Q3 Councillor Christy Burke

To ask the Chief Executive to put in place a camera at the rear of the houses in (details supplied (a)) in order to identify who may be dumping and also that Dublin City Council put in place a design for the overgrowth area at the side of (details supplied (b)).

Q4 Councillor Christy Burke

To ask the Chief Executive to put in place a system that the (details supplied (a)) are cleaned daily, the stairwells be washed down every week, that Dublin City Council meet every month with local residents from each block to monitor the works. Also that the service provider delivers a service to the residents in the units on (details supplied (b)).

To ask the Chief Executive when work will commence on the development for new units on (details supplied). And will the development have special adapted units for wheelchair use or other health issues.
