To ask the Area Manager to arrange for an inspection of *(details supplied)*. Residents are complaining of a constant sewer blockage at this shore which the tenant will not address.

# <u>Reply</u>

The public sewers at *(details supplied)* were inspected on 30th July 2018 last and found to be unobstructed and flowing freely. Any difficulties being experienced are therefore located on the private side which is the collective responsibility of the households served by the private drain. The DCC Drainage Crew inspected the outfall manhole on the private drain in the front garden of No.492 and found it to be clear and unobstructed. Any blockage/breakdown on the combined drain would therefore appear to be to the rear of the property which DCC is not in a position to enter. DCC Drainage Division has notified all households served by this drain of their collective responsibility for its maintenance and of their duties under the Water Services Act 2007 to maintain the free flow of private drains and to avoid causing nuisance or risk to public health or the environment.

- (1) There has been any previous occasion when a resident permit parking ballot has been fast tracked?
- (2) If there has been precedent of fast tracking permit ballots, was there any opposition to the outcome and how was it resolved?

# <u>Reply</u>

It is a long standing policy that the Environment and Transportation Department would insist on a petition from residents (25% of households on the road) in order to consider any proposal for a Residential Pay and Display and Permit Parking Scheme and ballot of residents in that regard. The petition provides some reassurance that there are at least a number of residents in favour of a request for introduction of a scheme and that a ballot may be warranted.

Ballots have been fast tracked in the past where residents have indicated an urgency, or Parking Enforcement are aware of the urgency, where for instance an adjoining street is balloting on a scheme and its introduction will impact on another street.

Regardless of how a ballot of residents comes to pass it is the Council's view that the result of the ballot is the only reliable means to determine the preference of the majority of residents and regardless of the outcome there will be residents that remain in favour and against the proposal.

- the radiator in the front upstairs bedroom leaked and caused water damage to come through to the kitchen roof - the tenant has replaced the floors herself but is asking that we repair the water damage to the kitchen roof.

# **Reply**

Dublin City Council staff from Housing Maintenance and the Electrical Services have called on numerous times to this property but have difficulty in gaining access to it. However, we can confirm that the bath has been re-fitted and is now secure. Our Electrical Services Division called to the property and have renewed the electrical sockets in the kitchen. The kitchen press doors will be measured and replacement doors ordered and these will be fitted when they become available. Arrangements

are in place to have the kitchen ceiling painted. The repair/upkeep/maintenance of the garden fence is the responsibility of the tenant.

To ask the Area Manager if the Council are still carrying out the door to door knocking with the Waste Management Section to ascertain if residents can prove that they are disposing of their waste legally. If not, why?

## **Reply**

The Bye Laws for the Storage, Presentation and Colllection of Household and Commercial Waste 2013 make provision for Authorised City Council Officers to determine compliance with the Bye Laws in relation to disposal of household waste. A number of methods are employed. Currently spot checks campaigns and canvassing in writing is being used. Door to Door campaigns required additional resources that very often do not yield good returns. The Gardai may be required to attend with authorised officers for H&S reasons. To date Waste Management and Public Domain have worked together sharing resources however some constraints are in place due to GDPR and FOI.

Please see relevant section of the Bye Laws:-

8.h A holder shall enter into a contract with an authorised waste collector for the collection of their household waste or commercial waste, unless otherwise authorised in writing by an appointed person. A holder can show compliance with this Bye-Law by demonstrating to the satisfaction of an authorised person that they hold a current contract as aforesaid or a current authorisation as aforesaid.

**8.b** holder <u>or</u> an authorised waste collector shall, when requested to do so, provide information in writing to an authorised person in a specified format regarding the measures taken by them to collect, store and dispose of waste

# Reply

The free city wide household bulky waste collection service is no longer available to any area of the city as it was decided that this free service was contrary to the core principle that the person(s) generating the waste should pay for its disposal, regardless of the type of waste been generated. The associated costs of this service had also become unsustainable and had reached approximately €500,000 per year. The service was therefore discontinued in favour of a more flexible and accessible service which is available on demand all year round and for which households pay a nominal fee which is currently €40.00. This service was introduced in May 2016 and has proved very popular with the public. Average collection time between request and collection taking place is currently 3 – 4 days and unlike the previous service it operates all year round. Full details of the service are available on the City Council website. The waste management department would not be in favour of reinstating the free collection service as it is not considered an efficient use of our resources.

To ask the Area Manager to explain why residents on *(details supplied)* were unable to gain access to or leave their homes by car during the recent 'Rock & Roll' half marathon and why these restrictions were not communicated directly to residents in a leaflet drop?

## **Reply**

The "Rock & Roll" Half Marathon is in its fourth year taking place in the City, and has been a very successful and well received event, with no major issues having been reported in previous years. This year, however, the organisers were required to find an alternative route for the event as the Phoenix Park was unavailable for the month of August, due to the Papal visit.

For the safety of all road users it is often necessary to close some roads for an event of this type and scale. While Dublin City Council supports events of this nature, which benefit the City, unfortunately the required road closures can temporarily inconvenience some businesses and residents. As part of the approval process, however, the event organisers are required to make every effort to minimise the impact of the event when road closures are a necessity.

In this instance, the organisers did notify all businesses and residents along the route of the proposed road closures. The organisers met with the residents association COVA (Chapelizod Old Village Residents Association) in relation to the event on 21<sup>st</sup> June, and follow up calls and meetings took place between 21<sup>st</sup> June and 2<sup>nd</sup> July.

Residents of Chapelizod received three leaflets informing them of the event and the closures. On 28<sup>th</sup> July a general event leaflet was distributed to businesses and residents along the route. On 1<sup>st</sup> August a specific leaflet for the Chapelizod area was distributed and on 9<sup>th</sup> August an additional Chapelizod specific leaflet was distributed at the request of a Sergeant in Blanchardstown Garda Station.

In addition, Advance Road Closure Signage was in place prior to the event. A road closure notice appeared in the Independent Newspaper on 3<sup>rd</sup> August 2018. Electronic Message Boards advising of the event were positioned along the route, AA road watch had information on Road Closures for this event and Dublin City Council's website advised of road closures in place for this event.

On the day of the event, Gardai facilitated pedestrian crossings as long as it was safe to do so for both participants and residents. Event organisers also ensured that a very experienced group of stewards were in place at this location, along with a sector lead in Chapelizod, who has vast experience of events of this nature. A cut off time of 10.23 a.m. was implemented at Mullingar House, and any athletes who had not passed this point by then were diverted onto the 10K route. At 10.45 a.m. another intermediate cut off at Knockmaroon Gate was implemented to ensure timely reopening of roads. At 11.49 a.m. a full cut off was implemented on the Lower Road in Lucan and all remaining participants were moved onto the footpaths to allow roads to be re-opened. At 12:04 p.m. Chapelizod Village was fully re-opened. This was 4 minutes later than the planned reopening at 12 noon.

Given the level of advance warning that the event organisers were required to undertake, it is unfortunate that some residents appear to have not received any notification. A de-brief meeting will take place shortly with the event organisers, where all of these concerns will be raised, and where there will be an opportunity to look for improvements which can be made for future events.

What works will this money fund? When does DCC expect to hear from the Department? How many affordable homes will be built and will there be a mix of houses and apartments?

# <u>Reply</u>

- A. The total cost of infrastructure for (details supplied) is €7,645,415. The terms of the Serviced Sites Fund Initiative provides, where a bid is successful, the Department of Housing, Planning and Local Government will contribute 75% of the overall cost and the local authority provides match funding of 25%. DCC has applied for €5,734,061.25 from the Department of Housing, Planning and Local Government, for Cherry Orchard.
- B. The proposed infrastructure includes diverting an ESB Networks underground service and an Irish Water foul main, to open up the western boundary of the site for development. To provide a new link road and access road with associated new utility infrastructure to the proposed new housing with off street parking to the houses and surface car parking to the apartments buildings. Public open spaces located off the distributor road will allow for pedestrian connectivity to the residential cul-de-sacs.
- C. The deadline for receipt of submissions was Friday 31<sup>st</sup> August. The Department has indicated that assessments will be carried out without delay.
- D. The proposed number of units proposed (details supplied) is 215
- E. The proposal includes 151 houses and 64 apartments

Work is continuing on the preparation of the Draft Local Area Plan for Park West – Cherry Orchard. Once this Draft is developed to a sufficient level of detail, and key infrastructural requirements have been determined, a workshop with the members will be held, where all aspects of the Plan can be discussed in detail. The key focus for the Plan will be providing guidance on land use, form and infrastructural requirements. Analysis of existing household type and tenure will inform the future housing requirements, in order to achieve a sustainable community.

### Housing Update for Cherry Orchard

In June this year, the Department of Housing, Planning and Local Government called for proposals under the Affordable Housing - Services Sites Fund (Department

Circular APH 1/2018). The aim of this initiative is to increase the supply of homes at more affordable price points to support households of low and middle incomes who are facing particular affordability pressures. The scheme which covers enabling infrastructure and services, aims to provide shovel ready low cost sites. Dublin City Council made a submission on 31<sup>st</sup> August 2018, seeking funding under this initiative for three sites within the City; one in Cherry Orchard and two in Ballymun. The site in Cherry Orchard which is known as the "hospital lands" is zoned Z1 (residential) and is estimated to have the capacity to deliver in the order of 215 housing units.

## **Reply**

River water stretches are monitored by Dublin City Council for drainage issues. Culverts Bridges and drainage racks are cleared regularly of vegetation, debris and litter by the Drainage Section. The Poddle Flood Alleviation Scheme is a partnership approach to address the source of flooding along the banks of the Poddle. The Lead agency is South Dublin County Council

Poddle Park and St Martins Park green spaces are maintained by Dublin City Council Parks Department. Illegal dumping is a problem along many of our waterways. Public Domain works with Waste Management and other agencies and community groups to promote a litter free environment. A survey of the area will be conducted within the next 2 weeks to assess what measures are in place and what can be done to prevent further dumping. It is customary to use signage, CCTV and awareness programmes to reduce the harm to the environment.

The Waste Management Department is committed to recycling and providing the best service we can in a busy, urban environment. We are always open to the possibility of adding new bottle banks in any area.

However, the reality is that finding sites for new bottle banks in the city is very problematic. All possible locations are investigated as to their suitability and where at all possible we will locate new ones. We are restricted in where we can place them under planning regulations (SI 600 of 2001) e.g. "*no such receptacle shall be situated within 50 metres of any house, save the consent in writing of the owner or occupier*".

Bottle banks are difficult to maintain and despite cleaning by our own staff and contractors, dumping is often an issue for us – which makes them unpopular. Furthermore, our service provider needs to be able to service all sites in a safe manner.

I hope this explains in greater detail the challenges we face in locating bottle banks in Dublin city and I would be happy to visit any suggested locations.
