

Report of the South Central Area Joint Policing Sub Committee meeting held on 28th September 2018

Dublin South Central Joint Policing Work Plan

Order: Report noted. The members noted that there was no Garda Representation at the South Inner City Drugs & Alcohol Task Force Meetings for the last year and requested consideration is given to their attendance at future meetings, subject to Garda availability.

Garda Matters

Order: Reports noted. The following issues were raised and a response was given by members of An Garda Síochána present at the meeting: -

- Increase in Anti-Social Behaviour in the Crumlin and Drimnagh Area most notably parks.
- The issues around providing a Drugs Squad at the new Kevin Street Garda Station.
- As the preparation for Halloween had started early this year it was agreed that An Garda Siochana and Dublin City Council should adopt a joint approach in the collection of bonfire material.
- The removal of four extra Gardaí at Luas stops and the surrounding area in Inchicore.
- A request that the contact number for the Public Order Unit be made available in the South Central Area.
- The provision of more Juvenile Liaison Officers in the South Central Area to deal with young offenders.
- Increase in racially motivated anti-social behaviour in the Inchicore area.
- Concern expressed over Garda numbers in all Divisions of the South Central
- Large number of youths causing antisocial behaviour around the shops in Ballyfermot.
- The roll of Gardaí in terms of evictions was discussed.
