An Garda Síochana	On going	In-person' call-backs to victims of domestic abuse and residential burglaries have been conducted by Community Gardaí, within 7 days of an incident throughout Q3 and Q4 2018. Continuous liaison with the elderly, elderly groups and key stakeholders in the area – home help, Social Workers, Health Centres. Increased interaction with the vulnerable people in the community, specifically the homeless and the elderly. Community Gardaí contact information leaflets were distributed in the District to vulnerable residents and groups. Co-operation with Homeless Services, DCC and Services for the Elderly throughout the Winter months and especially through the colder periods. Continuous liaison with workers and residents at Cambridge House – Women's Refuge Gardaí visited Lansa House on Monday 8th October 2018 and spoke with residents around the Garda role in helping people. Information was given on staying safe in the community when they are out and about away from Lansa House. Lansa house is a residential unit that provides short to medium term care to unaccompanied children arriving in Ireland and seeking Asylum. Currently there are 6 young people from various countries and backgrounds staying in the house.

Gardai distribute reflective yellow /orange jackets at schools / information stands/ public offices to cyclists / motor cyclists so as to increase their visibility on the road. Safe locking of bicycles continued to be promoted with our corporate partners, schools and third level colleges in the Dublin 2 area. Basic cycle safety and bicycle maintenance clinic, held for the first time in CBS Westland Row in November, will be considered for a rollout to all District Schools, National and Secondary for 2019. Reduce property crimes such as burglaries, thefts and robberies	Crime "hotspots" targeted	An Garda Síochána	On going	Operation Thor continues to be implemented to ensure high visibility policing that is utilised to disrupt and target criminals who engage in burglary / robbery and other serious crimes. Days of action have been completed by Detective Units in both Irishtown and Donnybrook with the assistance of the regular policing units leading to successful detections and investigations being carried out. The Crime Prevention Officer has conducted a number of security surveys and assessments to reduce the incidents of property crimes in the South East Area. They also highlight "hotspots" and allow Garda resources to be utilised to provide an early intervention to combat such crime. Prolific offenders were targeted and objections to bail made in District Court. Bail was revoked before the District Court where breaches of bail were detected. Continuous engagement with key stakeholders in a joined up approach to a successful reduction in anti-social and criminal behaviour. Uniform Gardaí on Mountain Bike Patrol concentrate on specific areas. Divisional resources such as the "Burglary Response Unit" are utilised to perform intensive patrolling of areas of recent criminal activity.

Dublin City Council & An Garda Síochána	On going	Public disorder hotspots are continually monitored and targeted by range of Garda Units including Community Policing, Operation Pier, Public Order Units and the Divisional Burglary Response Unit. In addition, reported continuous breaches of Misuse of Drugs Act around the National Drug Treatment Clinic was targeted in Q4 in to great effect. This is ongoing and includes the Community Policing & Drug Unit as well as Operation PIER. Operation Irene continues to be enforced by Gardaí. Mountain Bike / Foot patrols takes place of Parks / green areas / laneways on an ongoing basis to deal with drinking / loitering and anti social activity. Public Order Act is utilised to direct persons from an area and breaches are dealt with by way of Adult Cautions / J.L.O Scheme or Court appearance.

Garda Flickr website promoted to identify recovered bicycles and reunite them with owners. Blue Info Bikes are placed in areas of high bicycle use to promote bike safety and security, incorporating best practice for securing the bike. Staff at PEMS (Property) office continue efforts to return all seized and recovered bikes to their rightful owners through use of PULSE database. Operation currently in place in conjunction with UCD in relation to combating Bike theft on the campus. Gardai distribute leaflets / posters highlighting the need for strong security locking devices on bicycles and to take good quality pictures of bicycles so as to aid in identifying bicycles when found and restore them to their owners. Theft of bicycles in the Rathmines sub district to date this year shows a 17% reduction compared to the same period in 2017.

A total of 3,128 sq. metres of graffiti removed by the DCC appointed contractor in the year to end of October 2018, as well as recent removal of 1150 sq. metres along the Dodder banks. 14 of 22 traffic light boxes selected have been decorated so far resulting in an almost complete reduction of graffiti on the boxes. Repainting of other prominent utility boxes is being carried out. Graffiti continues to be removed by individual traders and residents, by traders groups and community / resident groups and by DCC Waste Management and other DCC departmental crews.

The following GAGA programmes are currently being delivered in the South East Area: Zumba classes aimed at secondary school level are being rolled out in St Louis High school, Rathmines and Presentation Secondary school, Terenure every Wednesday & Friday throughout November.
