
2019 Scheme of Polling Districts and Polling Places

In compliance with the Electoral (Polling Schemes) Regulations, 2005, copies of the Draft Polling Scheme were forwarded to the relevant Dáil Returning Officers, Dáil Deputies and City Councillors, inviting them to indicate within a period of five weeks any changes which they may wish to see in the Draft Scheme.

Dublin City Council gave public notice of the Draft Scheme on Monday 12th November 2018 indicating that they would consider representations received within the five week period ending 17th December 2018.

A total of 45 submissions were received as outlined in Appendix 1. The proposed amendments to the Draft Polling Scheme arising from these submissions are also listed.

With regard to the amendment of Polling Places, the appropriate Returning Officer will consider these when choosing public buildings for polling purposes. Accordingly, copies of these proposals will be forwarded to the City Sheriff and County Sheriff for consideration.

Dublin City Council will now make the Polling Scheme in accordance with the Draft Polling Scheme and with such amendments to the Draft Scheme, as it considered proper as outlined in Appendix 1.

The Polling Scheme when adopted is signed by the Lord Mayor and countersigned by the Chief Executive. The Polling Scheme made by Dublin City Council shall come into operation on the day specified in the scheme i.e. 15th February 2019.

Public notice of the making of the scheme and of the date on which the scheme comes into operation is then given stating that a copy is available for inspection on Dublin City Council's website and during office hours at the offices of Dublin City Council.
