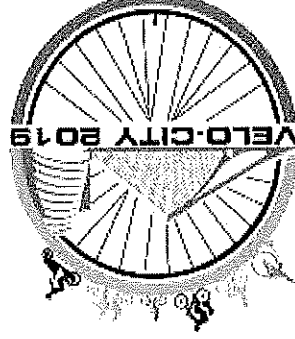
At the request of the Chair the next meeting of the Environment Strategic Policy Committee will commence at the earlier time of 2.30 pm
