Area Manager's Report South Central Area Committee Meeting 17th April 2019

Kilmainham Mill

A funding application to the Department of Culture, Heritage and the Gaeltacht was unsuccessful. Clarification is being sought from the Department. The list of essential works will continue regardless using existing funding. These works will include: -

- Asbestos survey
- Japanese Knotweed survey and management plan.
- Propping of floors
- Meshing of windows
- Roof repairs

A communications plan has been put in place and will launch on digital platforms in May on Dublin City Council website and social media. The steering committee has been on site visits on the 10th and 15th April to ascertain current offerings and usages around the city. A broader spectrum of consultation around usages of the Mill with stakeholders will commence in May / June.

South West Inner City Area Report

Francis Street Environmental Improvement Plan

This project is currently at detailed design stage and a tender package for construction of the scheme is expected to be issued in June. In advance of the main works, Irish Water intends to replace aging water infrastructure on the street and it is hoped these preliminary works will take place over summer. A communications plan will be in place for local residents and businesses.

Marrowbone Lane

A planned landscaping project alongside Braithwaite Street flats has been slightly delayed due to some design complications. It is expected to complete the project over the summer. The Area Office recently replaced failed trees at Marrowbone Lane Buildings and intends to undertake further minor landscape improvements inside the scheme over the summer.

Bridgefoot Street

The Parks & Landscaping Service advises that tenders for construction of a new park at Bridgefoot Street are expected to be issued later in the spring and it is hoped that the project will commence in 2019 and continue into next year. In addition to park, landscaping of the central median of Bridgefoot Street is planned. The Parks Service recently replaced trees along the median. Tree pruning and tidying up of planted areas was also undertaken in Oliver Bond House.

Shopfront Improvement Scheme 2019

The Area Office is currently offering small grants to businesses under the Shopfront Improvement Scheme. The deadline for participation in the scheme has been extended to 10th May. Currently, the scheme is supporting projects in The Liberties, Blackpitts and Rialto.

Busconnects

The NTA's Busconnects programme is currently inviting submissions on the 'Core Bus Corridors' element of the overall strategy to radically improve Dublin's bus network. A number of core bus corridors traverse the South Central Area including:

6: Lucan to City Centre

7: Liffey Valley to City Centre

8: Clondalkin to Drimnagh

9: Greenhills to City Centre

11: Kimmage to City Centre

The core bus corridor proposals at this stage, highlight likely required changes to road and street layouts, possible road widening, future location of bus shelters and other infrastructure, provision for cycling, pedestrian improvements. Submissions on the various core routes through South Central Area are invited until the end of April via www.busconnects.ie.

New Office Spaces Planned for The Liberties

Increasing the supply of high quality office space is an important element of the overall economic plan for The Liberties, drawing new jobs and investment to the area. The coming months will see new high quality schemes completed at former IAWS site (a new shared workspace called The Masonry opens later this month, which plans to accommodate over 700 people) and 61 Thomas Street (completion by end of year). Plans are also also afoot to expand The GEC to double its available floor space for start-ups, micro enterprises and social enterprises. The Digital Hub Development Agency is also expected to unveil its masterplan for the campus later this year, which is expected to entail a doubling of existing capacity.

Community Report for South West Inner City

The Big Hello National Community Weekend 4th – 6th May 2019.

Following the launch of the First National Community Weekend by Deputy Michael Ring, Minister for Rural & Community Development, funding has been allocated to the Dublin City Local Community Development Committee to support local residents associations or groups to host a picnic, or small community event over the May Bank Holiday weekend. A small grant of maximum €200 was advertised and administered through the Local Community Development Committee to the following groups:-

- Blarney Park Community Garden
- Family Hub Clonard Road
- Grotto Maryland
- Flanagan's Field.

Events will take place in these locations over the holiday weekend.

Annual Age Friendly Convention 2019

The National Older Person Council Convention is to take place on 9th-10th May 2019, in Donegal town. The event which will be hosted by Donegal County Council and Donegal Older Person's Council. The Older Persons Councils are an important means of engaging with older people across the Country and linking them into the work-taking place under Age Friendly City & County Strategies. The purpose of this conference is to allow Older People's Councils to network, share experiences, and identify priority issues

Bealtaine Festival

The Door embraces this year's Bealtaine Festival theme, which is one of hospitality and what it means as we age. Drama-movement workshops for men aged 50+ encourages them to take part in drama and movement exercise, get physical and keep active, exchange stories, etc. The drama will take place on Monday the 29th of April, Thursday the 9th of May, Monday the 13th of May and Monday the 20th of May at the F2 Centre11.00 – 12.30 pm. Dublin Community Clean up - 27th April 2019

Local groups across the South Central Area will "spring" into action on Saturday the 27th of April as part of the Dublin City and County Community Clean up initiative...... From the Mountains to the sea, keep it litter free. Rialto Environmental Group/Inchicore Environmental Group and several other resident groups will be involved in clean ups along the entire Grand Canal stretching from Inchicore to Harold's Cross. Many Community clean ups will also take place in various streets throughout the area.

Maryland Grotto Celebration

The local residents from Maryland will host an open air Mass on Friday 3rd of May at 6.30pm at the Grotto. This event marks the completion of the much-needed environmental enhancement of the Grotto and its surrounds. The landscaping is now complete, new benches installed, walls plastered and painted and the statue of Our Lady is lovingly restored to her former glory. In addition to Friday's service, which will feature vocalist Aisling Carabini, there will be a community street party on Monday 6th May from 2 – 6pm.

The History of Weaving in The Liberties

A Series of taster classes in weaving will commence across the Liberties in the coming weeks. These classes will take place in the community room at the Timber Yard complex in Cork Street, Myra Hall in Francis Street and St. Andrew's Community Centre in Rialto. The taster sessions will give participants an opportunity to explore their local history and in particular the vast history of the textile and weaving industry in the Liberties. All interested participants will be invited to register for a 10-week course this autumn with a view to reviving this beautiful local craft.

The Mayor on Meath Street

The Lord Mayor Nial Ring received a true Liberties welcome to Meath Street on Thursday the 11th of April. During his visit, he stopped to chat and pose for photographs with shoppers, walkers and customers in coffee shops. The members of the local Liberties Cultural Association introduced him to the local traders and they in turn presented him with gifts and stories in appreciation of his visit to their proud shopping street.

Crumlin Area Office Report

Opening Hours

We continue to operate our current hours but, as previously advised, the area office has recently lost a number of staff members due to transfers and retirements and this is becoming increasingly challenging.

Stannaway Court, Senior Citizens Complex

Following the completion of the required gas works insulation works have now commenced on block 1 (No.'s 1 -12). It is anticipated that the insulation on this block will be completed by the end of April. Preparatory works has commenced on the remaining blocks. New composite doors have been ordered and should be delivered shortly.

St. Agnes Park - Respond VHA

Final snagging works are continuing on a few units but the majority of the units have now been occupied. It is expected that all units will be occupied by the end of April.

Raleigh Square- Tuath Housing Association

Works are progressing on these units and they are on course for handover at the end of June 2019. Tuath has advised they will be seeking nominations from Housing Allocations for the 33 units (28 x 1 bed, 5 x 2 bed) in early June.

Rafters Lane - WALK VHA

Construction works are well underway on site. Due to the restricted access and confined nature of the site, the contractor has been given permission to bring in deliveries through Lissadel Court on one day a week. Deliveries are only allowed between 12.30pm and 2.30pm on Tuesdays and this arrangement is working well at the moment. The practical completion date for this project has now moved out to the beginning of August.

Armagh Road -FOLD VHA

Construction works are continuing on the site with an expected completion date of Q4, 2019. The complex will provide 97x1 bed Senior Citizens units.

Ard Scoil Éanna site

DCC has recently completed the purchase of the former Massey's funeral home to complete the site footprint. A feasibility study, including a cost benefit analysis, has been submitted to the Department for approval for funding. The feasibility study includes the redevelopment of the Lissadel Road maisonettes. The site will provide Social Housing and a Public Library. Housing Development will arrange a presentation for local Councilors when the project has received stage one approval from the DOEHLG.

Brickfield Park Area issues

The cctv camera, which was maliciously damaged earlier this year, has once again been attacked. The camera has been badly damaged and we are currently reviewing options for sourcing a more vandal proof camera and making it more difficult to access.

The Garda Crime Prevention Officer has submitted a report outlining improvements that can be undertaken in Brickfield Park to address anti-social behavior in this area. We are reviewing the report with a view to implementing its recommendations.

Knocknarea Court

A circular was recently delivered to residents by unknown persons. This circular claimed that the units breached fire safety regulations and were at "a high risk of fire occurring". We have issued letters to residents reassuring them that this is not the case. The units were

completed in December 2017 and were inspected and certified by the Design Team, the Contractor and an independently assigned Certifier as being in compliance with all relevant building regulations.

Dublin City Council is also reviewing recently introduced new regulations to determine if there are any additional items or works which could enhance the safety of recently completed buildings. If we propose to carry out any work in Knocknarea Court we will contact tenants directly.

Crumlin Park

The Crumlin Area Office, Community Section and Public Domain Section have recently organised a number of meetings to try and engage with residents in order to improve the physical environment of the complex. So far, there has been a disappointing response from residents but we will continue to try to get "buy in".

Community Report for Crumlin/Kimmage

Bru Easter Egg Hunt.

Dublin City Council Community Team in conjunction with the Bru Youth Service have organised Bru Easter Egg Hunt. This event will take place on Thursday the 18th April 1-2p.m. at Pearse Park, Crumlin (meeting by the playground). The event is for ages 12 years and under and parental supervision is necessary, pre-registration in Bru Youth Service is required.

As this is an outdoor event, it will be weather dependent and young people from the Bru have been involved in the event organisation and delivery.

Downpatrick Clean up Group

Dublin City Council Community & Social Development Team and the Public Domain Section continue to work with and support the development of the newly formed environmental group in the Downpatrick area.

Official Launch of Mural at The CCMA to celebrate the life of Phil Lynott

The official launch of a mural dedicated to the late Phil Lynott will be launched on Tuesday the 30th April 2019 at 11a.m, in CCMA, 11 Armagh Road, Crumlin, Dublin 12. Dublin City Council Community Development Team, Crumlin Area Office and South Central Area Public Domain Section, commissioned the mural, which is made with recycled materials.

Public Domain Report for Crumlin/Kimmage

South West Inner Area Report

The Door-to-Door Waste Enforcement Campaign in Rialto and Donore/Tenters area is so far yielding good results. Approximately 60% of residents have responded so far and are demonstrating compliance. Many households seem confused about what can be recycled. Contamination appears to be a citywide issue. On a positive note, the campaign has opened up a new opportunity for community engagement on sustainable living. Workshops on how to reduce waste and recycle more efficiently in partnership with community groups have been suggested and this is under consideration.

The annual Fatima/Herberton Environmental week, April 15th -19th, is underway with support from the Public Domain Section and Housing Department. A full programme of events including planting, clean-ups, and a sustainable living workshop facilitated by freelance Aoife Munn, Master Horticulturist, are planned.

Crumlin Area Report

Crumlin Park precinct improvements are at an early stage. The wall at the entrance has been repaired and repainted and the estate has been cleaned. Continuing community engagement is vital to decide on future improvements. Graffiti removal has been completed at Poddle Park, Suir Rd., Sundrive Rd., Bunting Park and Ravensdale

BALLYFERMOT/DRIMNAGH ELECTORAL AREA

Cherry Orchard

Landscaping works are continuing on the CHI site in Cherry Orchard. The contractors, MDY, are on site since Tuesday 12th February and their work is nearing completion. They expect to have the remaining thirty-six houses ready for occupation by end of April/early May. The issue relating to the street lighting and a connection by the ESB is still outstanding. The Project Manager informed DCC on 10th April that the ESB had visited the site but they left without providing power due to a technical issue relating to mini-pillar markings. The ESB are booked to return to the site on Tuesday 16th April to complete the connections. Interviews are ongoing with prospective applicants for the remaining 36 properties.

Elmdale

City Architects has informed me that, subject to delivery of parts this week, Phase 1 of the Elmdale development will be ready for letting by Monday 29th April. This phase comprises of 19 houses, 11 two-bed units and 8 three-bed units. All other phases will be handed over at intervals of two weeks until all units are ready for letting. All prospective tenants have viewed the units and, upon expressing their interest, letters of offers were issued. This letter helped applicants remain on a rolling tenancy with their respective landlord in cases where they are in private tenancies and facing eviction. If the applicant is not allowed remain in their private tenancy after the eviction date, they are offered alternative housing suitable to their needs in other areas of Ballyfermot. As with the previous Rapid build units in Cherry Orchard, we will set up interviews with MABS, Citizens Information, the Community Welfare Officer and on this occasion we are arranging for a restorative practice development worker to meet with prospective tenants before they sign for their tenancies. We have had expressions of interest from over 300 applicants in the units.

To compensate residents for the loss of their green space for the duration of the works, 120 family day passes along with individual adult and child passes to the Zoo have been purchased and will be distributed by staff in the Equine Centre to families in the Elmdale area. All windows of the existing residents' houses will be cleaned in the estate when all the construction work is completed.

Cornamona Court

Approval has been given by the DOELG to commence work on the Cornamona site. The contract was awarded on Friday 12th April and it is expected that work will commence on site in May 2019. Contact details for the contractor will be obtained as soon as possible and a working relationship will be established between the Ballyfermot Area office, the contractor and the residents to keep everyone informed of developments on site.

Environmental Work

The stone planter with the name of the estate engraved has been installed at the entrance to Barneville. Additional stone planters have been installed throughout the Ballyfermot area. Quotes have been accepted for the planting of additional trees throughout the Ballyfermot area also and work will commence shortly. Ten Cherry trees have been planted in California Hills

to enhance the Park and two gardens have been planted with spring bedding plants at the entrances. Outstanding works include the crowning of trees. Funding has been secured from the discretionary fund to upgrade two wheelchair accessible gates in the near future to prevent access to the Park by scramblers and horses. This work will be in consultation with the residents. The probation service has been carrying out regular clean ups of the area and Parks have changed the rota of the contractors regarding cutting of the grass.

The provision of skips throughout the area was very successful last year and it is intended to provide some skips in the Raheen/Clifden area in April. Residents will be notified when they are arriving.

Chapelizod

No further update in relation to the proposed housing development at Springvale. Contractors were on site at Liffey Vale to estimate what works are required to relocate the allotments there and a quote for the works is expected over the coming weeks.

Business Community

We are in the process of arranging a meeting with business owners to discuss the impact of the improvements to the streetscape and to work with them with new initiatives. We are hopeful that the row of shops adjacent to the Gala building will be painted soon as the weather improves. This work is being organised by the owners and it is hoped that this will encourage other shop owners to link with us regarding their own shop fronts. Funding has been made available for improvements to the shop fronts in Decies Road and quotes have been sought to carry out this work. It will include gutter cleaning and repair, painting of shop fronts, power-hosing pavements and replacing dead trees.

Drimnagh Task Force

The third meeting of the Drimnagh Task Force was held on 16th April. The following objectives were agreed: -

- To bring together voluntary and statutory services to work together to address negative issues affecting the community.
- To identify those young people / families most at risk of involvement in anti-social behaviour / criminal justice system and to assist in the development of appropriate targeted services or the enhancement of existing services to support those young people / families to make positive choices.
- To document the expected population changes that will occur in the future and what community / statutory infrastructure should be in place.

Drumfinn Park Project

The City Council has worked with participants from Ballyfermot Star on a weekly basis to carry out improvements to Drumfinn Park. This initiative was very successful and provided very positive engagement with the young people. The next stage of the project is to establish a friend's of the park group that will continue this good work.

Mercy Secondary School Transition Year Students Social Innovators Award


