# Q1 Councillor Ray McHugh

To ask the Area Manager to arrange for an inspection of the extension of *(details supplied)*. There is a constant leak in this extension that needs to be permanently fixed.

# Q2 <u>Councillor Ray McHugh</u>

To ask the Area Manager to arrange for a replacement door at *(details supplied)*. The door is in an unsafe condition.

To ask the Area Manager to arrange for an inspection of *(details supplied)*. The resident says she has problems with the windows.

## Q4 Councillor Ray McHugh

To ask the Area Manager to arrange for an inspection of the back garden at (*details supplied*). The resident informs me DCC left a clay pile in the garden that is causing damage to a fence and making the garden unmanageable.

## Q5 <u>Councillor Críona Ní Dhálaigh</u>

To ask the Area Manager why it is taking so long for the sink at (*details supplied*) to be replaced? The tenant has repeatedly reported it. It was broken by council workers when fixing the boiler. Can it please be replaced? Also, the front door is in very poor condition and needs to be replaced. Vents were recently put in the house to try and address the dampness but it is now freezing. Can something be done to address this?

To ask the Area Manager to arrange for an inspection of the front and back doors of *(details supplied)* and address the concerns of the resident.

To ask the Area Manager if the provision of a public bin outside (*details supplied*) can be arranged as soon as possible. I have had complaints from residents after the previous bin was removed without consultation.
