With reference to the proposed disposal of a plot of land to the rear of 10 Carleton Road, Clontarf, Dublin 3.

An application has been received from Cogan Daly & Co Solicitor on behalf of owners Robin Cahill and Janice Noonan to purchase a plot of ground to the rear of the property at No. 10 Carleton Road, Clontarf, Dublin 3. The plot of ground in question, which is shown outlined red on Map Index No. SM-2019-1141, has an area of approximately 86 square metres, and has been incorporated into the rear garden for many years.

It is proposed to dispose of the City Council's fee simple interest in this plot of ground to Robin Cahill and Janice Noonan subject to the following terms and conditions:


- 1. The Council shall transfer the site outlined in red on Map Index No. SM-2019-1141 in fee simple.
- 2. The consideration shall be in the sum of €2,150 (two thousand one hundred and fifty euro). i.e. €25 per square metre i.e. €25 x 86 square metres.
- 3. The purchaser shall be responsible for any costs involved in incorporating the plot into their garden.
- 4. The purchaser shall be responsible for their own legal costs in the matter and shall also pay approximately €1,500.00 (plus VAT) towards the Council's legal costs.

The agreement shall contain such other covenants and conditions as deemed appropriate by Dublin City Council's Law Agent.

No agreement enforceable at law is created or intended to be created until an exchange of contracts has taken place.
