With reference to the proposed disposal of a plot of land to the front of 212 Malahide Road, Clontarf, Dublin 3.

An application has been received from the estate of Joseph Knowles to purchase a plot of ground to the front of the property at No. 212 Malahide Road, Clontarf, Dublin 3. The plot of ground in question, which is shown outlined red on Map Index No. SM-2019-1219, has an area of approximately 81 square metres, and has been incorporated into the front garden for many years.

It is proposed to dispose of the City Council's fee simple interest in this plot of ground to the estate of Joseph Knowles subject to the following terms and conditions:

- 1. The Council shall transfer the site outlined in red on Map Index No. SM-2019-1219 in fee simple.
- 2. The consideration shall be in the sum of €2,025 (two thousand and twenty five euro). i.e. €25 per square metre i.e. €25 x 81 square metres.
- 3. The purchaser shall be responsible for any costs involved in incorporating the plot into their garden.
- 4. The purchaser shall be responsible for their own legal costs in the matter and shall also pay approximately €1,500.00 (plus VAT) towards the Council's legal costs.


The agreement shall contain such other covenants and conditions as deemed appropriate by Dublin City Council's Law Agent.
