

- Q.1 Councillor Noeleen Reilly**  
To ask the Manager for the locations where the new bins are going in Ballymun/Finglas.
- Q.2 Councillor Noeleen Reilly**  
To ask the Manager when the railings at the end of Cranogue Close will be erected. They were agreed by the housing office in 2018.
- Q.3 Councillor Noeleen Reilly**  
To ask the Manager to clear the bushes at Balbutcher Lane
- Q.4 Councillor Noeleen Reilly**  
To ask the Manager to look at the Junction of Ballymun Road, Glasnevin Avenue and Collins Avenue, the right hand traffic lane doesn't line up with its counterpart lane on the Ballymun Road heading towards Ballymun.
- Q.5 Councillor Noeleen Reilly**  
To ask the Manager to clear up Coultrey Park, there is ongoing problems with illegal dumping destroying the park. Can the camera investigate who is doing the dumping.
- Q.6 Councillor Noeleen Reilly**  
To ask the Manager to clear the verges and footpaths along the railings at Johnstown Park on Ballygall Road, It is very slippy and mucky.
- Q.7 Councillor Noeleen Reilly**  
To ask the Manager to repair the footpaths on Belclare Drive, they are in a very poor condition.
- Q.8 Councillor Noeleen Reilly**  
To ask the Manager to write a letter to residents in Cairn Court about throwing out food and illegally dumping on the grass beside the courts.
- Q.9 Councillor Noeleen Reilly**  
To ask the Manager to clear the paths around Tolka Estate, they are very mucky and slippy, and if the grass can be cut back.
- Q.10 Councillor Anthony Connaghan**  
To ask the Manager to provide an update on request to investigate new pedestrian traffic crossing at junction of Mellows Road and Kildonan Road.
- Q.11 Councillor Anthony Connaghan**  
To ask the Manager if O'Cualann Housing have been approached with a view to providing affordable homes on the Kildonan lands development. Can the Manager provide an update on the proposals for the site.
- Q.12 Councillor Anthony Connaghan**  
To ask the Manager if it is possible for the Finglas or Ballymun Swimming Pools to be utilised for kayak/ canoe clubs to train safely off river.

**Q.13 Councillor Anthony Connaghan**

To ask the Manager to arrange for the potholes on Ratoath Road at junction of Rathvilly Road to be repaired. There is at least one large and one small at the junction.

**Q.14 Councillor Anthony Connaghan**

To ask the Manager to arrange for the potholes on Wellmount Road adjacent to the FAST building to be repaired and for the road to be included on future works plans for re-instatement.

**Q.15 Councillor Anthony Connaghan**

To ask the Manager to arrange for an inspection of the junction of Ratoath Road and Scribblestown Lane where cars are frequently parking on the footpath making it dangerous for pedestrians. Can adequate pedestrian refuges be put in place and possibly bollards to prevent parking blocking the pedestrian route along the main road.

To ask the Manager to arrange for the back garden wall at (details supplied) to be reinstated to its original position. The previous tenant built a new wall cutting off part of the back garden presumably to create a space for parking at the back of the house. However, this space is being used by a neighbour's van and is dangerous as it blocks the back gate and in case of emergency they would not be able to get out the back gate. It also makes the back garden smaller with less room for the children to enjoy. See image attached

**Q.17 Councillor Anthony Connaghan**

To ask the Manager to arrange for an inspection of the mould and damp at (details supplied). Could the Manager also confirm if this house is due to have insulation works in the near future and if ventilation units are required. One of the children in the house has bad asthma and only one kidney, therefore it would be appreciated if any works required could be treated with urgency.

To ask the Manager to provide an update in relation to the new bath required at (details supplied) and could a timeframe be given for these works.

**Q.19 Councillor Anthony Connaghan**

To ask the Manager to arrange for planting of wild flowers on Ballygall Road East, particularly to brighten up the area at the layby. Could this area also be treated for weeds and an update be given in relation to the large containers (works related) that have been left there, will they be removed soon, or could they be painted if they are to remain. This area is starting to become a blackspot for rubbish.
