**Re: National Development Plan 2021-2030**

Dear Cllr. McGrattan

I wish to reply to your correspondence of 6<sup>th</sup> December in relation to the National Development Plan (NDP) 2021-2030. It is important to note that the Department of Public Expenditure and Reform sets the overall strategy and budget allocations for the NDP, and so it is a matter for individual Ministers and Departments to bring forward projects for approval and implementation.

It is possible to get a breakdown of all larger projects and programmes over €20 million through the Project Ireland 2040 tracker, where it is possible to separate by Department, County and Region, amongst other filters (link: <https://assets.gov.ie/200464/3cceb69e-3275-4031-8b0a-36a39d69004f.xlsm>).

Separately, for a more comprehensive list of projects, please see the interactive *myProjectIreland* map, which also includes projects under €20 million. It is possible to filter for counties and regions on the interactive map also through the dashboard function (link: <https://www.gov.ie/en/collection/f828b-myprojectireland-interactive-map/>).
