## Annual Report of the Joint Policing Committees 2021

---

Section 36 of the Garda Síochána Act 2005 provided for the establishment in 2006 of Joint Policing Committees (JPCs) in each Local Authority. In Dublin City, this consisted of both a Citywide Joint Policing Committee and five Area Subcommittees corresponding with the five operational areas of the City Council.

Guidelines for the operation of Joint Policing Committees were originally introduced by the Department of Justice in 2008 and revised in August 2014 to cover the period 2014 – 2019 (Council Report no. 288/2014 refers).

With effect from April 2016, responsibility for issuing guidelines in respect of Joint Policing Committees comes under the remit of the Policing Authority, which was established by the then-Minister for Justice and Equality in January 2016 to oversee the performance of An Garda Síochána in relation to policing services in Ireland. The Authority has not made any amendments to the existing guidelines to date, although their representatives continued to attend a number of JPC meetings during 2020.

The main purpose of these committees is to provide a forum whereby a Local Authority and Senior Garda personnel, with participation from Local Authority members, Oireachtas members and community/business interests, can discuss and make recommendations on matters affecting the policing of the area.

The Dublin City Joint Policing Committee 2019-2024 was originally chaired by Councillor Mary Fitzpatrick. However, following her election to the Seanad in 2020, Councillor Daithí De Róiste was re-elected unanimously as Chairperson in September 2020, with an agreement in place that the Chairmanship would be handed over to the Social Democrats Party for the second half of the current council term. Consequently, Councillor Tara Deacy was elected as Chair at the January 2022 meeting.

A Strategy Document was originally prepared for the Council term 2019-2024, with the objective of having each of the 6 Joint Policing Committees focus primarily on 3 key issues for the duration. Owing to the fact that the JPC structure is currently under review, and the recent establishment of a 2-year Pilot Community Safety Partnership in the North Inner City Electoral Area which, it is envisaged, will replace the Joint Policing Committee in that area going forward (Appendix 1 refers), it has been decided to retain these objectives for the foreseeable until such changes come into effect. These objections are listed as follows:

Three high priority issues for Dublin City six-year (2019-2024) Strategic Plan:

1. Community Safety / Confidence-building
2. Antisocial Behaviour – Housing Estates
3. Street Crime

The following action matters form the basis of the annual work plans for each of the six committees:

All Committees (Dublin City and the five Joint Policing Subcommittees) are to report under the above 3 headings in their Work Plans and Annual Reports going forward. However, these headings are not exclusive and Committees are also encouraged to report under any other headings deemed appropriate for their respective areas.

Meetings of the Dublin City Joint Policing Committee are held every two months and take place in the Council Chamber, City Hall, Cork Hill, Dublin 2. Owing to the Pandemic, these meetings all took place remotely during 2021 and it is anticipated that this will continue for the foreseeable, with the possible introduction of hybrid meetings in the future.

The Joint Policing Committee is required to submit a report to the City Council annually on the performance of its functions during the preceding year, which is set out hereunder.

**Continued to recognise and respond to the needs of victims of crime and to ensure protection of vulnerable persons and groups**

The Gardaí maintained a full service to victims of crime throughout the pandemic.

Welfare beats took place daily to engage with homeless, check their welfare and to inform them of homeless services.

Community Policing Gardaí continued to carry out multiple tasks for people who were cocooning. By the end of 2021, the number of people cocooning was very limited due to the elderly and vulnerable receiving their vaccine. The majority of elderly people were able to carry out their day-to-day activities without assistance.

Liaison with elderly groups continued in 2021.

Gardaí conducted Domestic Violence call-backs under **Operation Faoiseamh** to ensure the victims concerns were addressed. In person, call-backs to victims of domestic abuse and residential burglaries were conducted by Community Gardaí within 7 days of an incident throughout 2021.

In serious incidents Family Liaison Officer are appointed to liaise with families and keep them updated as to progress in a case.

The Divisional Garda Victims Service Office also liaised with victims of crime offering practical support and assistance.

**Support the Neighbourhood Watch Schemes**

### **Ballymun Safety Forum Meetings / Updates**

Due to the pandemic and public safety guidelines, no public forums/safer Ballymun meetings took place in 2021. Our Housing, Public Domain and Community Development teams continued to link in with residents and vulnerable citizens to ensure that we continue to offer on-going support to all and address concerns/issues as they arise. We explored the option of holding on-line public safety meetings but there was little or no desire from residents to attend such meetings to discuss safety or sensitive matters. Other agencies and stakeholder such as Ballymun Network for Children, Drugs Task Force, BRYR, and Young People at Risk agreed to attend however, Dublin City Council & An Garda Síochána already meet with these agencies on a regular basis on-line and we discuss issues raised. Both agencies met with stakeholders and residents on numerous occasions.

### **Ballymun Safety Fora Update 2021**

The Ballymun Safety Strategy 2021 - 2024 was approved and adopted by the North West Area Joint Policing Subcommittee in March 2021. A number of commitments were agreed between Dublin City Council, An Garda Síochána and the Ballymun Local Drugs Task Force. An Garda Síochána and Dublin City Council have meet monthly to addressed areas of concern and issues raised by residents and public reps. Short term actions have being agreed and implemented to address anti-social behaviour and drug dealing in specific locations. Dublin City Council have established a Youth Advocacy Group in



Ballymun it is the intention that these youths will engage with the Safer Ballymun Network and will be represented on the Safer Ballymun Steering Committee. We endeavour to bring their voice, ideas and potential solutions to issue raised to fruition.

Dublin City Council & the Ballymun Local Drugs Task Force secured funding to appoint an External Safety Coordinator to coordinate the delivery of the actions in the plan. We advertised the post in December 21, however none of the candidate that applied met the criteria outlined. We will re-advertise the post in 2022.

### **Finglas Safety Fora Update 2021**

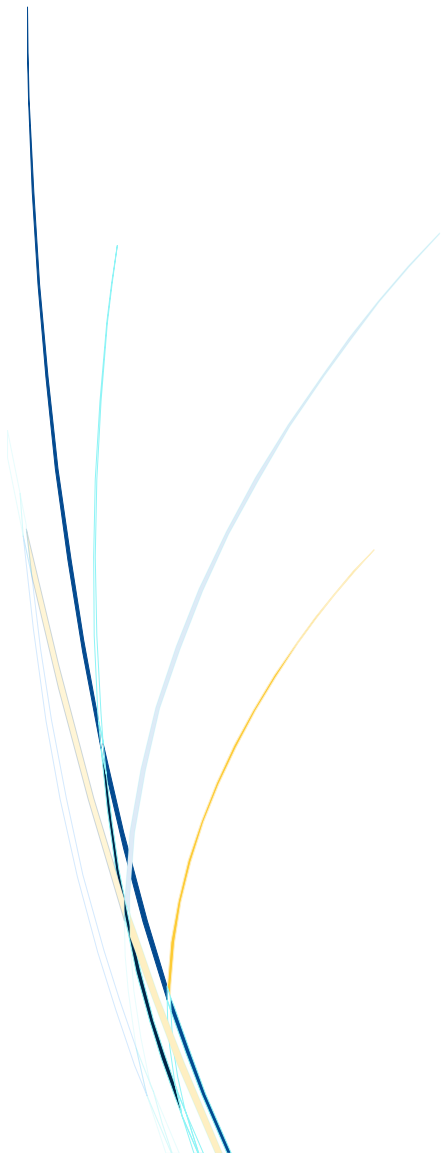

## Update on the Dublin North Inner City Local Community Safety Partnership



## Overview

The Dublin North Inner City Local Community Safety Partnership (LCSP) was established on a 24-month pilot basis to help promote community safety across the 10 neighbourhoods within Dublin's North Inner City.

The neighbourhood zones in Dublin's North Inner City are broken down as follows<sup>1</sup>:

- City Centre East
- City Centre North
- City Centre West
- Clonliffe/Ballybough
- East Wall/North Lotts
- Halston Street/Inns Quay
- Montpelier/Arbour Hill
- Sheriff Street/IFSC,
- Smithfield/Broadstone, and
- Dublin Port.

The independent Chairperson for North Dublin Inner City LCSP, Mr. Cormac Ó'Donnchú, was appointed in February 2021. In late April he was joined by the Local Community Safety Coordinator, Patrick Craig, followed by the Local Community Safety Administrator, Rachel Meade, in May.

In October 2021, Patrick Craig resigned from the position of Community Safety Coordination. The position was filled, without delay, by Sonya Keniry and with little impact on the Partnership.

The Partnership is still in its embryonic phase and is continuing to scale in activity. While the LCSP support and adhere to public health guidelines, the impact of the global pandemic has impeded the natural events generally associated with community engagement and board formation. In addition, a temporary cessation while there was a staff changeover and the Christmas break has also had an impact on the progress of setting up the service.

That said, many milestones have been achieved since the formation of the Partnership in July and the LCSP is in a strong position to continue with the work it has been tasked with.

## **Board Formation and Meetings**

The Partnership's Board of members is still in the process of establishing itself and has met on two occasions to date; once virtually on the on the 29th of July 2021, and the second in-person on the 28th of October 2021.

The next meeting is scheduled for the 17<sup>th</sup> of February and will be held in Ozanam House. The easing of Government restrictions will provide an opportunity for the Board members to meet in person and to start to build relationships and focus on issues of concern regarding community safety and begin the work of how best to tackle them.

There is provision for 30 places on the LCSP Board. Currently 24 positions have been filled drawing from a diverse cross section of the community, which includes representation from An Garda Síochána (AGS), publically elected representatives and the Local Authority. Some of the agencies invited to join the Board are strategic so as to allow for a broader response to community safety. These include a representation from Tusla, HSE and NEIC and 5 community members who reside across the North Inner City. There is also representation from the business community, youth groups and social projects.

There are 6 vacancies remaining on the board and they include a representation from the Local Drugs Task Force, a representation from the voluntary sector and one more resident from the north inner city (EAST).

The Board will be tasked primarily with writing a safety plan. To assist with this task the Board has been invited to visit Derry and see at first hand the gains that have been made by its equivalent Local Community Safety Partnership.

### **Information Sharing Event: Derry/Strabane Community Safety Partnership**

Plans are currently underway for Board members to visit Derry in late May of this year. The Dublin Inner City LCSP Coordinator has met with her counterpart on two separate occasions with the view to planning this visit and prioritising what would be of most benefit to the Board to see.

It is intended that the Coordinator and the Administrator of the LCSP will make a scouting visit in February and attend some of the community safety meetings virtually to assist complete the plan for the visit.

## **Community engagement to date and proposals for further community outreach**

**Neighbourhood meetings:** Between May and October of 2021 a number of local neighbourhood meetings were held. It should be noted that of the 10 neighbourhoods identified within the Dublin North Inner City Area, Halston Street/Inns Quay and Dublin Port were initially considered not to be viable for meetings due to lack of engagement. In October, Halston Street/Inns Quay and Smithfield/Broadstone were amalgamated, as Halston Street/Inns Quay was not viable for an individual meeting at this time. A meeting was held with Dublin Port representatives, as this is a self-contained business area with no residential population.

In total 16 community safety meetings were held across the 10 neighbourhoods with various levels of engagement. Issues raised at these meetings were varied and include, but were not limited to;

- On street drug taking and dealing,
- Street lighting,
- Anti-social behaviour, and
- Litter/street cleanliness.

Updates were given where relevant from An Garda Síochána. While the community safety meetings had some positive outcomes the attendance was poor on several occasions. As a result, a review of how these meetings are convened and managed is currently underway, and it is intended to resume engagement in a revised format in the near future.

**Bike marking scheme:** In addition to the community safety meetings other gains were made by the Partnership. These included a bike marking scheme piloted with the food delivery drivers. Following a tragic fatal incident in East Wall, in January 2021, one of the issues that came to light was that food delivery drivers are frequently the subject of bicycle theft. The property marking scheme was provided free of charge, and piloted in conjunction with An Garda Síochána and LCSP. It is intended to resume this pilot and build on its success.

**National Learning Network (NLN):** Links were also forged with NLN (REHAB Group) which is temporarily located in Cathal Brugha Street. Together the principal of the NLN and LCSP Coordinator established a working relationship to assist in building the confidence of the student body of NLN of their safety while studying in the Inner City. Links with the NLN will be resumed in the first quarter of this year. Additionally, work with the NLN will scale to include introductions to AGS Community Policing and Crime Prevention teams.

Street Safety/Lighting: Further gains were made in the City Centre where it had been reported that residents and visitors felt unsafe due to poor public lighting or lights being defective. This issue was particularly evident in the case in the older and female population. Most defective lights were repaired or replaced quickly. This was also the case when broken windows and fly tipping was reported to the relevant agencies. Issues were resolved quickly and without incident. These improvements to the local environment contribute substantially to improved sense of public safety.

Killarney Court: The LCSP was aware of persistent reports of ASB in Killarney Court. The LCSP, in association with AGS COMPOL, arranged for the Community Garda to have direct engagement with the residents; and high-visibility patrols. The security guard for the complex had also reached out to youth services in the area to help divert the youth actions to a more positive role. The youths have since desisted from entering the complex.

Dance school: A meeting took place between the LCSP Chair, a member of the Board, and the members of a local dance school. The youths noted a lack of lighting while leaving their class created a feeling of fear and insecurity. The LCSP contacted DCC and arranged for lighting to be installed. The youths have agreed to undertake a street clean, and have agreed to appoint a liaison to feedback to the Partnership.

### **Current undertakings of the LCSP**

Communications: Legacy Communications has been engaged to devise a specific advertisement campaign targeted at particular areas of concern for local residents and visitors to the North Inner City, starting with littering and dog fouling.

Submission to Oireachtas: The LCSP Chair was invited to tender a written submission to the Oireachtas, on the subject of anti-social behaviour. This submission was issued to the Oireachtas on 21 January 2022, and the Chair has requested feedback. We currently await a response.

CES evaluation: In 2021, community safety pilots were also established in Longford and Waterford. All three pilots are being monitored and evaluated by the Centre for Effective Services (CES), on behalf on University of Limerick. The Chair and Coordinator are tasked with making representations to the Board members to promote engagement with the evaluation process. While participation is voluntary, Board engagement is considered of value. The outcome of the evaluation and success of the pilots will form the basis of a national rollout of Community Safety Partnerships.

Relationship Building: The LCSP are continuing to forge relationship within partner organisations, agencies, pilot schemes etc.
