1 Minutes of the Meeting of 6th May 2022

2 Matters Arising:

There were no matters arising.

3 Updates from SPC Chairs:

a Finance - Cllr Seamas McGrattan

Deferred until next meeting.

b Housing - Cllr Dermot Lacey

The Housing SPC has had 3 meetings since the last CPG. They most recently met on 13th July and Cllr Lacey spoke of his concern regarding the growth in homeless figures. He also commended the work of the Animal Welfare Unit.

c Planning and Urban Form - Cllr Ray McAdam

Cllr McAdam noted that meetings had been deferred to the last quarter and confirmed 3 meeting will take place before the end of the year. Noted that there were discussions ongoing regarding O'Connell Street.

Cllr Lacey requested that the Manager would review and recommend a method to bring applications for Large Scale Residential Developments to the attention of local Councillors.

d Traffic and Transportation - Cllr Noeleen Reilly

The Lord Mayor welcomed Cllr. Noeleen Reilly as the new Chair of the Traffic and Transport SPC and wished her well in her new role. Cllr Reilly noted that at the last SPC there was a presentation on the Public Lighting Upgrade Project and updates from the 30 KPH Speed Limit and Zebra Crossing Working Groups.

e Arts, Culture, Leisure and Recreation - Cllr Cat O'Driscoll

Last meeting held in May – items discussed included Active Cities Project; Skatepark in Ballyfermot; A Collections Management Policy and a further update on the research study “Feeling more part of Dublin - Evidencing the

impact of participation in cultural projects led by Dublin City Council". The SPC are due to meet again later this month.

f **Economic Development and Enterprise - Cllr Claire O'Connor**

There has not been a meeting of this SPC since the last CPG meeting but Cllr O'Connor informed members that the work of the LECF advisory group was continuing. She wished the Lord Mayor well in her role as chair of the Corporate Policy Group.

g **Climate Change, Environment and Energy - Cllr Michael Pidgeon**
