In the period 1st July – 31st August 2022, incidents were reported via Litter Hotline/CRM for the Central Area.

In addition to the CRM incidents, the Public Domain crew carry out inspections of their assigned routes on a daily basis. Collecting any dumped bags/materials which is not reflected on the above figures.

The total tonnage of collected illegally dumped items by our 5 outdoor staff members was:

- **35.90 tonne in July, 28.18 tonne for August 2022. Total Tonnage for 2022: 276.93 tonne**

Overtime

Over time was carried out five times for a mixture of weed removal and standard waste removal during July and August with **4.92 tonne** being removed.

Community Clean up equipment was distributed to **25** Community Groups / individuals between 1st July – 31st August. Requests for the removal of bags from community clean ups were handled by Waste Management and Public Domain staff.

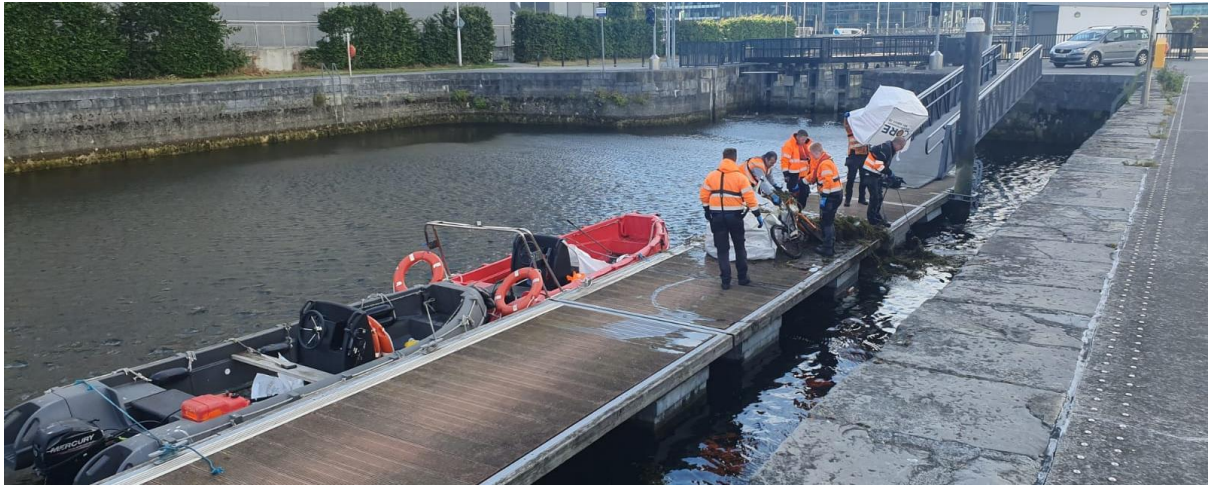
Mattress Amnesty

The Public Domain ran a successful Mattress Amnesty thanks to funding procured through an ADI grant. Mattresses were removed across the Central area during the week 15th – 19th August. Nearly 300 mattresses of various size was removed from preregistered addresses.

Canal Clean Up

A joint initiative between Irish Rail, Irish Water and the Public Domain culminated in a heavily littered area of the canal being cleaned on during the first week of August. A second clean-up has been scheduled at the same location with a possible third clean up being performed further down the canal in the near future.
