The Lord Mayor opened the meeting and outlined the purpose of the Special Council Meeting. She advised that it is to consider the Chief Executive's Report 119/2022 and addenda on Submissions and the Chief Executive's Report 120/2022 on Motions with a view to Members reaching agreement by resolution on amendments to the Draft Plan and on placing any material amendments on public display or if there are no material amendments then to make the Dublin City Development Plan 2022 to 2028. She further advised that if there are material amendments any person, including Councillors, will be entitled to make a

submission on the material amendments during the public display period which will be from 27th July to 1st September 2022 inclusive.

Councillors were reminded of their obligations under the code of conduct. Members were requested to indicate to the meeting administrator or to the Lord Mayor if there is any motion on the agenda to which they or a connected person has a conflict of interest. Where a Councillor has a conflict of interest they are required to declare the conflict and leave the chamber or be moved to the Zoom Lobby until the item is dealt with. Councillors were also advised that if they have a conflict of interest but will not be at the meeting when that item is taken that there is still is an obligation to inform the Lord Mayor or meeting administrator of the conflict so that it can be recorded.

The meeting was reminded for the record that Councillor Danny Byrne notified the meeting administrator in writing in June of 2021 that he was recusing himself from the Development Plan process due to his occupation.

In order to ensure the smooth running of business it was agreed that Report No 119/2022 including addenda on Submissions be taken as read, considered and agreed other than where Members have submitted a Motion in this regard. It was agreed to work through the Chief Executive's Report on Motions, Report No 120/2022 using the matrix of motions to proceed chapter by chapter through the 5 categories of Chief Executive Recommendations. The Chief Executive's Recommendation would be put first with Councillors speaking only if they disagree with the Chief Executive's recommendation. If not accepted the original Motion would be put and considered proposed by the Councillor concerned and seconded by the Lord Mayor. Where the motion is from a Party/Group it will be considered proposed by the respective Group Leader and seconded by the Lord Mayor. Where motions are similar and have the same CE Recommendation these will be taken together and determined once ie when first reached so for example from Chapter 1, Motion No.s. 1.4 to 1.11 and Motion No.s. 5.17 to 5.20 from Chapter 5 will be taken together when Motion No. 1.4 is reached and so will not be revisited when Chapter 5 is reached. (Similar Motion No.s are identified in the Matrix).

**Taking of Motions:** Proceeding through each chapter Motions will be taken in the order of the 5 categories of the matrix except for Chapter 5 and 13 where the categories will still be followed but section by section as this will enable similar topics to be dealt with together.

The Lord Mayor will ask if there are any objections to the CE Recommendation. If there are none, the CE Recommendation will be accepted and minutes will state: Motion Agreed, Motion Agreed as Amended, Motion not Agreed but where the matrix states 'Motion not Agreed Already Addressed' because the Councillor has accepted it is already in the draft plan/report, it will be minuted as Motion Agreed. Where the CE Recommendation is Motion not Agreed Outside Scope the Lord Mayor will determine if the motion is out of order. The minutes will state Lord Mayor ruled the following motions out of order and then they will be listed.

If there are objections to the CE Recommendation the proposer of the Motion will have 60 seconds to speak and any other Councillors wishing to speak will have 30 seconds. The CE or City Planning Officer may respond. If an amendment to the CE Recommendation is possible, the Lord Mayor will ask the proposer of the motion if they agree with the amendment. If they do and if there are no objections, the Amended CE Recommendation will result in 'Motion Agreed as Amended'. If the proposer does not agree or if there are objections, the 'Amended CE Recommendation' will be put to a vote. If the vote is carried, the Amended CE Recommendation will result in 'Motion Agreed as Amended'. If not accepted, the original Motion will be put to a vote which will result in either 'Motion Agreed' or 'Motion Falls'.

## Minutes Draft Development Plan Meeting 5th – 7th July 2022

The City Planning Officer advised Councillors that we are entering the last phase of preparation of the new City Development Plan. The draft plan is the most comprehensive plan ever produced incorporating over a 1000 strategic directions from Councillors, over 4000 submissions and over 500 motions following the public display of the draft Plan which ended on the 14<sup>th</sup> February 2022. The City Development Plan is a spatial plan for the sustainable, co-ordinated growth of our capital city. According to the latest census the population is now at almost 590,000 which is 6% increase on 2016 and is projected to grow to 630,000 by the end of the decade. The draft Plan provides for 40,000 plus new homes with the associated social and physical infrastructure. An environmental assessment has taken place on every policy and objective in the draft Plan. In addition all motions as originally submitted and the CE Report have been screened under environmental legislation. Any changes that are made at this special council meeting will also be subject to environmental screening.

The City Planning Officer clarified that:

Motion Agreed (103) means the Motion is agreed as submitted.

<u>Motion Agreed as Amended</u> (122) means the substance of the Motion is accepted but some amendment is proposed to ensure consistency with the Development Plan and language in Development Plan.

<u>Motion not Agreed Already Addressed</u> (68) means that the substance and spirit of the Motion is already included in the Draft Plan and/or CE Report on Submissions. This is not as harsh as it seems and is there to avoid duplication and ensure the Plan is not too long.

<u>Motion not Agreed (147)</u> is for planning reasons which are outlined in the CE Report. *If the proposer agrees with the CE response the motion will not be put and will be considered withdrawn.* 

<u>Motion not Agreed Outside Scope</u> (76) is for one or more of the following reasons: It is not in compliance with national policy, for example, would contravene or not be consistent with the National Planning Framework or other Section 28 guidelines.

It relates to other legislative provisions, for example, the Building Regulations.

It would be contrary to the provisions of the Planning and Development Act 2000 (as amended).

It relates to the functions/operations of other organisations and/or of the Council, for example, Waste Management.

The City Planning Officer then advised that the material amendments to the draft Plan agreed at this Special City Council meeting will be placed on public display from the 27<sup>th</sup> July to the 1<sup>st</sup> September during which period anyone can make a submission. Not later than 8 weeks after the publication of the material alteration notice, the Chief Executive will make a report to members on the submissions/observations received and that it is envisaged that the Special Council meeting to make the new plan will take place towards the end of October with the new plan coming into effect 6 weeks later.

The meeting progressed over three nights. Councillor Darragh Moriarty recused himself when Motion V3.43 was reached and rejoined when it had been dealt with. Councillor Naoise O'Muiri recused himself when Motions V3.54 and V3.55 were reached and rejoined when they had been dealt with. Cllr Joe Costello and Cllr Nial Ring indicated they would recuse themselves for V3.65 however CE Recommendation was accepted without debate.

Report No 119/2022 including addenda on submissions was noted. Finally after all items had been dealt with it was proposed by the Lord Mayor and seconded by the Deputy Lord Mayor that:

"Having considered the Draft Development Plan 2022-2028 and the report of the Chief Executive in accordance with section 12(5)(a) of the Planning & Development Act 2000 (as amended), this Council hereby resolves in accordance with Section 12(6) of the Planning and Development Act 2000 (as amended), to AMEND the Draft Development Plan 2022-2028 as agreed at the Special Meeting of the City Council held on 5th, 6th and 7th July 2022 be placed on public display in accordance with the provisions of the Planning and Development Act 2000 as amended."

A full list of all decisions on the motions is detailed in Appendix A attached and details of recorded votes are in Appendix B. The meeting concluded on 7th July 2022 when all the business on the Agenda was completed.
