Current Projects in the area

Belcamp B

Contractor expected on site Q4 2022.

Glin Court

- The redevelopment of Glin Court has received Stage 3 approval.
- Presently, a review is commencing on the tender documentation before the issuing of the tender for the appointment of a contractor to construct the new housing scheme.
- The project is for the full demolition of the existing two housing blocks and the construction of 32 new homes for Older Persons.
- It is expected that we will start on site Q4 2022.

Cromcastle Underpass site

Feasibility stage, Design team appointment.

Cromcastle Court / Woodville

- The regeneration of the first phase of Cromcastle Court and the Coal Yard site has Stage 1 approval. The proposal is for the demolition of three of the existing housing blocks on the Cromcastle Court site and for the construction of a new housing scheme in its place and the redevelopment of the Coal yard site providing 39 new homes.
- A design team has been progressing with design proposals and are currently working towards the pre-Part 8 process.
- Further consultation with residents and the local community is planned to take place over the coming months.
- Upon receipt of Stage 2 approval from the D.H.L.G.H., it is intended to lodge the Part 8 planning permission in Q3 2022.

Oscar Traynor

Dublin City Council and developer Glenveagh are at the end stages of the development agreement negotiations. Currently there are environmental studies and site investigations on site in preparation for planning application in Q4 2022.
