Operation Thor continues to be in operation in this Division. All burglaries reported are subject to Technical Examination. Crime Prevention advice is given to victims. The Burglary Response Unit continues to tackle offenders. It is hoped that this Unit will be replenished with new members before the end of the year (replacing members lost to promotions and transfers). Community Policing members continue to deliver safety information to residents & stakeholders within their individual CPA's.

There is continued liaison with UCD, RDSI, TCD campus, Union reps, staff and residents on a regular basis. On the 15 th of November, an AGM of the Donnybrook District Neighbourhood Watch / Residents Associations was held at the Aviva Stadium. A number of speakers gave talks on the night in relation to Crime Prevention, Cyber Security and Domestic Violence. There are regular meetings held with each neighbourhood watch committee attended by the Community Policing Sergeants or Gardaí. In addition, there is a designated liaison Community Garda for each sector in the sub-district and they provide assistance with crime prevention advice as well as local initiative's run by various groups. This is regularly monitored and overseen by the Community Support Office.

Crime prevention and advice posters / leaflets / brochures etc. are distributed among the scheme members by way of direct contact / e-mails etc. and people are encouraged to visit the Garda website to avail of more information. Community Gardaí set up information stands at various locations in the district and also attend local activities / meetings where material can be distributed and discussed in detail. The Divisional Crime Prevention Officer is utilised to visit businesses and individuals and to provide detailed security and safety advice that will be of benefit to a business / individual. Terenure Community Gardaí have established a new Neighbourhood Watch scheme in an area of Rathgar and continually promote the benefits of Neighbourhood watch at local meetings etc.

An Garda Síochana	On going	Gardaí continue to conduct Domestic Violence call backs under Operation Faoiseamh and ensure that any concerns from victims are being addressed. In person call-backs to victims of domestic abuse and residential burglaries are been conducted by Gardaí, within 7 days of an incident occurring. Local Community Gardaí regularly perform welfare checks on elderly and vulnerable people in the community and have built up a register of older and vulnerable persons that are visited and reassured. Community Gardaí are continually reminding elderly and vulnerable people about "bogus tradespeople and cold callers" to the door and alerting people to email scams and text messages attempting to gain access to their bank accounts etc. In serious incidents, Family Liaison Officers are appointed to keep in contact with families and regularly update them as to progress in their case. The Divisional Garda Victim Service Office also liaise with victims of crime offering practical support and assistance. Investigating Gardaí also offer support and advice in 'Callbacks'

Community Policing members continue to promote bike safety with people they meet cycling within their communities. Community Gardaí deliver the Garda schools programme to all schools in the area and School talks have continued throughout Q4 and have incorporated road and bike safety advice. Gardaí distribute reflective yellow/orange bibs at schools and information stands and Garda public offices. Community Gardaí and Roads Policing Unit recently performed a checkpoint on Lower Rathmines Rd and distributed over 200 jackets to cyclists. Fixed Charge Notices are issued to deal with errant cyclists and locations where cyclists are a source of complaint are actively patrolled with a view to eradicating bad behaviour and educating cyclists as to the rules of the road.

Continued liaison with the licensed trade and those involved in the management of the night time economy	An Garda Síochána	On going	There is regular engagement with all local businesses and licensees across the South East Area, to ensure compliance with the Intoxicating liquor Act and also that the potential fines are outlined for those selling alcohol to underage and/or drunk individuals. Premises licensed to sell alcohol are inspected on a regular basis to ensure compliance with Licensing laws. Owners / managers / staff are reminded to be vigilant in relation to the underage Policy and encouraged to report any instances or suspicions of persons buying alcohol on behalf of minors. Test purchasing operations are carried out in the Division periodically, to ensure all Licence Holders are not selling alcohol to minors. All applications for a licence to sell alcohol are strictly vetted by a Garda Sergeant in advance of any Court application and premises are visited to ensure that the premises is fit to receive a licence. Operation Irene is enforced in all public parks / green areas / open spaces and these are regularly subject to high visibility policing. Both the Public Order Act and Intoxicating Liquor Act are utilised where breaches occur.

Reduce property crimes such as burglaries, thefts and robberies	Crime "hotspots" targeted	An Garda Síochána	On going	The Divisional Burglary Response Unit carry out targeted patrols across the SE Area. The Crime Prevention Officer has conducted a number of security surveys & assessments to reduce the incidents of property crimes in the CE Area. Prolific offenders are targeted and objections to bail are made in the District Court. Bail is revoked before the District Court where breaches of bail are detected. There is ongoing engagement with key stakeholders in the Division, in a joint approach to a successful reduction in anti-social & criminal behavior. Operation THOR targets and disrupt criminals engaging in burglary/robbery/other serious crimes. "Days of Action" are implemented to target known offenders/wanted criminals. Searches are conducted for stolen property and Court warrants are executed.

Reduce property crimes such as burglaries, thefts and robberies	Crime "hotspots" targeted	An Garda Síochána	On going	High Visibility checkpoints are set up in areas of recent crime and to disrupt mobile criminals. Uniform Gardaí both on foot and on Mountain Bikes concentrate on specific areas and Divisional resources such as the Burglary Response Unit are utilized to perform extensive patrolling of areas and housing estates. Crime trends are analyzed to identify hotspots and Garda resources are utilized to provide early intervention to combat such crime. Information is provided to Neighbourhood Watch groups and Residents' Associations so that they are more aware of suspicious activity and are encouraged to contact Gardaí immediately if in doubt.

Dublin City Council & An Garda Síochána	On going	Public disorder hotspots are continually monitored and targeted by a range of Garda Units, including Community Policing, Operation Citizen, the Public Order Unit and the Burglary Response Unit. Operation IRENE continues to be enforced by Gardaí and mountain bike & foot patrols take place to include back lanes and waste areas to deal with any drinking or loitering etc. The Public Order Act is enforced to direct persons away from an area and breaches are dealt with by way of Cautions (Adult / JLO) or court appearances.
Continuing to target the organised crime groups harming communities through violence and the sale and supply of drugs	Quarterly reporting on our success in targeting organised crime groups, emerging threats and challenges	An Garda Síochána	On going	Community Police (Operation Citizen) and the Divisional Drugs Unit continue to carry out on-street searches of individuals known to be involved in the drugs trade, to obtain search warrants and search premises where drug use is known to be carried on and to identify persons involved with criminal gangs and who their cohorts are. They target sale & supply in the Pearse Street CE Area, specifically within the environs of Pearse House & Mercer House. Challenges include the increase of incidents between rival groups in the Pearse Street area V the Store Street Area. A comprehensive Policing Plan for the Creighton Street and City Quay area is in force to deal with this specifically.

There have been 23 detections for the Sale & Supply of Dugs for the South East Area for Q4 to date (1st of October, 2022 – 27th of November, 2022). This is a 12% decrease in detections on the same time period in 2021 when there were 26 detections.

Promote the pilot pedal cycle registration scheme which is in operation in the E & D districts in an effort to thwart stolen bikes being circulated and to facilitate the return of "found" bikes to owners by the Gardaí.	An Garda Síochána	On going	Staff at PEMS (Property) offices continue efforts to return all seized & recovered bikes to their rightful owners through the use of the Pulse database. Pictures of stolen & found bikes are also put on the Garda Síochána Facebook page to gather information and return the bicycle to its rightful owner, where no personal engraving is found. 2 members are trained to carry out Bike Marking and it is hoped that Bike engraving days will be held in both CE Areas before Christmas. On the 12 th November, in conjunction with UCD a ' Light Up Campaign ' was run. Members of the Students Safety Group and Gardaí set up a bicycle checkpoint on the grounds of UCD. Cyclists going through the checkpoint were given bike safety and security advice. Over 200 sets of lights were also handed out to cyclists. Community Gardaí utilize the ' Garda Blue Bike ' scheme in schools to educate students about good locking mechanisms and identifiable markings which aid the return of property to rightful owners. All are advised to take a picture of their bicycle with identifying marks clearly visible and record details on property marking cards provided. This is also deployed in shopping areas where there is a high footfall to remind people of the need for good security for their bikes.

Dublin City Council & An Garda Síochána	On going	No formal complaints to the DMRS this quarter. Community Gardaí promote the "Think don't Tag" initiative by D.C.C. in local schools. Gardaí on patrol are directed to remain alert to this type of crime and report immediately any incident of spray painting so that arrangements can be made for the speedy removal of same. All incidents of graffiti reported to the South East area office continue to be investigated. There have been over 15 incidents of Graffiti reported to the South East area via the Citizen Portal. Nearly 780 sq. m of graffiti, most of which is spotted by Public Domain staff when out and about in the area, has been referred to the approved contractor for removal throughout the South East area since 1st October. Graffiti is also removed by individual traders and residents, Traders groups, Community & Resident groups, DCC Waste Management and other DCC Department crews.

An Garda Síochána	On going	Gardaí on patrol are regularly briefed and reminded of the issues created by people engaged in aggressive street begging at or close to commercial/ financial / retail interests. Gardaí engage with beggars and discourage their activity and utilise the Public Order Act where required and those who fail to comply with directions issued are arrested and dealt with in the appropriate manner. Community Police(Operation Citizen) attached to Pearse Street continue to concentrate on the problem areas, namely George's Street, Lower Baggot Street, Main Street Ranelagh, Sandymount Village, Grafton St, etc. In Q4, Camden Street has been noted as having an increase in the reports of aggressive begging taking place. Operation Citizen & the CRT (Kevin Street) have initiated a joint operation to rectify this issue. Enforcement of legislation continues, with prosecutions through the District Court. In the South East Area, there were 26 detections under the Begging legislation to date (1st of October, 2022 – 27th of November, 2022), an 86% increase in detections on the same time period in 2021 (14 detections)

All Community Gardaí and core unit members regularly patrol the parks in the area, which include, St. Stephens Green, Merrion Square & Ringsend Park, to capture breeches of Liquor Licensing Laws, DCC By Laws and/or anti-social behaviour. D.C.C / Park rangers report to Gardaí anti-social behaviour in parks / green areas and open spaces. Mountain Bike Gardaí are deployed to the parks under Operation IRENE and pay particular attention to wooded areas. Any offenders are dealt with by way of JLO / Adult Caution or otherwise. Community Gardaí met with representatives on D.C.C. in relation to cycle lanes in Bushy Park recently as a result of a local complaint.

Gardaí on occasion supply medals and plaques for activities in schools and clubs and make presentations. Youth At Risk age 10-21 years Youth at risk programmes aim to provide viable outlets for young people to take part in and enjoy sport and physical activity on an ongoing basis thereby mitigating anti-social activity and behaviour. Programmes are delivered in partnership with various partners including local Youth Services and An Garda Síochána. Youth At Risk Highlights in the SE area: The FAI Friday Night League is just one example of how DCC/DCSWP supports young people in the SE area. The Leagues continued over the last period in Irishtown stadium delivered by DCSWP's FAI Cofunded Football Development Officers and a network of volunteers. The initiative plays a critical role in DCSWP Youth at Risk programme in the SE area at it engages young people during anti-social hours and helps forge positive relationships with An Garda Síochána. The 2022 league recently concluded in the stadium with the presentation of trophies and medals to participants.

DCSWP continues to work closely with our colleagues in the Sports Admin Section, colleagues in DCC Sports & Fitness Centres and Parks & Landscape Department to maximise use of our outdoor spaces for young people. DCSWP's new strategy will align with the City Development Plan & National Sports Policy; The final draft will feature two separate but interrelated documents: > Sports Infrastructure Strategy > Sports Provision & Programming Strategy (including review of DCSWP).
