**Crime Prevention  
Matters and Other  
Information**

There has been a significant increase in the allocation of Gardaí dedicated to the Cabra Area. Every regular policing unit has seen an increase in numbers, which has led to an increase in dedicated, proactive patrols and improved response times.

A new Crime Prevention Officer has been appointed.

A meeting is scheduled to take place with the Public Transport Operators in order to engage with Anti-Social Behaviour and Crime occurring on Public Transport Routes.
