The licence fee is  $\in$  35,000 (thirty five thousand euro) per annum, abated to  $\in$  1,000 (one thousand euro) per annum, provided that the property is used for sporting and community purposes only.

Accordingly, it is proposed to vary Report No. 55/2023 insofar as to clarify the licence fee at  $\in$  35,000 per annum, abated to  $\in$  1,000 per annum, provided that the property is used for sporting and community purposes only.

No agreement enforceable at law is created or intended to be created until an exchange of contracts has taken place.
