Unfortunately, owing to these budget restrictions TAG were unable to facilitate a pedestrian crossing at Foxfield Green. Two worded SLOW road markings and two Children Crossing signs have been provided recently on Foxfield Green to remind drivers of the playground ahead and to expect playing children nearby. On-street parking reduces speeds and improves driver caution acting as a form of traffic calming. Implementation or extending of parking restrictions at the above location would not only remove a parking amenity but also contribute to an increase in speed on the road in accordance with Design Manual for Urban Roads and Streets guidelines. The combination of these measures offer a reduced carriageway width for motorists and increases driver caution. Riverside Park is currently traffic calmed with six speed ramps placed at the appropriate distances apart for optimum traffic calming and has 30km/h Slow Zone signage, indicating the lower speed limit and that the area is a Home Zone or Slow Zone. This warns motorists that it is a residential area and to expect children, and it is clearly marked at the entrances from Greencastle Road and Clonshaugh Road. A sign Children Crossing is also installed on Riverside Park from Clonshaugh Road and one near junction with Glin Drive plus a worded "SLOW" road marking on the both sides of the carriageway, as well consider as a traffic calming. There is a 3.5 tonne limit sign at the junction of Greencastle Road and at the junction with Clonshaugh Road. For these reasons, the provision of extra traffic calming measures is not recommended at this time. Not Recommended	TAG reported that Grange Road is a Regional link road and main traffic artery with significant traffic volumes and therefore has a standard speed limit of 60km/h. It facilitates bus services and is an emergency route with very heavy traffic flow. Introduction of physical traffic calming measures would not be appropriate and is not recommended. Enforcement of the speed limit is a matter for An Garda Síochána. A 3.5 tonne limit would not be suitable for Grange Road as, again, it is a primary arterial route for the transportation of goods to and from the Baldoyle Industrial Estate. The implementation of a 3.5 tonne limit on Grange Road would only serve to displace this traffic onto other, more circuitous routes and as such is not recommended.
