Update on St. Anne's Redevelopment

On the 17th May we arranged a site visit to Cornamona Court in Kimmage, a new Dublin City Council senior Citizen Complex to give the residents of St Anne's Court an idea of the type of development that is proposed for St Anne's court.

We received excellent feedback from the tenants who all agreed it would be wonderful to move in to a modern one bed apartment built to these very high standards.

We followed this up by arranging for the drawings of the proposed new development to be erected in St Anne's Court community room from Tuesday 6th of June to Friday 16th June to allow residents to review at the leisure.

Staff from Clontarf & Donaghmede LEA's Housing team have been visiting the residents of St Anne's Court, keeping them updated on a regular basis, and addressing any issues the resident may have.

I will of course keep you updated on dates and times of the next Information sessions, once the plans have progressed and we have more information to share.
