TAU staff are currently on site completing a housing needs assessment with each family. Design plans will then be drafted based on the findings of the needs assessment.</li> <li>Cara Park 9 House build – Final design has been agreed. Design will be presented to Travact and the community in the coming weeks.</li> <li>Reuben Street 1 House build – Dept has approved the funding for this project. Due to go out Tender in Q3.</li> <li>Dept have approved funding from their Dormant Fund Accounts – monies will be split between St Dominics Park, Labre Park and St Margaret's Park and used to provide play and community facilities on site.</li> <li>Belcamp Lane – Consultation has taken place with occupants of Northern Close, Tara Lawns and St Dominic's Park regarding future Part 8 proposal and removal of waste along Belcamp Lane.</li> <li>Request – For St Joseph's Park to be looked at in terms of a full redevelopment of the site. Conditions on site are quite poor and need to be addressed as soon as possible. Response – Tony – Fingal County Council have redevelopment plans</li> </ul>

		Query – Any update from the Dept in relation to the Caravan Loan Scheme for 2023?  Response – Last year's scheme is currently under review with the Dept. They have not yet given the go-ahead to extend it to 2023. TAU have a waiting list if it is implemented again. There may be a stricter criteria introduced which people will have to adhere to if they want to avail of the loan.
		TAU has issued letters to Members regarding attendance. Still awaiting some responses.
