Environment and Transportation Department

Parking Tag and alternative methods of paying for parking

Since the beginning of the Covid-19 situation, the numbers using the Parking Tag had dropped very significantly in line with the reduction of parking meter usage. The weekly revenue on average of €400,000 had reduced to €25,000 for Pay and Display parking in March and April 2020. However, the numbers using the Parking Tag have increased and by week ending 11th June 2023, that week's revenue was €306,308.87. For week ending 11th June 2023, the usage of coin in parking meters was €85,866.80 and for week ending 11th June 2023 card payments were €120, 538.

Permit Parking, Pay & Display

The Pay and Display and Permit Parking Scheme on Belgrave Avenue, Dublin 6 will commence on 3rd of July. The hours of operation are Monday to Friday 8am to 6pm.

Decarbonising Zones

In response to the All of Government Climate Action Plan 2019 Action No.165 and the recent circular issued by DHLGH in February 2023 on Decarbonising Zones, the Council has identified potential Decarbonising Zones (DZs) in Ballymun and Ringsend. The Council are being assisted by Codema and the Dublin CARO, who are providing the evidence base of local level emissions, energy use and low-carbon resources, overlaid with other location based data which will help in decision making such as locations of housing retrofit programmes, sustainable energy communities, public buildings etc. The four Dublin Local Authorities are developing a regional based approach to defining DZs. A scoping out of work in line with the guidance provided in Annex D of the Local Authority Climate Action Plan Guidelines is currently being prepared.

Road Maintenance Services

Road Maintenance Services' Annual Works Programme for 2023 has been presented to the Elected Members. The programme will deliver approximately 18km of footpath upgrade works and 16km of carriageway resurfacing works this year. The tender and contract documents for the appointment of contractors to deliver these works are currently being prepared. During the period January to April 2023 the Division repaired/ made safe approximately 1,600 defects and hazards on the road network. Furthermore during the same period 142 critical defects and hazards on the road network were repaired/ made safe within 24-hours of them being reported.

Waste Services Update

Street Grading

234 surveys were undertaken on 216 streets across the six waste management areas in April 2023. Grading was mainly carried out between 9am and 1pm Monday to Friday. Overall 58% of streets graded received a Grade A, 29% Grade B, 13% Grade C, 0% Grade D.

Recycling Services

Parks & Landscaping Services have engaged a service provider to refurbish Eamon Ceannt Park Dept., including works to the bring centre. Works are scheduled to begin on 31st July and will take approximately 12 months to complete. The bring centre will close for the duration of the works. Glass and textile banks will be placed on the footpath outside the existing site for the duration of the works.

Clothing Waste Prevention Pilot

Waste Management Services have created a new textile waste project that aims to prevent good clothing from becoming waste and support the transition to a circular economy. A new guide on 'How to Organise a Clothes Swap' was written to assist anyone who wishes to plan their own clothes swapping event. Community groups are also invited to borrow a 'Clothes Swap Kit' containing the equipment, such as rails, signage boards and hangers, they may need to hold this type of event. School Programmes

Picker Pals is an anti-litter educational programme for primary schools. The programme gives young people the tools and positive motivation to develop stewardship of their local environment. Bulky Household Waste Collection Service

Dublin City Councils online bulky waste ordering system is now fully digital and customers can now request and pay for a service collection 24/7 as the entire process is fully automated through the Citizen Hub Platform. Customers can now complete the ordering process from beginning to end including making secure payment without the need to go through our customer services department.

There is no material change to the actual service itself, how it operates or cost. IPB Pride of Place Awards 2023 – Arrangements are being made to select groups for nomination to this year's competition.

Dublin Waste to Energy Community Gain Fund

The 2023 Dublin Waste to Energy Community Gain Projects Grant Scheme was open for applications from the 7th April 2023 to the 19th May 2023 inclusive. The amount of grant funding available for disbursement is based on an annual contribution by Dublin Waste to Energy Limited which itself is determined by the amount of waste accepted for thermal treatment at the facility. On this occasion, a total amount of €1million is available for disbursement to eligible projects within the Irishtown, Ringsend and Sandymount catchment area.

Applications were invited to submit proposals to the Scheme for assessment by the Dublin Waste to Energy Community Gain Fund Committee. This year, 47 grant applications were submitted requesting grant funding of circa €4.2m.

The 47 grant applications are divided into three categories as follows:

- Grant Applicants Requesting Amounts Over €100K (12 Applicants)
- Grant Applicants Requesting Amounts Between €20K and €100K (20 Applicants)
- Grant Applicants Requesting Amounts Under €20K (15 Applicants)

The Dublin Waste to Energy Community Gain Fund Committee will hold several grant application assessment meetings throughout July 2023 where each application will be carefully considered, discussed and reviewed against the Schemes general conditions and criteria, ensuring that only those selected will provide maximum community benefit and are viable and sustainable in the long-term. Following this lengthy and detailed process each applicant will be notified by way of letter of the outcome of their grant application. These grant application notification letters will be e-mailed to each grant applicant in August 2023.

Regarding the Dublin Waste to Energy Community Gain Projects Grant Scheme 2021, 21 of the 28 approved applicants have drawn down their grant funding to a total value of circa €326K. The total funding awarded was circa €500K, and therefore the balance remaining for drawdown is €174K. Due to unforeseen circumstances, two organisations have decided to withdraw their grant aided projects. The remaining 5 beneficiaries have until the 30th of June 2023 to complete their projects and draw down their funding. Worth noting is that grant funding not availed of in respect of any Projects Grant Scheme is carried forward and used to fund future Schemes.

Dublin District Heating Project

The Dublin District Heating Project (DDHP) is an important project which will contribute to the reduction of carbon emissions in Dublin City and ultimately to Ireland's Climate and Energy targets by delivering on Government policy at a European, National and local level.

A new unit has recently been established to provide additional resources to deliver this project for Dublin City Council (DCC) which, in Phase 1 aims to capture waste heat from the Dublin Waste to Energy ("DWtE") and pipe it into homes and businesses in the Poolbeg, Ringsend and Docklands areas of Dublin city. Heat will be generated from the conversion of non-recyclable waste at the Dublin DWtE facility which has the potential to generate up to 90MW of heat.

To meet its objectives, DCC is seeking an experienced private partner with the relevant DH expertise, knowledge and capability to participate in a joint venture company (JV) which will develop, implement, operate and retail the DDHP. DCC recently commenced a 2nd Round of a market engagement on a commercial structure for the DH utility. It is also intended to commence a prequalification procedure this year for a suitable JV partner to operate the utility with DCC.

A Technical Advisor will also be appointed this year to assist DCC in advancing the design and statutory processes for Phase 1 of the project and to assist in the procurement and establishment of the JV Co. that will operate the DH network.

Protection of Water Bodies Office (PWBO).

DCC is working to deliver a number of projects to ensure that the opportunities to meet DCC's Water Framework Directive (WFD) obligation of achieving "good" status for all our water bodies by 2027 are maximised. Current examples are:

- Sustainable Drainage Systems (SuDS) trial project to 'slow the flow' of surface water run-off from entering our sewer network. Design nearing completion. Subject to planning approval, the Protection of Water Bodies Office is working to deliver this project on-site in the third quarter of 2023.
- Culvert Improvement Works Screen Upgrade Works. The construction works are ongoing with most sites near completion.
- The Bathing Water season has started on the 1st of June 2023 and will run until the 15th of September 2023.. Results will be made available in softcopy format on <u>Beaches and Bathing Water Quality | Dublin City Council</u> or on <u>Find A Beach Beaches.ie Beaches.ie</u> & in hardcopy format at bathing water entrances. Where warnings are required to be raised to protect public health, the Health Service Executive will be consulted and Environmental Protection Agency notified.

Drainage Planning, Policy & Development Control

The SuDS Working Group has produced a new "Property Level Guide to SuDS". This is intended to give guidance on SuDS implementation for small developments, individual houses, extensions, driveways etc. It provides straightforward advice on meeting SuDS requirements in the City Development Plan. It also assists anyone who may want to install water butts, permeable paving etc. to help protect their own local area from flooding and climate change.

Flood Defence Camac River

- Consultants have been appointed by DCC to investigate the reduction of flood risk across
 the DCC and SDCC sections of the River Camac. Environmental and topographical
 surveys are now complete. A computer model has been built to investigate tidal, fluvial
 and pluvial flood risks associated with the river. Preliminary flood extent maps have been
 verified. Flood alleviation options such as storage, walls, embankments and de-culverting
 are currently being computer modelled. A further public consultation is planned in
 September 2023 following the successful ones in June 2022.
- This study as with all other flood alleviation projects is being integrated into a desire to "de-culvert" and widen what is now seen as an over engineered river where possible so that it can, over time, be restored to a more natural state, as far as reasonably possible. The project will also involve identifying and remedying urban pollution sources, where possible. This is also being done in conjunction with an existing Greenway proposal and in tandem with Urban Regeneration and Development Fund (URDF) funded projects in the area. The new City Edge project gives opportunities to achieve some of this. River corridors of 10m-25m wide are policies in the new development plan and these will be implemented where possible on this very constrained river. Liaison with large stakeholders is ongoing on possible flood storage areas in DCC and SDCC.

- Further wintering bird surveys are completed. Building threshold surveys are completed.
 A large Site Investigation for both Dublin City Council and South Dublin County Council area of the Camac catchment has been awarded and is due to commence in July 2023.

Climate Action Team

The Climate Action Team is primarily focused on developing our revised climate action plan (CAP). To support the development of our revised climate action plan to meet National Statutory requirements and the goals of the EU Mission, a review of the current CCAP is under way. Workshops with staff to consolidate actions is underway.

The Climate Action Team with EMRWMPO was involved in a bid for Dublin to be the 2023 Circular Hotspot. The application was led by the Rediscovery Centre and was successful. The four day event ran from May 29th 2023.

The Climate Action Team's have issued the draft food strategy for public consultation. Edible Dublin: Food Strategy will be open for comment for six weeks.

DCC is part of CULTIVATE an EU-funded project to increase public awareness and knowledge of Food Sharing initiatives (FSIs), to understand what drives or hampers their practice, and to foster sustainability, inclusion, and resilience in urban and peri-urban food systems through food sharing as a hub city. CULTIVATE will develop the **Food Sharing Compass**, a social innovation support platform for FSIs, policy makers, food supply actors, researchers, and citizens. With its five tools, the Compass helps these stakeholders navigate food sharing landscapes and cultures to understand, develop, replicate, scale out and strengthen food sharing. The aim is to create more sustainable, resilient, and healthy urban and peri-urban food systems. CULTIVATE supports the EU's inclusive climate mitigation and adaptation ambitions.

Climate Action Regional Office

The Dublin CARO Coordinator's five year secondment contract is up and he will be leaving CARO at the end of June 2023. As lead authority for Dublin Metropolitan CARO region, a replacement will be advertised by DCC pending agreement with DHLGH and agreement of the Service Level Agreement between DECC and CAROs. A graduate intern will be joining the Dublin CARO team on a temporary basis for a 12 week contract in the 3rd week of June 2023.

The Service Level Agreement between DECC and the Lead Local Authorities for each of the four CAROs expired at the end of March and was subsequently extended to end June for agreement by CCMA/DECC. Further instruction is awaited from the Department of the Environment, Climate and Communications with regard to a new service level agreement.

On the 24th of February 2023, pursuant to the provisions the Climate Action and Low Carbon Development Act 2015 to 2021, and Section 14B(2)(a) thereof[1], the minister for the Environment, Climate and Communications instructed all Local Authorities to prepare a Local Authority Climate Action Plan (LACAP) containing adaptation and mitigation actions. This plan must be completed within 12 months of the receipt of this request. It should be noted that the 4 Local Authorities already have Climate Change Action (www.dublinclimatechange.ie) published in 2019. The Dublin Metropolitan CARO and Codema have been assisting and supporting the four Dublin Local Authorities in this regard in terms of reviewing and updating their existing Climate Change Action Plans to align with the most recently published National Climate Action Plan 2023 and to increase the level of ambition in line with national targets. Detailed guidance documents have also been prepared by a national steering

group including the CAROs, Local Authority reps, Codema, SEAI, EPA and Met Éireann to assist the sector in preparing their Climate Action Plans. CARO Chair monthly meetings with all four Dublin Climate Action Teams and Codema to discuss and share progress on Climate Action Plan preparation.

It is a requirement of the Climate Action and Low Carbon Development (Amendment) Act 2021 that local authority Climate Actions Plans, must be aligned to sectoral climate action and planning. Dublin CARO is supporting the Climate teams in the 4 Dublin Local Authorities in this regard.

5 Sectoral engagement workshops for all LAs have been completed. Dublin CARO organised and moderated at the second sectoral workshop on Transportation on 22nd May. Other workshops addressed the sectoral topics of Heritage & Biodiversity, Built Environment and Landuse Planning, Community Development and Enterprise, and Landuse Change. These workshops explored sectoral climate actions that need to be accounted for in LA Climate Action plans and were attended by over 300 attendees across the 31 local authorities. Speakers from dedicated sectors were present and offered valuable insight. Adaptation and Mitigation measures around climate change were addressed. Dublin CARO attended training sessions on Decarbonising Zones on 14th and 15th June.

CARO is continuing the roll out of the Local Authority Climate Action Training programme for local authority staff. The training programme was developed by CARO in conjunction with the LASNTG and other expert partners such as Climate Ireland. Dublin CARO, the Local Authority Services National Training Group (LASNTG), Greenville Procurement Partners and a number of strategic partners have developed Green Procurement Training for local authorities. This training is a key action for delivery of the LA Climate Action Charter 2019 whereby local authorities have pledged to implement green public procurement strategy and procedures across all business areas. Strand 1 of this training is a 45-minute introduction to green public procurement webinar aimed at local authority staff across all departments and levels. This strand went live in May 2022. Strand 2, a 3 day course comprising self-directed and on-line training commenced on 13th June 2022. It was aimed at procurement officers, budget holders and decision makers. Strand 3 which is aimed at staff involved in developing the green procurement strategy in local authorities commenced in late September. Invitations to staff to complete this training will be via the training officers in the LAs and will finish in July 2023. To date 2000 local authority employees have completed the training. Dublin CARO presented the LA GPP Training programme as part of the SEAIs 'Legislation for Local Authories' course in June. Dublin CARO has also presented the project to the Office of Government Procurement's Strategic Procurement Advisory Group.

LASNTG have completed other training programmes on Climate Action Training for Local Authority Staff in April, June and a further programme is scheduled for November 2023. LASNTG scheduled 2 X 1 day Climate Action Training Workshops for the 28th and 29th March and the topics covered were beneficial in developing the Local Authority Climate Action Plans. Dublin CARO were in attendance at the workshop.

Dublin CARO organised the first in a series of climate action site visits scheduled for 2023 for climate action teams. The first site visit on 08.02.2023 was to view work being undertaken by Bord na Móna at the Mount Lucas Wind Farm in rehabilitating and restoring peatland. Bogs are also important carbon stores and the visit showed and explained carbon monitoring work undergoing as part of the restoration and rehabilitation work. Members from other climate actions teams and CARO Regional Offices were also in attendance. The second site visit on 18.04.2023 was to the Neoen Solar Farm at Hilltown Co. Meath commissioned in 2022 with an electricity generation potential of 18 MWp (MWp is an abbreviation for Megawatt peak – a unit of measurement for the output of power from a source such as solar or wind where the output may vary according to the strength of sunlight or wind speed. MWp is a measure of the maximum

potential output of power. A Megawatt is 1,000 kilowatts. A kilowatt is 1,000 watts. A watt is one amp flowing through one volt.

Dublin CARO is looking into organising further site visits for climate action teams in the coming months and is currently looking into the possibility of a visit to an anaerobic digestion (AD) plant in Autumn 2023.

Dublin CARO funded prizes for winning projects in the Globe Nature Based Solutions Schools Projects at a prize giving ceremony on 12th May at the Wood Quay Venue. The Globe Programme is an initiative of An Taisce's Environmental Education Unit and is supported by NASA and the EPA.

Dublin CARO attended the EPAs National Climate Change Conference 2023 at Dublin Castle on 25th May.

As part of National Biodiversity Week 2023 (19th-28th May) Dublin CARO assisted, funded and attended a Climate Change Cruise at Dublin Bay on 26th May. Over 90 persons were in attendance and included climate change and Biodiversity experts and enthusiasts alike.

Dublin CARO are co-sponsoring and will be in attendance at ECCA (European Climate Change Adaptation Conference) at The Printworks, Dublin Castle from 19th - 21st June and will have a stand to showcase national/sectoral objectives and ongoing projects including the Linte Na Farraige project.

Ambient Air Monitoring Network

Work will commence on the preparation of the Noise Action Plan, which is due in 2024.

The Active Travel (AcT) Programme - Walk-Wheel-Cycle Network.

The multi-disciplinary team within the Active Travel Programme Office (AcTPrO) continues to work on the design and delivery of a number of projects as part of the overall network, which when fully completed, will result in 95% of people being within 400 metres of the high quality network within Dublin City.

A comprehensive quarterly report on the activities of the office has been submitted to the Lord Mayor and Elected Members for the July Full Council Meeting, report no. 151/2023. The updates below contain some highlights of ongoing activity for the Active Travel Programme.

The number of projects with construction activity increased to six during the month with the commencement of construction on the **East Coast Trail Phase 1** (Alfie Byrne Road/East Wall Road Section) This project will provide segregated cycling facilities and improved pedestrian facilities along a 1km route that extends from the entrance to the Eastpoint Business Park on Alfie Byrne Road, along Alfie Byrne Road and East Wall Road as far as East Road.

The Project Team comprising members of AcTPrO and Traffic held a meeting with members of the Central Area Committee on the 31st of May 2023 and gave details of expected works, programme and communications for the project. This presentation can be downloaded from the project's newly created webpage. A detailed leaflet for the works is being distributed to households and businesses in the area, distribution started on the 22nd of June. The newly created webpage has drawings and project information available for download, and can be found at www.dublincity.ie/ectnp1.

The five other projects with construction activity are at various stages of progression. The **Clontarf to City Centre (C2CC)** project will deliver 8km of walking facilities, 6km of cycling facilities, and 5.4km of bus lanes, from Alfie Byrne Road/Clontarf Road Junction to Amiens Street/Talbot Street Junction and a section of the Tolka Valley Greenway from Annesley Bridge to Alfie Byrne Road/East Wall Road Junction. Construction commenced in Q1 2022 and will continue until Q1 2024.

The 800m of new cycle track and footpaths which were opened along Fairview Park from Malahide Road to the Tolka in early April continue to be enjoyed by users. The fourth project leaflet was distributed in early April to over 52,000 homes and businesses in and around the C2CC catchment, giving project updates and photographs of project progress. This is available for download from our webpage www.c2cc.ie.

Night-time and weekend works involving major traffic management measures continued in June, similar to previous months.

The latest C2CC Consultative Forum which includes local Councillors and representatives from local residents and businesses was held on 9th June 2023 in Carleton Hall in Marino. An update of the works undertaken to date was presented and an outline of the upcoming works was also shared.

Some of the main upcoming works related to the Scheme is to progress from the Inbound side to the Outbound side between Five Lamps and Edge's Corner. There are some localised inbound locations which are to be finished but it is intended on progressing to the outbound to commence on that side. As part of these works 3no. Outbound bus stops are to close in line with the permanent design proposals.

In order to undertake a number of road crossings and road reconstruction related works, regular weekend and night time works will continue to be carried out throughout this year. Regular notifications of these works are being sent out via DCC's social media accounts, and to the C2CC Consultative Forum which, as mentioned above, includes local Councillors, and representatives from local residents and businesses.

During the overall quarter, the contractor increased his crews to 30 and the number of operatives to 100. The crucial traffic diversion from Edges corner into the city has enabled the Contractor to progress works on multiple work fronts over nearly the full length of the scheme.

Royal Canal Greenway Phase 3 will provide 2.1 km of cycling facilities and 2.1 km of walking facilities along the Royal Canal, from Newcomen Bridge (North Strand Road) to Cross Guns Bridge (Phibsborough Road). Construction commenced on site in February 2023 and is expected to continue until Q2 2025.

The towpaths between Cross Guns Bridge and Binns Bridge and between Russell Street Bridge and Clarke's Bridge continue to be unavoidably closed to the public until further notice to facilitate the works. The towpath between Binns Bridge and Russell Street Bridge closed to the public on Tuesday 6th June and that the towpath between Clarke's Bridge and Newcomen Bridge closed on Tuesday 20th June.

A temporary road closure order for Charleville Mall for the period from Tuesday 20th June to Friday 1st September 2023 inclusive is in place to facilitate the installation of ESB high voltage ducting.

The contractor is currently installing ESB high voltage ducting on the northern canal towpath between Cross Guns Bridge and Lock 3. Three gas main diversions are scheduled by Gas Networks Ireland in this area for late June. The pedestrian and cycle bridge abutments are under construction just to the east of Lock 3. The bridge is being manufactured off site and is scheduled to be delivered to site in two sections, welded together on site and lifted in to place in early July.

Sheet piles have been installed on the south bank of the canal between Croke Park and Clarke's Bridge. Construction of the sheet pile capping beam has commenced and will continue into July.

The contractor took temporary possession of Portland Place Park in late May in order to use it as a secondary site compound and to facilitate access to the relatively inaccessible section of canal towpath between Binns Bridge and Russell Street Bridge. Trial pits are now being dug to confirm ground conditions and the position of underground utilities. Installation of sheet piles commenced along this section of the canal towpath in late June. Portland Place Park will be refurbished upon completion of the project in 2025.

The project webpage is updated as works progress on site; its address is www.dublincity.ie/rcgp3

Also for Binns Bridge, Pre-Part VIII planning departmental consultations have been completed and the Part VIII was noted at the Central Area Committee meeting on 9th May. The Part VIII application is due to be lodged in in early July.

The **South Grand Canal Cycle Safety Improvements** scheme involves the upgrade of existing signalised junctions from Leeson Street Junction to Suir Road junction by 'tightening' wide junctions to improve safety for pedestrians and cyclists, and will also provide signalised pedestrian crossings.

Main Contract Works on site are currently on hold due to the Liquidation of the Contractor, DCC are awaiting correspondence from the court appointed Liquidator.

In the interim, measures have been taken by DCC to ensure public safety is maintained. Temporary Traffic Management measures were removed from a number of locations and footpaths/carriageways reopened. Discussions are ongoing to complete remaining minor civil works at Clogher Road & Aughavannagh Road Junctions. This will allow for the commissioning of new traffic lights and the removal of the remaining temporary traffic management items. Any works carried out will be to ensure there is no risk to public safety while a determination is reached on how the remainder of the contract works will be completed.

Contractors Cairn Construction have been appointed to undertake measures for the **Liffey Cycle Route** along Eden Quay (0.25km section) from O' Connell Bridge to Butt Bridge/Beresford Place junction and installation works commenced on the 3rd of May and are currently progressing well.

The section on the south side of the River Liffey, along Burgh Quay, Aston Quay & Crampton Quay, between Talbot Memorial Bridge and the Ha'penny Bridge is progressing through the final design stages and the preparation of tender documents to procure a Contractor. Following a review process with the NTA it is anticipated that this section on the south quays and across O'Connell Bridge will be tendered in Q3 2023 with construction expected to follow in Q4 2023.

The Dodder Greenway (Herbert Park to Donnybrook Road) Project will deliver 450m of walking and cycling facilities, including flood protection measures, along the Dodder River between the entrance to Herbert Park at Eglinton Terrace and Anglesey Bridge.

The Deck Slabs for the Cantilever Sections of the piled Flood Defence wall were finished in Q2 and the corresponding Structural Walls have begun. Site Clearance to allow the construction of Tennis Court 6 for Bective Lawn Tennis Club has been carried out. Fencing type and details have been agreed with the IRFU .The Invasive Species had been removed from site under licence in Q1- a small recurrence has since been noted, removed and the area isolated. The Site Entrance at Donnybrook Road adjacent Anglesey Bridge is being used as a secondary entrance and is operating well. Substantial Completion is expected in Q4 2023

Non-Statutory Public Consultation on the two sections of the **Dodder Greenway** from Fitzwilliam Quay to Londonbridge Road and Beatty's Avenue to Herbert Park commenced on May 29th 2023 and ran until June 30th and more information is available on the Dublin City Council Public Consultation Hub at https://consultation.dublincity.ie/

A Public Information meeting on the two sections was held on Thursday 15th of June in the Sandymount Community Centre.

On the **Royal Canal Greenway Phase 4**, the proposed amending Part VIII planning proposals were presented to the Central Area Committee meeting on 9th May. All of the Councillors' questions from the meeting are currently being collated and responses will be issued to the Councillors prior to the amending Part VIII submission.

Following on from the presentation to the Central Area Committee in May, an on site meeting took place between the Project Team and Elected Members on Tuesday 6th of June.

The tender competition for the **Fitzwilliam Street** cycle route is now closed and the review process is underway.

The **Sandyford Clonskeagh to Charlemont Street (SC2C)** walking and cycling scheme went to non-statutory public consultation on 30th January until 28th February. A total of 675 submissions were received via the online consultation hub by the closing date. Other submissions were made via email and at the Public Information Event on 7th February. A Public Consultation Report has been drafted and is expected to be published on the DCC website during the summer of 2023.

The Concept Design and Option Selection process for the **Finglas Village Improvement Scheme** are being advanced. A Rapid Build Options Report is required to be prepared for the scheme in accordance with NTA requirements for this phase. The proposed options will then be considered by Active Travel and the NTA, and the Elected Members will be updated accordingly.

On the **Finglas Area Roundabouts** scheme, the Preliminary Design for the Jamestown Road Roundabout has been completed, and the next step is to submit the Project Appraisal and Business Case to the NTA for approval to proceed to detailed design, and appointment of an environmental consultant to complete AA and EIA screening reports. We are also coordinating with Fingal County Council on the requirement for a Section 85 agreement *(one LA performing for another)*. It is expected that detailed design will be completed in Q3 2023, followed by the preparation of tender documents for the appointment of a contractor. Construction is to commence in 2024 subject to NTA approval and funding availability.

The tender documents have been prepared for the McKee Avenue/St Margaret's Road/Lidl junction with approval to proceed awaited from the funding body. Construction is expected to begin in Q4 2023.

The route option selection and design work is ongoing for the **Santry River Greenway**. A series of public consultation events will be held in Q3 2023. This will provide the local community with the opportunity to comment on the emerging preferred route.

The implementation of the **East Coast Trail - Clontarf Baths** scheme has been paused to allow resolution of land acquisition matters.

The **Kilmainham to Thomas Street** design team have been progressing with the detailed design drawings including a new pedestrian corssing at South Circular Road/ St James Walk junction which will improve crossing facilities for pedestrians and cyclists at Rialto Bridge and tie-in with the proposed two way cyclepath at James Walk and also St James Linear Park. Installation of the scheme is planned to commence in Summer 2023. The Public Consultation Report has been prepared and was reviewed by DCC Planning Department. It will be published on the DCC Active Travel webpage before work commences.

The **City Quay to Harcourt Street** multi-disciplinary project team are preparing concepts for a number of options for this significant route along Merrion Street Upper, Merrion Square West, Merrion Street Lower. This will aid further engagement with stakeholders. Internal DCC consultations are ongoing.

The designs for the **Trinity to Ballsbridge** scheme will go to Public Consultation following NTA approval. Information leaflets are being developed and will be distributed in the local area during the Public Consultation period. When the scheme is published more information, including the closing date for submissions will be available on the Dublin City Council Public Consultation Hub at https://consultation.dublincity.ie/

The **Coolock to Clontarf** project team presented a scheme along Gracefield Rd, Brookwood Ave, Sybil Hill Rd & Vernon Ave to the Elected members in the North Central Area in May. Following this, to non-statutory Public Consultation on 6th June, 2023. More information on this scheme can be viewed by accessing the Active Travel webpage at https://consultation.dublincity.ie/traffic-and-transport/gracefield-road-to-vernon-avenue-scheme/

The Public Consultation closes for submissions on 4th July, 2023.

Preliminary Designs are progressing and internal consultation ongoing for the **Grand Canal to Lincoln Place** scheme. It is planned to present this scheme to the elected members in the South East Area in Q3 2023. Following that and pending NTA approval the scheme will proceed to non-statutory Public Consultation.

The Active Travel team have prepared the Public Consultation Reports and developed the service requirements for the appointment of Engineering design teams to develop the detailed design for the following five schemes;

- North Circular Road (from Dorset St Lwr to Amiens St)
- ➤ Hanlon's Corner Junction Upgrade
- Ratoath Road & Cappagh Rd
- Howth Rd, from Station Rd to James Larkin Rd (Raheny to Kilbarrack)
- Kilbarrack Rd to Oscar Traynor Rd.

New Policy/Strategy

Sports & Recreation: The DCC Sports Plan underway. Consultation with area committees and public to be undertake in June and July.

Dublin City Parks Strategy 2023-2025: Parks Biodiversity & Landscape Services has initiated a period of public consultation which will run from 8th May 2023 until 15th September 2023 to inform the development of the new Dublin City Parks & Landscape Strategy. As part of that public consultation process, Dublin City citizens have been invited to participate in an online questionnaire to gauge opinion on the quality and value of public parks operated by Dublin City Council. A press release was issued on 10th May 2023 to advertise the public consultation. Submissions can be made via this link: Parks Questionnaire 2023 - Dublin City Council - Citizen Space.

Libraries: A new **national public library strategy** will shortly be launched. The new strategy will be the successor to '*Our Public Libraries 2022 – Inspiring, Connecting and Empowering Communities*' which has overseen much progress in the public library service in Ireland over the past 5 years.

Local Economic and Community Plan 2022-2027 (LECP) Advisory Group formed with ongoing meetings. A stakeholder consultation plan is currently being drafted.

Departmental Priority

A new branch library will open in **Finglas** on the Seamus Ennis Road in August. The existing library in Finglas Village Centre closed on Saturday the 24th June at 5:00pm in preparation for the move to the new building. The opening date of the new library will be advertised widely on social media in July, date to be confirmed.

The **Summer Programme for Children**, will run during July & August with storytelling, music and drama performance, puppet shows, creative writing, climate change, STEM workshops and much more. Highlights include 3D Printing and Upcycling workshops, interactive Music Programming and Creative Writing sessions as well as book themed events, storytelling, crafts and drama workshops to complement the Summer Stars promotion. There are over 40 events to choose from, including family friendly events.

We welcomed 100s of **Students** to our branches during May and June as preparations for the national exams began in earnest. We wish them all the best in their studies.

Summer Stars, the free national reading programme for children will take place in Dublin City Libraries from June 12th to August 31st. This year we are running a Summer Stars competition where parents can send in pictures of the book their child is reading with some words from their child about why they love it. More information here.

As part of the **Creative Hubs Summer Programme**, Ballyfermot, Cabra and Coolock libraries will host a dedicated Early Years programme, featuring performance and workshops in dance, drama, visual art and storytelling. The programme includes storytelling and dance sessions developed for neuro divergent groups.

The 'My Little Library Book Bag' initiative will run in libraries nationally from June 8th to October 31st. The project is part of the National First 5 Strategy and is available free for every child starting school including Ukrainian children up to ages 7/8. Bags can be collected at any library.

Throughout July our **Library in the Community Team** will bring a variety of events and a popup library to community events and festivals in the city including Funtropolis in Merrion Square and The Rose Festival in St Anne's park.

LOTE4Kids can now be accessed via an **app** allowing parents and children to enjoy the magic of books in other languages at home. Each book is provided with an English translation to help develop multilingual reading and listening skills. Download <u>Android</u> or <u>Apple</u>

Economic Development & Enterprise SPC Hybrid meeting in City Hall / Zoom took place on 25/04/23. Agenda items included International Relations Update, Smart Tourism Programme, Dublin Belfast Economic Corridor, LECP, Dublin Place Brand Strategy, Circular Economy Hotspot 2023, Night Time Economy Advisor & SoCircular Outcomes Report/Brochure. Dublin City Council Kerbside Management Pilot Meeting with Appyway

On 14th June, Dublin City Council hosted Appyway team who has been involved with Smart Cities Unit for the Kerbside Management Pilot. The Pilot started in October 2022 and has been selected as one of the 35 projects under National Pathfinder Programme, an initiative by Department of Transport. Dublin City Council has now mapped and created a digital inventory of the kerbside assets, not only for internal use but also for citizens with an open link here. The area defined for the pilot was the South Docklands region where approximately 20 unique kerbside assets were identified and approximately 2000 data points were collected by mapping 30+ kerb kilometres. The assets include double yellow line, single yellow line, paid bays, resident bays, loading bays, various traffic regulations, tariffs and also have the potential to include public realm assets like planters, pay and display machines etc. The City Council is also collaborating with Curb IQ team for the same pilot and have created a digital inventory of kerbside assets for Grafton/Dame Street area. The members in the meeting came from different teams including Transportation Planning, Traffic Enforcement, Traffic Asset Management System (TAMS), Micromobility, Public Realm and members of Pathfinder team from Department of Transport.

Smart Docklands Internal Engagement Workshop

On Tuesday 13th June, the Smart Docklands team held a workshop in Wood Quay Venue with Dublin City Council staff from a variety of departments to ideate possible avenues for future collaboration. Following a welcome speech from Chief Executive Owen Keegan, Jamie Cudden, DCC Smart City Programme Manager, presented an overview of the Smart Docklands district, introduced the team, the district's projects to date, and highlighted opportunities for participation in the next chapter of Smart Docklands. This workshop highlighted the district's existing citizen engagement and connectivity work, aiming to align them with ongoing projects and initiatives throughout the council. As a partnership between the council, Trinity College Dublin and CONNECT SFI Research Centre, Smart Docklands offers an excellent opportunity to support and accelerate sustainable innovation across the city. ADAPT Annual Scientific Conference

Dr. Mani Dhingra (Digital Twin Manager) and Aleksandra Kocon (Technician) from the smart cities team presented a poster at the-second ADAPT Annual Scientific Conference in the Helix, DCU on 30th May 2023. The conference provided a forum for advancing discussions on the ongoing collaboration between the ADAPT SFI Research Centre for Al-Driven Digital Content Technology at Maynooth University and the smart cities unit of Dublin City Council for understanding the role of digital twins for stakeholder and community engagement. DCC has already been experimenting with state-of-the-art technologies such as 3D models, drones, and LIDAR across various thematic challenges such as energy consumption, urban planning, public engagement, environment, tourism, and infrastructure management. Advancing towards a more sophisticated system, this project intends to apply a people-centric approach for effective stakeholder collaboration and explore novel forms of community engagement.

Service & Digital Transformation

The tender for an online consultation portal will be published in June.

The project to implement a new Chief Executive Orders system based on the system developed by Fingal continues to be rollout out. Currently working on phase 3 with Housing, and Dublin Fire Brigade. The Area Offices and Law Department have been postponed to the next stage.

The team continued to roll out the online appointment booking system to allow citizens and businesses to book either in-person or online meetings.

The online venue booking system is now live with the Arts office. We are seeking to engage with other areas in relation to online customer bookings for venue hire.

The pilot is ongoing for the digitally enabled outdoor workforce project. Staff from Sweeney's Terrace Waste Management Depot and Housing Maintenance, Ballymun have been provided with phones and access to CitiDesk. The pilot is being extended to the new citywide wash crew. There are a lot of learnings from the pilot and we are working through issues identified.

Lord Mayor Caroline Conroy presented awards to staff at the inaugural staff awards scheme, the Three Castles. Awards were presented in the categories Sustainability, Innovation, Cross Functional Collaboration, Commitment to Citizen, Service Excellence, COVID Response.

Work is continuing on the digitisation of internal processes on CitiDesk. We are engaging with Housing and Planning & Property Development.

The digital application support team are working with the Communications Office to agree website governance, privacy and accessibility standards.

Active Travel are now using the Citizen Alerts platform which allows citizens to register their interest in receiving updates on projects.

Citizen Hub Project

We are working on providing a digital solution to Choice Based Lettings and also on making grants schemes available for application online. The Councillor Portal is in test, as is a solution for customers who wish to engage with us through Irish. The reporting solution is being developed. Work is ongoing on UX/UI to improve how the solution operates with dublincity.ie

Corporate Data and Analytics Unit

Citizen Hub: A new Corporate Template has been created for dashboards and is currently being implemented.

Open Data: An audit of current open data has been completed and the theme of culture is now being explored. Engagement has begun with all relevant stakeholders to map out all culture data assets and an assessment of these will follow. Data has currently one open data request and has published a new data asset to Dublinked.

Annual Service Delivery Plan: The process documents and mappings are now complete for Housing. The first phase of stakeholder engagement has begun with Environment and Transportation. This will allow full process documentation and mapping of its ASDP metrics.

Promotion of Data within DCC: Engagement with stakeholders continues and is a major role of the Unit. A 'Data Journeys' event is planned for the 12th of July. An expert set of presenters will share their knowledge and experiences through engaging presentations on the set up of their data units. These include representatives from the Department of Children, Equality, Disability, Integration and Youth, National Transport Authority, Department of Agriculture, Food and the Marine and Maynooth University and An Garda Síochána.

North City Operations Depot

The North City Operations Depot was officially opened by Lord Mayor Caroline Conroy on 20 June. Staff have begun the process of moving into the depot and this process will continue over the next few months.

Customer Services

From 25th May - 18th June

- 10,053 calls were answered, with just over 70% of those calls answered in less than 30 seconds
- 1,894 emails were sent out from the generic customer services email account
- 2,418 payments processed
- 1,347 Parking Permits applications and renewals processed
- 908 visitors greeted at the reception desk in Civic Offices

Improving Customer Experience Initiatives

- A number of new staff have joined Customer Services and most have now completed their training. This has speeded up the average time for a customer to be answered on the phone and between 25th May and 18th June, this has now reduced to an average of 1 minute and 4 seconds.
- A new Irish speaker has joined Customer Services and is now dealing with business queries through Irish.
- Work is continuing on the development of the new Parking Permit System to facilitate online applications.
- A Mystery Shopper Programme has been designed and is expected to be carried out in July/August to compare performance with the end of last year.
