To the Chairperson and Members of the South East Area Committee

Report of the Director of Services, Central and South East Areas

City Quay

A landscape architect is finalising the public realm improvement for the front of City Quay fronting the Liffey. It is hoped that this work will commence in late Q3. We are also liaising with an artist in relation to a proposed mural which will form the backdrop to the public realm improvement where cars currently cross the footpath to park.

Bridge Project

The area office continues to liaise with Swan Youth Services and St. Andrew's Resource Centre together with Gardaí in Store Street and Pearse Street with a view to reducing antisocial behaviour in the vicinity of the Quays which was a major problem last year. We are working on arranging diversionary activities for young people in the area.

Cabbage Garden

Awaiting update from Parks.

Sandymount Green

Traffic calming on Sandymount Green will continue every Friday, Saturday and Sunday until the end of September. There will be music on Saturdays and Sundays and Waste Management will provide enhanced cleaning in the area at weekends.

Rosary Hall

After receiving extra funding of €240,000, which was approved at the April City Council meeting (as well as €125,000 already allocated), it was decided to retender the entire proposed works. Meetings took place with both main community groups and consultant architects during the summer 2021 to outline and agree the proposed works which included mechanical & electrical works, fire safety works, remedial works and lift replacement.

The Area Manager also engaged in meetings with both community groups regarding governance of the facility and a management agreement was finalised in May 2022.

A supervisory committee comprising of two members of the football club and two members of the Harold's Cross Village Community Council (HXVCC) and the Area Manager will be established to optimise the use of the facility for the benefit of the community.

Tender documentation was completed and advertised and tenders were received back on February 14th. When these tenders were assessed by consultants it was apparent that construction inflation has led to a significant increase on the previously estimated cost.

A full Corporate Project Support Office (CPSO) appraisal form has been submitted in relation to the matter and it has been included in list of projects for capital funding

The disposal of the lease was agreed at the Area committee meeting in June and was brought to the July Council meeting and approved.

Final further work in relation to the agreed Protocol for Management of the Building was agreed late last year and the Lease signed

The works were tendered on 6th April and the last day for submission was the 8th May. The tenders have been assessed and preferred bidder selected.

All those who responded to tender will be contacted this week and the lowest tenderer will be issued with a letter of intent. The community groups have been informed of the progress.

Age Friendly Initiative Harold's Cross

The Age Friendly Committee for Harold's Cross has been operational since early 2020. A draft report was submitted by the Harold's Cross Village Community Council (HCVCC) in conjunction with Rob Chester, Area Community Officer and it was agreed to progress a number of these proposals, funding permitting. In tandem with this it is proposed to hold a workshop to further engage with the residents and ensure particularly any elderly resident who was not consulted has an opportunity to contribute to the process and be included. It was agreed to defer the facilitation of a workshop to get the views of the wider community till autumn 2022.

A subgroup under the Housing SPC has been convened to look at the City Wide Age Friendly Strategy. Under this structure, submissions for funding may be advanced, including the Harold's Cross project.

It has been agreed by the elected members that further monies (€8,000) will be allocated to this age friendly initiative in the discretionary funding for 2022.

IT age friendly tablets have been distributed to residents and have been very well received. Cliff Run Media have supplied over 1,000 units to established age friendly projects across the country; the tablet comes with one year's free WIFI and are dignity proofed to make access as easy as possible.

It is anticipated that when the works are completed on Rosary Hall, it can play a pivotal role in age friendly activities going forward.

Eir have completed the work involved in getting an additional line into Harold's Cross Park to enable Virgin Media to set up the Wi-Fi hot spot for the area around the café.

A series of subgroup meeting have taken place in 2022 including February 11th, 28th, March 16th and April 8th to progress matters and it is hoped to schedule a programme of events to encourage people to participate in.

The first Ageing Well Café meeting took place on March 8th and was attended by about 40 residents with great support from HXVCC. There was a good cross section of our older persons.

A trip to Russborough House took place on April 11th.

An Ageing Well Café meeting took place on 17th May in McGowan's and a full Age Friendly Committee meeting took place on May 5th.

The subgroup met on July 15th and a main meeting took place on the 20th September.

A trip was organised to the National Stud on Tuesday 27th September and was attended by a large group.

An event took place in McGowan's on 7th December and was very well attended

Further monies has been set aside in the Discretionary Fund this year for the HX Age Friendly Initiative.

A physical meeting took place on 5th April in the Pastoral Centre Harold's Cross and was well attended.

A meeting of the subgroup took place on 30th May and a main workshop took place on 8th June.

The Area Manager would like to thank Cllr. Feeney and Tony McDermott for their facilitation on the evening and the collation of the information from the participants that will be reviewed by the main age friendly group at the next meeting

Rutland Grove / Eamonn Ceannt Park

A Crumlin Halloween Mini Festival took place in Eamonn Ceannt from 12pm to 4pm on Monday 31st October 2022 and received very good feedback from the community who attended.

A 'Friends of Eamonn Ceannt' meetings took place on 15th December in the Pavilion in Eamonn Ceannt Park and again on March 30th.

Active Travel have indicated that they do not intended to proceed with the Kimmage – Clogher Cycleway at present.

Les Moore at the meeting on 30th March indicated that Active Travel have the expertise and funding and it is not his intention to sanction any roadworks that were passed as part of the Part 8.

At this meeting the 'Friends of Eamonn Ceannt' Committee visited the area in question and the Area Manager, on request, has written to John Flanagan, Assistant Chief Executive of Environment & Transportation Department to see if they would decrease the size of the footpath to facilitate some dedicated parking.

In relation to the upgrade of the depot, Parks Department have informed local residents that due to the withdrawal of a subcontractor, that depot upgrade is delayed for two months.

A meeting between the Gardaí, three local resident groups and the Area Manager took place on Wednesday evening 31st May to highlight some of the local concerns regarding matters including anti-social behaviour, illegal parking, overflowing bins and damage to playground.

A friends of Eamonn Ceannt meeting is scheduled for Wednesday 28th June.

A new date of 31st July has been given for the commencement of upgrade works and a meeting has been sought with the local residents' association.

Grand Canal

A meeting was held in January 2020 with Waterways Ireland representatives and Councillors to discuss ongoing management and maintenance of the canals in the city and to agree a new structure for interaction between Waterways Ireland and DCC. The latest meeting was held on 2nd February 2023. Next meeting due to be held on 26th July 2023 via Teams.

Portobello Harbour Square

Áit Urbanism + Landscape were appointed as consultant for the project and two initial public consultation workshops were held on 1st and 8th June 2022 at St. Kevin's Community Centre. Concept designs were prepared by consultants based on the outcome of these workshops and these were put on public display at St. Kevin's Community Centre between 3pm and 8pm on Thursday 21st July 2022. Online consultation was open until 19th August 2022 and a large number of submissions were received. Preliminary Appraisal form has been lodged with the Capital Project Support Office (CPSO). Provision has being included in the Parks 2023/24/25 draft Capital Programme. Parks Department presented the latest design to Councillors on 18th May 2023. A further public consultation took place at St. Kevin's Community Centre on 31st May 2023 and subsequently online. It is hoped to commence Part 8 process in July 2023.

Rathgar Village Improvement Plan (VIP)

Herzog Park, Rathgar - Final Phase

The final phase of the project includes the re-alignment of the front boundary of the park and the revised car park layout, as set out in the Part 8 permission. A preliminary site meeting was held with Road Construction engineers on 14th April 2022. Surveys of the area were carried out including a drone survey and GPR Survey to assist in the design process. Roads engineering resource is now in place and a meeting was held on site on 5th May 2023 with Roads Engineer, Parks Department and the area office. Once the detailed design process has been completed, costings will be compiled and a tender prepared for works to car park area in 2023. When these works are carried out, further landscaping inside the park will be required as part of the works to complete the project.

Ringsend Irishtown Local Environment Improvement Plan (LEIP)

Library Square: (Mitchell & Associates) Meetings with internal stakeholders were held during September and October 2018. A meeting was held with local businesses to discuss parking / loading arrangements on 5th December 2018. A presentation was made to area councillors on 13th February 2019 and a preliminary draft design was brought to a public meeting for all stakeholders on Thursday 21st March 2019 in the Ringsend Irishtown Community Centre (RICC). Following a period of consultation up to 19th April 2019, submissions were received and were reviewed by the project team. A revised design was brought before the Public Realm Working Group on 22nd October 2019. A meeting of all internal stakeholders was held on 28th November 2019 and further required detail was identified by key departments. An invitation to tender for additional services to bring the project to Part 8 was issued to consultants and Mitchell & Associates were formally appointed on 17th November 2021. Preliminary meeting of design team took place on 15th December 2021 and detailed meetings with internal departments were held in January and February 2022. GPR Survey was carried out in January 2022.

A second round of meetings with internal departments was held during April/May 2022 and work was carried out on finalising the design. A meeting was held with local businesses to agree servicing arrangements for traders on Fitzwilliam Street in November 2022. A public information meeting to present the designs to the community was held in December 2022 in Ringsend Irishtown Community Centre which was well received. A Road Safety Audit has been carried out. Pre-Part 8 drawings were circulated to Technical Departments on 14th April 2023 and final issues are now being resolved. Councillors will be briefed before we commence the formal Part 8 process.

Choice Based Lettings / Allocations

We are currently completing estate management checks on applicants for CBL's in Cashel Avenue and Rutland Avenue flats before these vacancies are allocated. We received in excess of 90 applications for the Cashel Road house and in excess of 40 applications for the Rutland Avenue flat. The next CBL's which will be advertised are likely to be in SC complexes at Lissadel Court, Maxwell Court, Clonmacnoise Grove and Stannaway Court.

CCTV Benbulben Road

Following on from the provision of Discretionary Funding for the installation of CCTV at Benbulben Road, we have continued to try to progress the matter. Adhering to advice from DCC's Data Protection Office, a letter was sent to the Garda Commissioners Office on the 11th March 2021. This letter requested written authorisation from the Garda Commissioner for Dublin City Council to install CCTV at the location, which is a public area and not within the bounds of a Dublin City Council complex. The current DCC code of practice for installation of CCTV in public places requires such authorisation from the Garda Commissioner. The office of the Commissioner replied on the 11th May 2021 and submitted a number of documents, including An Garda Síochána's Code of Practice for Community Based CCTV Systems. The documents submitted are at variance with DCC's code of practice for CCTV in public places and do not seem to take into account that DCC are installing the CCTV rather than a Community based organisation. Discussions took place with local based senior Gardaí in order to try and reconcile the differing positions but following further advice from our Data Protection Office further clarity was required from An Garda Síochána. Further communication from An Garda Síochána outlining their position on this matter stated that their internal policy/procedures will only allow authorisation of this scheme if it is designated a Community CCTV Scheme. Designating this CCTV Project a Community Based CCTV Scheme would impose greater responsibility on the local community in relation to their role in consultation, installation, maintenance and management of the CCTV system. In addition, given the proposed location of the CCTV and the serious criminality which has taken place there, there is a significant potential for health and safety issues to arise for community representatives involved in such a project. It would also have the potential to increase costs for the project.

Following a meeting with our Data Protection section some clarity has been provided in relation to CCTV. Regarding CCTV in public places, they have confirmed that we are required to seek the authorisation of the Garda Commissioner through the Community Based CCTV Scheme process. Accordingly, the first step in installing CCTV at Benbulben Road will be to form a project team, to include members of the local community, An Garda Síochána and Dublin City Council, technical experts etc. Given the required involvement of the local community, the issues of health and safety outlined above are still a concern. However, a meeting has been held with reps from the local community and a potential solution was put to them that would reduce any potential risk and satisfy the requirement for local community involvement. On that basis we will shortly proceed to form a project team. There is a detailed and lengthy process to undertake before an application is submitted and it is crucial that all steps in the process are closely followed in order to ensure the best chance of securing the authorisation of the Garda Commissioner. It should also be noted that the ultimate outcome in this matter may well be that CCTV is not justified at this location, at this time.

Former Fr. Lar Redmond Hall, Keeper Road, Drimnagh

This community hall has been vacant for many years and Housing Development are proposing to redevelop the site for Housing. The site will be developed by Respond Housing and the proposal is to build Older Persons Units on the site. Information days took place in Dolphin's Barn Library on Wednesday 25th and Thursday 26th January. The main comments related to the proposed height of the developments and this was repeated at the presentation that was made to the Area Committee on 13th March. Following a redesign in response to points raised at the Area Committee Meeting and at the Community Consultation event Responds Architects have completed a further redesign. The main changes are as follows:

- A reduction of the overall building height from 7 to 6 storeys.
- Increase in height to the rear block from 4 to 5 storeys with the top floor set back.
- Reduction in car parking spaces provided from 5 to 3.
- Relocation of the communal room from third floor to upper ground floor, with dedicated entry from Keeper Road.

• Unit numbers have reduced from 22 to 20, due to the reduction in height, with unit areas remaining at approximately just over 50m2.

A planning application was lodged on 16th June with the last day for observations being 20th July.

Ravensdale Close / Clonmacnoise Grove

Following a meeting on Thursday 26th January with Housing Development and FOLD AHB (approved housing body) to review feasibility studies for the redevelopment of Ravensdale Close and Clonmacnoise Grove senior citizens' complexes it was agreed that both projects were viable. The plans are currently being finalised and consultation with residents has commenced. So far there has been a very positive response from residents. Outline designs are still being worked on and when they have been completed a presentation will be made to the residents.

South East Inner City and Pembroke Community Development Update

Cabbage Patch Park

A weekly multi-sports programme will take place for young people in the park from 19th July to 16th August, organised by our Sports Officer and the YMCA.

Taking Liberties for Local Charities will have their annual Fun & Sports Day on Sunday, 23rd July from 12 - 5pm at the Cabbage Patch Park. Activities will include Sports, Magic Show, Balloon Modelling and local Dance Performances. This event also serves as a fundraiser for Our Lady's Hospice

Musical Garden Parties

Many of our senior residents will be able to enjoy refreshments and take to the green and gravelled "dancefloors" of our sheltered housing schemes during July and August as we provide some live outdoor music. These events, organised in conjunction with the local Housing Liaison Officers, also serve to showcase the huge efforts of local residents who take such pride in their gardens and communal areas. South Docks Festival

A whole range of events for all ages including a Community Parade, Fair in the Square, Talent Showcase, Dublin Port Tour and a 70s Night will take place between 17 - 21 July as part of the 36th South Docks Festival, which is being run by St. Andrew's Resource Centre on Pearse Street. Summer Projects

These well organised summer projects have been running for a number of years with a host of fun and educational activities always on offer for local young people.

Ringsend & Irishtown Summer Project

Over 200 young people have registered with Ringsend & Irishtown Community Centre for the two summer camps taking place in July and August. They'll run for 4 days a week and include trips to Ardgillan Castle, Kia Ora Farm, Tayto Park, Dublin Zoo, Clara Lara and Malahide Castle.

Talk About Youth Project Summer Project

This project operates from St. Andrew's Resource Centre on Pearse Street and will this take place from 4 - 14 July. Over 150 young people will participate in activities including a Funky Planting workshop, a Nature Scavenger Hunt & Picnic, a Sports Day and Day Trips to Lilliput Adventure Centre, Bray, Sandycove and Dun Laoghaire.

YMCA Summer Project

This project operates from the YMCA on Aungier Street and will be catering for over 100 young people primarily from the Dublin 8 area. This project will run for 8 weeks from 3rd July to 16th August with a number of activities on offer including alpaca trekking, water sports, rock climbing, laser tag, crazy golf and day trips to the likes of Belfast, Howth and Causey Farm.

Sandymount Pedestrianisation

Traffic calming is in place on the east side of Sandymount Green, every weekend (Friday, Saturday and Sunday) until the end of September 2023. This was agreed by Councillors at the May South East Area Committee meeting. Premises have the opportunity to trade outdoors at weekends and this area will then be re-opened to traffic as per normal from Monday to Thursday.

The South East Area Office has arranged additional planters and musical entertainment at weekends. Waste Management will provide enhanced cleaning at weekends.

The area office has been engaging proactively with local businesses, residents, An Garda Síochána together with SAMRA and local Councillors and appreciates all the support received to date.
