Update on St. Anne's Redevelopment

Geotechnical Survey

Grafton Architects have appointed sub- contractors Thomas Robinson, Hanmar Site Investigation Services to carry out a Geotechnical Survey in St Anne's Court - Details below.

- > Dates confirmed to start works 18th July 25th July
- > **Duration of works** 2 weeks approx.
- **Hours of work** 8am-6pm They have advised that they will endeavour to keep loud works until the afternoon where possible and practical.
- Expected noise levels This will be a noisy job unfortunately, however we have asked if there is any acoustic protection that can be added to the Harris fencing to reduce the overall noise levels.
- Any obstruction to walkways or parking spots -There will be temporary protection barriers around any works including Harris fencing and signage.
- > Traffic Management There will be some opening up of road surfaces and traffic management will be in place while these works are underway.
- Communication Staff from Clontarf & Donaghmede LEA's Housing team will deliver a newsletter to all residents' advising them of the upcoming works, we will of course continue

visiting the residents' of St Anne's Court, keeping them updated on a regular basis, and addressing any issues the residents' may have.

We are happy to inform you that an agreement has been made with the Area Office and Housing Maintenance Department, for works to be carried out to upgrade and replace all front & back doors in St John's Court, senior citizens complex. It is hoped that these enhancement works will be completed by Q 4 of 2023.
