General Matters

New Finglas Library:

Dublin City Libraries is due to open shortly. The opening date is yet to be confirmed.

Finglas Employment Initiative:

The Local Area Office has initiated contact with all the major infrastructural investors in the Finglas Area with a view to providing employment opportunities to local people with regards to the LUAS and various other projects happening in the area. New members to include Colaiste Idé, The Finglas Training Centre which will add depth to the level of services to be offered under this project.

The next meeting will take place on the 29th September 2023.

Scribblestown

An order of magnitude costing for the drainage and surface water issues in Scribblestown will be completed this week. It is the Area Offices intention to seek tenders for this work with a view to completing by end Q3 2023.

The Area Office will also seek to engage a suitably qualified consultant to complete the survey of roads and footpaths in the estate and produce order of magnitude costs. Once complete the Area Office will seek tender to complete this work.

Public Lighting have completed their survey of public lighting in the area and a report on findings is due.

Berrvfield

The Housing, Community and Public Domain Sections are working with the residents in Berryfield and the surrounding area with a view to alleviating some of the issues that have been identified by residents.

Rivermount FC

Work has begun on the works agreed with the Club under the Discretionary fund. The works are expected to be completed by the end of July.

Small Scale Works

Small scale works are currently being identified across the area to enhance the physical environment. Entrances to the Finglas area are to be enhanced, derelict sites cleaned up, small repairs to railings etc have been identified for attention.

The event attracted the attention of people passing by.






Teen Space

The site is located at the side of Finglas Leisure Centre and not far from the "Out Door Gym and Mellowes Park Playground. The site is safe and secure, with many Teenagers using the walk through the Park after attending the Youth Resource Centre, Leisure Centre or on their way to and from school.

The original consultation pointed to young people wanting a safe space to hang out, WiFi and a shelter .Dublin City Council will now look at appropriate companies from our works framework and seek tenders.



Sports Capital & Equipment Programme 2023.

The Department of Tourism, Culture, Arts, Gealtacht, Sport & Media has announced the Sports Capital & Equipment Programme 2023.

Groups intending to make an application must first with the Department by 5.00pm on Friday 25th August 2023.

The 2023 Sports & Equipment Programme will open for applications at 9.00am on Monday 17th July until 5.00pm on Friday 8th September 2023

Dublin City Council Community & Social Development Staff will assist groups with applications where possible

Sports Capital & Equipment Programme 2023 announced with increased thresholds for local and regional projects

- Local project maximum grant increased from €150,000 to €200,000
- Regional project maximum grant increased from €300,000 to €500,000
- · Specific focus on climate action, sustainability and gender equality

The Minister for Tourism, Culture, Arts, Gaeltacht, Sport and Media, Catherine Martin T.D., and the Minister of State for Sport and Physical Education, Thomas Byrne T.D., today announced that a new round of the Sports Capital and Equipment Programme (SCEP) will open for new applications from 17 July. The SCEP is the Government's primary vehicle for providing support to sports clubs and communities to develop sports infrastructure around the country. Applicants for local projects can now apply for up to €200,000, increased from the previous maximum grant of €150,000. The maximum valid grant available for projects deemed to be of regional significance has been increased from €300,000 to €500,000. In addition, this year's SCEP "Guide to Making an Application" has a focus on climate action and sustainability for the first time, supporting local clubs to take steps to reduce their energy consumption and applying for more efficient lighting. For the first time in the history of the SCEP, projects will only be considered for grant support if access is guaranteed to men and women on equal terms. As one of the stated objectives of the Programme is to increase female participation, all applications for funding of women-only facilities will be deemed valid for consideration.

Minister Martin said: "This is excellent news for sports organisations that have plans to improve their facilities and wish to avail of support. The Programme has already made an enormous difference to communities in every part of the country. To encourage as many people to participate in sport and physical activity as

possible, we need to have appropriate sports facilities and equipment. The new round of the Programme will again prioritise applications from disadvantaged areas, those that target people with disabilities, and projects that share facilities amongst different organisations and sports. In relation to changes to the scheme, I am very pleased that applications for improvements to swimming pools will be accepted for the first time. I also welcome the fact that, for the first time, the "Guide to Making an Application", as published today, has a specific focus on climate action and sustainability issues".

Minister Byrne said: "I have seen at first hand the huge difference that Sports Capital and Equipment Programme grants make to sports clubs and community groups across the country. I am also very aware of the impact that construction inflation has had on our sports clubs and community groups in recent years and I am delighted to note that we are increasing the maximum grants available under the Programme. Ensuring equality in sport has been a particular priority for me since my appointment. Under this round of the Programme, applicants that do not provide access to facilities on similar terms to male and female users will not be eligible for capital funding. As one of the stated objectives of this Programme is to increase female participation, all applications for funding of the very small number of womenonly facilities will be deemed valid for consideration. This new requirement is highlighted in the Guide to Making an Application which is available to download on the Department's website".

The first step in obtaining a grant is to register on the Department's online system and the Ministers encouraged any clubs that are not already registered to do so now. Clubs can register at www.sportscapitalprogramme.ie

Once registered, all applications must be made on the same website. The system will be open for applications from 17 July to 8 September.

The "Guide to Making an Application" was also published on the Department's website today and can be found here: gov.ie/sportscapital The Guide essentially sets out the terms and conditions of the Programme. A review of the 2020 round of the Programme was published in May and all of the main recommendations have been included in the Guide.
