1. Local Area Plan Update

Site 1 - Shopping Centre

<u>Douglas Newman Good</u> received 6 responses to the market soundings exercise to ascertain interest in the site. Following the date for receipt of submissions a separate proposal for the Shopping Centre site was subsequently received by the Development Department of DCC. Responses received do not present an optimum solution for the site and therefore DCC will now consider next steps having regard for market conditions, construction costs, housing demand in the area etc.

Vacant DCC units

Shangan Neighbourhood Centre

The disposal of unit 3 to the STAR Project for their easy Street team is still ongoing. Economic Development Officer to advertise 2 other vacant units.

Turnpike, Santry Cross

The Economic Development Officer has been instructed to advertise the vacant units at Santry Cross previously occupied by the Dublin Northwest Area Partnership. The double unit is designated for a commercial office.

Site 6 - Coultry Road / Main Street

DCC Housing have discussed the development of the site under the CREL Cost Rental model with O'Cualann (proposed site developer) Circle and Tuath (who would operate the proposed units). An outline development programme is to be submitted to DCC Housing by O'Cualann.

Social Housing PPP Bundle 3

Site 10 – Shangan Road

The scheme will deliver 93 units in total, comprising of 73 senior citizen apartment units of which 67 are 1 bed units and 6 are 2 bed apartment units. The remaining 20 units are comprised of 10 general need units (5 x 2 bed; 4 x 3 bed and 1 x 4 bed) and 10 medical need units (5 x 2 bed; 4 x 3 bed and 1 x 4 bed). The PPP Project will deliver a new link road and a landscaped public and private open space, as part of the overall development. Planning approval has been secured for all six sites in PPP Bundle 3 across Dublin, Sligo, and Kildare & Wicklow. The programme is now in the **pre-qualification assessment phase of procurement.**

Social Housing PPP Bundle 4

Sites 5- Main Street site to South of Santry Cross, Site 15 - Balcurris Gardens, Site16 - Balcurris Close, Site 17 - South of Santry Cross & Site 18 - Balcurris.

The above sites have been approved by the Department of Housing, Local Government & Heritage for inclusion in the National Social Housing PPP Programme, Bundle 4. Previously an update was presented to NWAC members by the PPP Project Team. The programme for the PPP Bundle 4 sets out the initiation of planning in Q4 2023. The said sites remains on programme. The Project Team will be meeting with Councillors & Area Officials on 18th July to present proposals and next steps including wider stakeholder engagement.

Sites requiring Expression of Interest

Sites 8 NW of Coultry Park & Site 9 Coultry Road

These sites are currently being prepared for Expression of Interest for the development of the site. Housing and Community Services have met with the Area Office and internal Departments to agree on infrastructural requirements. These have been finalised and Expression of Interest documentation is being finalised.

Sites 11 Sillogue Avenue & Site 13 Sillogue Road/Holy Spirit

Cluid have been selected to carry out a detailed feasibility study following a competitive Expression of Interest Process and in June they presented an initial concepts to DCC Housing Development team for discussion. Members will be updated on progress in the coming months.

DCC Affordable Schemes

Sites 12 Sillogue Road & Site 14 Balbutcher Lane

Density and site requirements for both sites being finalised in advance of Part 8. Members received a presentation in relation to site 12 & 14 on 4th July.

Site 19 - Saint Joseph's

The applicant has finalised its response to all issues raised in the Further Information (FI) request dated 8th November 2022 relating to Planning Application 4853/22. The FI was submitted on 18th May 2023 and a decision to grant planning permission was made on 14th June 2023. Decision is now due.

Site 21 - Poppintree Neighbourhood Centre

O'Cualann is currently in discussions to appoint a contractor.

Site 25 - Parkview

Planning Application 5252/22 was lodged on 18th November 2022. This application is for 34 dwellings and a crèche. A Further Information (FI) request was issued by Planning on 20th January 2023. A detailed Road Safety Audit formed part of the FI and this has now been completed. The FI was submitted on 16th June 2023.

A Section 183 Disposal report is due to go before the North West Area Committee.

Redevelopment of Ballymun Plaza Update

Cearnóg an tSeachtar Laoch

Consultants (AECOM) were appointed in 2022 to develop the Part 8 planning drawings into a Tender / Construction package. A draft of these drawings including all Civil, Landscape and Electrical Engineering was issued in March 2023 for review by the Parks Department. The park has Part 8 planning approval.

The Parks and Landscaping department have now received the final Tender Drawings from AECOM and have outlined an indication of the timeline from now.

It should be noted that the works on the Shangan Road repaving has been considered with the local area engineer and will be carried out in advance of the main site project as advanced works.

Sillogue Infrastructure

Sillogue Green

The surfacing contractor is due on site 13th and 14th July to finish off footpath works behind Sillogue Green.

Sillogue Avenue

Additional trees were planted this week at cul de sac 2 and the grassed areas are beginning to grow. Several trees have been vandalised to date, damage to the area by scramblers and quads is evident and out of the contractor's control (wheel marks and bare patches).

Sillogue Gardens

Cul de Sac 1 -

Surfacing works ongoing, top section completed last Friday

The haul road/storage area is being cleared, subsoil, tree planting and topsoiling to follow.

More surfacing works due to be completed week ending 7th July.

Cul de sac 2 - Works completed, snag items outstanding.

Cul de sac 3 - Roadstone due to carry out asphalt works on week ending 14th July, they will plane off and overlay the carriageway, snag items ongoing.

Cul de sac 4 - Snag items ongoing, carriageway surfacing works ongoing.

More surfacing works due to be completed week ending 7th July.

Public lighting works ongoing, awaiting ESB's attendance to make permanent connections Wad River Close Access

New footpath and boundary walls have been constructed from no.7 to no.12 Sillogue Gardens. The Wad River Close developer has arranged for their contractor to come to site at the end of July to construct a new ramped pedestrian access between Sillogue Gardens and Wad River Close.

Sillogue Road

Raising of ironworks is required, the road linings will then be reinstated.

Dublin Community Games

There are a number of residents interested in starting a residents group and getting involved in the enhancement of their area. A meeting will be organised with all interested parties and it is anticipated to organise a fun day with local residents will be organised in July or August.

A taster session of Chair Based Exercise classes have been organised by the Community and Social Development team to take place in the Poppintree Community Centre. The classes will take place on Tuesday 11th, 18th and 25th July.

Shop-front enhancement scheme 2023

Four grants of €3,000 were approved under the Shop-front Improvement Grant from the Area-wide Discriotnary budget – 3 Finglas, 1 Ballymun. This year the focus was on areas on the outskirts of Finglas Village with the EDO calling into business in areas such as Clune Rd, McKee Ave, Finglas Village, Clune Rd, Sycamore Ave, Fitzmaurice Rd, the Barry Shops and Ballymun.

A number of business were glad to learn of the support and while not everybody was in a position to apply, expressed a desire to do so in the future. The businesses have until the end of the year to drawdown the grant. Since launching in 2021, 27 grants totalling €61,115 has been approved.

Authority Climate Action Plans (LA CAP). As part of
this, each Local Authority must choose at least one
area to implement a Decarbonising Zone (DZ). Once
they have chosen a zone, they are required to develop
a Decarbonising Zone plan by February 2024.
As Dublin's Energy Agency, Codema is supporting

Dublin City Council with the development of the **Ringsend and Ballymun Decarbonising Zones Plans** to ensure that the actions needed to reach net-zero by 2050

- 1) Reflect those living and working in these communities
- 2) Address some of the most prevalent needs within the community
- 3) Are informed by best-in-class evidence.

Ballymun has been selected as a Decarbonisation Zone and the Economic Development Officer will sit on the 'transition team' comprised of local leaders who will act as the steering group to co-create the Decarbonising Zone plan.

Global Action Plan Community Environmental Programme

<u>Community Garden Programme</u>
The garden is thriving after a beautiful sunny June. The garden is open to volunteers, as usual, from 11-1 on Tuesday and Thursday and from 5:30-7:30 on Wednesday.

Volunteer BBQ

We held the first of our seasonal BBQs on June 10th and it was a huge success. We were delighted to be in a position to buy barbeques, wellies and supplies for our volunteers who are seeking international protection thanks to the generous support of the Local Community Development Committee (LCDC). GAP are proud to support Ballymun for All movement and to be in a position to support communities through GLAS garden.





GLAS garden is a very positive, inclusive space with volunteers from all over the world as well as the local community.

Young Ballymun, Nature Explorer programme

Nature Explorer is a key element of our social inclusion work at GLAS garden. The programme offers families the chance to spend time together in nature and engage in gardening and craft activities.

As many of the families don't have easy access to green spaces in their accommodation, this opportunity is really important. Nature Explorer aims to have a positive impact on wellbeing and to provide a safe and fun experience of the outdoors for families. Our afterschool programme has been running weekly on Tuesdays for the past few months and has been going really well. Our toddler group will start in September.





Environmental Education Programme

Park Stewardship Programme

The Park Stewardship programme is funded under the Ballymun Social Regeneration Fund it is a central component of the GAP education programme. The programme aims to foster a connection to nature and a sense of responsibility for the parks and green spaces in the community, as well as developing student's knowledge and understanding of local biodiversity and ecology.

In 2023, there has been a huge demand for the programme, with more schools expressing an interest than we can engage in the programme.

The programme consists of

- Safety in the park.
- Biodiversity and wildlife.
- Waste, litter and clean ups.
- Tree, wildflower seed planting.
- Talk from the community liaison Garda.
- Art in the park.
- The programme has 8 themes, they are arranged to suit the time of year, the needs of the group and the location.
- The final module is an award ceremony, where each student receives a certificate of participation.

In recognition of the impact this programme has, DCC have decided to fund the programme in schools outside of the Ballymun area. We are in the process of scheduling these with schools in D9, D11 and D5 currently.

Holy Spirit BNS, St. Joseph's Junior school, Gaelscoil Bhailemunna and Our Lady of Victories Infant school have all taken part in the programme this year. The programme is a fun, creative and hands-on way of learning about biodiversity in the local community and we are delighted to now be offering the programme to schools outside of the Ballymun area thanks to funding from DCC Biodiversity.

Climate Action for You(th)

"Climate Action for You(th)" is our suite of workshops for school groups which relate to tangible positive actions which school communities can take to address climate breakdown and biodiversity loss. We take a very school and student-led approach to this work. This allows us to respond to and support schools with issues that are relevant to their lives and experiences. Common themes we explore include waste, climate change, fast fashion, and biodiversity.

This term we welcomed students from the Autism unit of Virgin Mary GNS to explore the garden. We used our senses to explore the different smells, tastes, colours and textures we could find and the girls planted calendula seeds to take back to school. It is very important to us that the garden is an inclusive space for the whole community and we hope to welcome the girls back for some more sessions next term.

Climate Change and Disability

In June GAP published the findings of a survey among people working on climate and disability issues. The survey found widespread consensus that climate debate and policies to date have not adequately considered the needs and views of people with disabilities. The paper shines a light on the often neglected effects of climate change on people with disabilities and emphasises the pressing need for greater inclusivity in climate policy decision-making.

GAP were delighted to represent Global Action Plan and Ballymun at a garden party at Áras an Uachtarán celebrating environmental organisations working to restore nature and support climate action. The event was hosted by Sabina Higgins on behalf of the president Michael D Higgins.

Ballymun Library

Ballymun Library continues to engage with the public with a diverse range of in-person activities and events to suit people of all ages.

Summer Stars is the public libraries national summer reading programme, where children are encouraged to continue to enjoy the pleasure of reading over the summer. Summer Stars continues throughout the summer and runs until the end of August.

At Ballymun Library, we are inviting children to sign up for the Summer Stars Reading Challenge and earn rewards along the way including bags, pencils, notebooks and stickers. You'll get a reading card and a bookmark when you sign up. You can track your progress with the reading card which can be marked each time a book or an ebook is read. The more books you read the more rewards you get. All children who complete the reading challenge will be awarded with a certificate and a medal.

All completed reading cards will be entered into a draw at the end of the summer for prizes including two Smyths Toys vouchers and a National Book Token.
