With reference to the extinguishment of the public right of way over the laneway to the rear of houses at 27-33 West Road, East Wall, Dublin 3.

Proposal

A request, to have the public right of way extinguished over the laneway to the rear of houses at 27-33 West Road, East Wall, Dublin 3 was made. The reason for this extinguishment is due to anti-social behaviour. It is regularly used for intravenous drug use and is littered with needles and other drug paraphernalia. The residents have reported numerous bike robberies and attempted break-ins via this laneway. Also it has become a location for illegal dumping. The extent of this proposed extinguishment is shown outlined in red on the attached map, SM 2022-0309.

The Central Area Committee, at its meeting on the 13th June 2023, agreed to initiate the statutory procedure to extinguish the public right of way over this laneway under the provisions of Section 73 of the Roads Act 1993.

Statutory

By public advertisement on the 7th July 2023, representations or objections were invited by the 25th August 2023. The site notice at this location was erected on the 7th July 2023.

No objections were received.

Service Checks


A service check has been carried out and no service provider will need to alter the current services on or under or over that part of the referred lane.
