Update on St. Anne's Redevelopment

The Housing Delivery Project Manager is currently preparing the stage two application to the DHLGH for funding and hopes to submit this in the coming weeks.

The integrated design team are working on the planning application (179a exemption) which they will proceed with once stage 2 funding is achieved.

The decanting strategy is going well with resident's preferences a priority. Surveys are ongoing and are communicated to residents in advance.

Clancarthy Court

Agreement has been made between the Area Office and the Housing Maintenance Department, for works to be carried out to upgrade and replace all front doors in Clancarthy Court, senior citizens complex. It is hoped that these enhancement works will be completed by Q 4 of 2023.
