The Chair advised the group that Codling Wind Park have been invited to present to the committee.

5. Codling Wind Park – Pat Sammon & Fiona Campbell, Codling Wind Park

Members thanked Pat and Fiona for the presentation and raised the following questions

- What will be the return on investment on this project (RM)
- Who buys the electricity generated and is there a price agreement for that **(RM)**
- How does the price for wind generated electricity compare with the market price (**RM**)
- In relation to the landfall, who are you in dialogue to determine the location (NOM)
- Is there a single point of failure from and engineering perspective only having one connection (NOM)
- Is the planning authority for all elements of the project An Bord Planála (NOM)
- Eirgrid will be working in the Sandymount area over the next six years, can the works be done in tandem to minimise disruption (COC)
- Could this presentation be given to the South East Area Committee (COC)
- Will there be a community fund, what communities will benefit (JC)
- For how far away is a 320 m turbine visible (KS)

• Will Poolbeg and this project be able to develop concurrently (CB)

Pat Sammon and Fiona Campbell responded

- The pricing structure is a work in progress and we are precluded from discussing this.
- The return on investment will depend on the price agreed for the electricity generated
- An Bord Planála is the determining Authority, we interact with DCC, Wicklow CC and Dun Laoghaire Rathdown CC who are statutory consultees
- 1 application for the full farm including all works will be submitted to ABP
- The operations base planning application will go to Wicklow Co. Co
- There will be transitional joint bays to allow for maintenance etc.
- No problem presenting to other committees
- We will be connected to Eirgrid works but our involvement ends at the substation in Poolbeg, Eirgrid would handle everything beyond that.
- It is inevitable that there will some overlap with eirgrid works
- An administrator will be appointed to determine what communities benefit from the fund
- Turbines can be visible for 41km
- We don't anticipate and problems with the Poolbeg Development

6. Net Zero Cities – Declan McCormack, CODEMA

Members thanked Declan for the presentation and raised the following questions

- What level of citizen engagement will there be in relation to pathways to climate neutrality **(RM)**
- Will there be multiple scenarios (RM)
- Would be concerned with the lack of public consultation (MF)
- What level of SPC / Councillor engagement will there be (JC)
- Where are smart cities in this project / Cork (CB)
- When will the oversight committee be established, will there be Councillor representation (CB)

Declan McCormack & Tony Flynn responded

- Net Zero2050 has a representative stakeholder committee established, there were numerous workshops. A similar approach will be used to Net Zero Cities 2030
- There will be extensive consultation
- There will be an outreach to the citizens of Dublin
- The characteristics of areas have to be examined to develop an applicable plan
- There will be multiple actions

- The project is being managed by the City Council, CODEMA have been engaged to develop the plan
- We are looking at using an engagement platform to enable the citizen to make views known
- The Climate Action Plan will be rolled and in tandem to that we will be working on the Net Zero Cities Plan.
- We will put engagement with SPC's on the next CPG Agenda to agree a structure on how consultation with the other SPCs can evolve.

7. Climate Action Pam 2024 – 2029 – Sabrina Dekker, Climate Action Co-Ordinator

Members thanked Sabrina for the update and raised the following questions

- Are the CAP actions remaining the same (RM)
- What are the decarbonisation zone strategy requirements (RM)
- The plan should be as concise as possible (NOM)
- Will the development of the plan be adequately resourced (NOM)
- Summertime is not the best for going to public consultation (NOM)
- The LCDC is currently developing the Local Economic and Community Plan, Climate resilience & Circular Economy are surfacing as key objective with this plan is it possible to link in to ensure the 2 plans strategically align **(CM)**
- Social Housing Flat complexes are lacking facilities, bike parking, recycling. It seems that these areas are seen as being in the back waters (MF)
- The new plan should contain significant detail on how social housing flat complexes issues will be addressed (MF)

Sabrina and Tony Flynn responded

- Actions are changing, it is a work in progress
- The DZ contains energy, transport, transition and biodiversity aspects with consideration for adaptation
- It is intended to set up a climate action office that is adequately resourced to ensure the plan is developed on time.
- Ballymun is also included in the DZ zones
- We will keep the members updated on an ongoing basis in relation to the development of the plan. We are time bound by when the plan has to be ready.
- The statutory requirement for the City Council is to have the Plan adopted by 24th February 2024.
- Both have significant synergies it would be advantageous that the plans agree, we will link in with LCDC
