Update on St. Anne's Redevelopment

The Housing Delivery Project Manager is currently preparing the stage two application to the DHLGH for funding. This will be submitted on 6th of October.

The integrated design team are working on the planning application (179a exemption) which they will proceed with. Stage 2 funding has been granted for this.

The decanting strategy is going well with residents' preferences a priority for relocation. To date we have successfully moved 18 residents, all of whom have been given a letter of comfort, so if they so wish, they can return to St Anne's Court when the new development is completed.

Update on Millwood Court Fold Housing Project.

DCC initiated an "Extinguishment of the Public Right of Way" (EPROW) process over the summer months. This has now concluded with councillors voting in favour of the proposal to extinguish the right of way at the September NCAC.

Fold Housing circulated the timeline on 4th of October to all area councillors. However, please be advised that these dates and times are subject to change, as we await the finalisation of the land transfer.
