## <u>Central Area Public Domain Report</u> <u>North Inner City & Glasnevin / Cabra Area</u>

## **Litter Hotline/Citizens Hub**

In the period  $1^{st} - 31^{st}$  October 2023, incidents were reported via Litter Hotline/Citizens HUB for the **North Inner City & Glasnevin / Cabra Area**.

In addition to the CRM & Citizens Hub incidents, the Public Domain crew for the North Inner City & Glasnevin / Cabra Area carry out inspections of their assigned routes on a daily basis. They collect any dumped bags/materials found, that is not always reflected on the above figures.

The total tonnage of collected illegally dumped items from our four vehicles was:

• 47.04 tonne for October. This brings the total for this year to 408.22 tonne.

## **NEIC Community Clean-ups**

Community Clean-up equipment was distributed to 13 Community Groups / individuals between  $1^{\rm st}-31^{\rm st}$  October. Requests for the removal of bags from community clean ups were handled by Waste Management and Public Domain staff.

### **Graffiti Removal**

There were 26 requests to remove graffiti during the month of October. Internal staff as well as private contractor PMAC carried out all removals.

#### **Weed Removal**

Due to the level of demand placed on Public Domain Staff to remove potential bonfire materials over the past month no weed removal took place. Hopefully within the coming days normal activity will commence, this is subject to staffing levels.

#### <u>Halloween – Bonfire Material Removal</u>

The Public Domain, Waste Management, Housing and external contractors worked exceptionally hard to remove as much potential bonfire material from the area as possible. Tonnage collected by our crew and Breffni will be reported on in next month's report as figures are not available at time of writing.


Overtime starting at 6am and finishing at 4pm was carried out over the past two weekends, emails, phone lines and Citizens Hub reports were monitored and addressed until 9pm each week day.

Contractors worked similar hours to internal staff including 10 hour shifts per day on Halloween weekend.

There were multiple large seizures of wood/tyre stockpiles throughout the NEIC/NWIC and Cabra Glasnevin Areas along with interceptions of materials in transit with assistance from the Gardaí. Effective lines of communication were in place between the DCC teams, the Gardaí and private land owners.

There were requests to remove graffiti during the month of October. Internal staff as well as private contractor PMAC carried out all removals.




# **Weed Removal**


Additional locations in the Cabra/Glasnevin area were identified and cleared by Waste Management Services over the month of October as part of our weeding schedule.

#### Halloween - Bonfire Material Removal

The Cabra Glasnevin had a dedicated Halloween Response for 2023 which yielded some positive results.

This combined effort across Public Domain, Waste Management, Housing, An Garda Síochana and external contractors led to multiple large seizures throughout the LEA.

Our response was activated on the 25<sup>th</sup> and ran right up to the 31<sup>st</sup>. It involved a number of staff patrolling the area from 7am providing locations and data to be recorded and external contractors were instructed to lift any bonfire material.


We had two contractor vehicles in the area each day responding to calls from the general public through our dedicated response line, An Garda Síochana patrols and Public Domain. We also had support from the NEIC drones and the aerial unit in An Garda Síochana.

Callouts during busier periods were risk assessed with An Garda Síochana providing assistance when needed. Very happy to confirm no incidents involving staff or contractors throughout the response.

The tonnage collected by our crews and external contractors will be reported on in next month's report as those figures are not currently available.

All sites and material that was lifted throughout our response has been recorded on a database that will form part of our response for 2024.
