Recommended	<p>According to a recent speed survey, the traffic volumes on Villa Park Avenue does not meet the criteria for the provision of ramps. Dublin City Council has a limited budget for 2023 therefore unable to recommend any speed ramps/traffic calming at the aforementioned location at this time. The Area Engineer will add the request for speed ramps/traffic calming to a list for future consideration dependant on whether future funding is made available to the Area Engineer.</p> <p>During a site visit, it was observed that cars were illegally parked on the footpath through the road extension. On street parking is a natural traffic calming measure, by reducing the available carriageway width, raising driver's attention and reducing speeds. Cars should be parked on the road and not on the footpath.</p> <p>Please note that instances of illegal parking should be reported to Dublin Street Parking Services, the City Council's parking enforcement contractor (Ph: 01-602 2500 or Email info@dsps.ie) or to the local Gardaí, as a matter for enforcement under the Road Traffic Regulations.</p> <p>To warn drivers to slow down and to expect children crossing, the area engineer recommends the installation of a Slow road marking and a children crossing sign on Villa Park Avenue.</p> <p>The Area Engineer has recommended Slow markings (M106) on Villa Park Avenue, in front of property No. 22, and 18m west from the junction with Nephin Road.</p>	Councillor	06/07/2022	2

Generally when considering the installation of traffic calming measures, those roads without any vertical deflection are considered a priority over roads which are currently traffic calmed.
