St Anne's Court

The redevelopment project of St. Anne's Court Raheny, has successfully received Stage 2 funding from the DHLGH. The Integrated Design Team will now progress to Stage 2c which will define the design and prepare for the planning process.

Communication with residents is ongoing and updates will continue to be provided both to the Area Committee and to residents as the project progresses.

Works carried out in Senior Citizen's Complexes 2023

Below is a list of some of the works carried out in Senior Citizens complexes in co-operation with area Housing Maintenance Section and "Discretionary Funding".

- 1. In the past year, a variety of enhancements were installed In all complexes, ranging from wheelchair accessible picnic tables, planters, bird boxes, benches, chess tables, decorative penny farthing plant holders and hanging baskets.
- 2. A deep clean of all community rooms within the senior citizens complexes was carried out as part of a broader initiative to galvanise community activities post Covid 19.
- 3. Initiation of a number of gardening programmes in the complexes to improve their aesthetic appeal.
- 4. A comprehensive programme of new bin shelter construction in 10 complexes to meet recent EU Directives regarding presentation, storage and removal of general waste, organic refuse and recycling material.
- 5. CCTV enhancement within the Greendale Court complex.
- 6. All balconies and stairwells in complexes where required have been resealed and upgraded, which will help prevent slip trips and falls and prevent dampness in flats below.

- 7. Facilitating the KARE organisation's "Meals on Wheels" programme as they shift operations from St. Anne's Court to St. Bridget's Court. This logistical work will ensure the continued success of KARE's critical operations in the area.
- 8. Initial consultations and preparatory works to facilitate the introduction of the new telecom alarm system installations in all DCC senior citizens complexes.
- 9. Enhancement of the overall lighting within St. Gabriel's Court complex with particular focus on the entry driveway.
- 10. Extensive tree pruning programme throughout many of our complexes. Work is currently underway in St Gabriel's Court, Clontarf.
- 11. Drainage, Surface Water and Housing Maintenance sections carried out a survey and cleaning of all gullies, surface water and foul drainage systems and effected repairs where needed, in all complexes.
- 12. An upgrade and replacement of all front and rear doors in St John's Court senior citizens complex has been completed. This upgrading work will continue in 2024 commencing with Clancarthy Court.
- 13. A large order for enhancement products has just been placed with PACE, to encourage tenants to take part in small gardening projects. These include planters, small herb gardens & new work sheds. A training programme is currently being compiled to enable tenants to begin in the first quarter of 2024.

These and other improvements in the complexes were part of a comprehensive enhancement programme undertaken by this office utilising available discretionary funds and supported by several Dublin City Council departments throughout 2023.
