

4. Choice Based Lettings

- Since CBL on line went live 16th October, 661 units have been advertised with 12,160 applications
- 81% of these applications were completed by applicants themselves through the online portal
- As of end of November 30% of lettings have been filled through CBL
- Refusal rate has continued to drop with the use of CBL


