North Inner City

Litter Hotline/CRM

In the period 1^{st} – 22^{nd} December 2023, incidents were reported via Litter Hotline/CRM/Citizens HUB for the Central Area.

In addition to the Citizens Hub reported numbers, the Public Domain crew for the North Inner City & Glasnevin / Cabra Area carry out inspections of their assigned routes on a daily basis. They collect any dumped bags/materials found, that is not always reflected on the above figures.

The total tonnage of collected illegally dumped items from our four vehicles was:

• **13.86 tonne** for December 2023. All receipts were not submitted at the time this report was submitted, a revision is expected in net months report. There was an additional 1 tonne collected in November that was not reported at the time. Resulting in November's tonnage as being 56.65 tonne. Revised Total Tonnage for 2023: **492.45 tonne.**

Community Clean-ups

Community Clean up equipment was distributed to **4** Community Groups / individuals between 1st December – 23rd December. Requests for the removal of bags from community clean ups were handled by Waste Management and Public Domain staff.

Graffiti Removal

There were requests to remove graffiti during the month of November. Internal staff as well as private contractor PMAC carried out all removals.


Cabra / Glasnevin
