7	11145020	Traffic Calming	PHIBSBOROUGH ROAD (C)	Dublin 7	request a yellow box, traffic calming measures, safe pedestrian crossing.	Not Recommended	It is not recommended to install a yellow box at the location. Yellow boxes are intended to prevent blocking of road junctions. Side road traffic flows should be significant and the side road should serve a minimum of fifty houses or a major traffic generating facility. Enniskerry Road is a cul de sac with less than fifty houses. These guideline are in place to avoid a proliferation of yellow boxes in the City which have substantial maintenance costs associated with their implementation. Phibsborough Road is part of Bus Connects (Ballymun to City Centre) project that will support integrated sustainable transport usage through infrastructure improvements for active travel (both walking and cycling), and the provision of enhanced bus priority measures for existing and all future services who will use the corridor. The junction with Enniskerry Road is included in this project for a big upgrade, including the construction of a controlled pedestrian crossing. Recommended	In order to provide a better access for pedestrians and cyclists, the area engineer recommends double yellow lines on the south east side of Botanic Avenue to prevent vehicles from blocking the sightlines and access to the existing cycle racks. Not Recommended	The area engineer does not recommend extending the double yellow lines to the pedestrian crossing. The pedestrian crossing is signalised with a yellow box and a continuous centre white line. During a site visit it was observed the road markings were faded. It is recommended to repaint the road markings both at the beginning of Kempton Ave. Junction with Navan Road (Yield and No Entry) and the continuous white line and double yellow lines until the junction with the Navan Road. Not Recommended	The area engineer does not recommend double yellow lines on St. Patrick's Parade, as the road is wide enough to accommodate on street parking without causing a hazard.
